Additional Information In	Christoffer Badse position with UNICEF DANMARK is at the level of senior legal advisor since 2022 working with legal monitoring and advocacy in relation to a wide range of challenges to domestic implementation of the rights of the child in Denmark and reporting to the UN regarding obstacles and progress and cooperating with civil society organisations and other stakeholders. Mr. Badse graduated law school from the faculty of law, Copenhagen University in 2001 and has been affiliated with the Danish Institute for Human Rights from 2003 to 2022 before taking up position with UNICEF DANMARK. Mr. Badse has been working primarily in a national and European setting on human rights issues via monitoring human rights development, legal drafting and advocacy but has also been involved in teaching and conducted workshops and presentations in relation to reporting techniques on a wider international level. Mr. Badse was department director for the legal NHRI monitoring department of the institute, where the mandate as the NHRI of Greenland and the cooperation with the Greenlandic Council for Human Rights also was placed. Main areas of responsibility: general (legal) monitoring regarding the rights of the child at UNICEF DANMARK working with legal monitoring, advocacy and projects in a domestic setting.
