Information has also been taken from secondary sources such as the 2009 APAV study on Victims in Europe.¹ While phase 2 of the project was divided into two parts, focusing firstly on generic victim support services and secondly on specialised areas of victim support, this third phase of the project, comprised of Parts A and B, will focus principally on the structure or lack thereof of generic victim support services; although a limited number of questions relate to specialised areas of victim support. However, in the cases of victims of trafficking, once the official identification of the Police takes place, the victims receive temporary residence permit and are eligible to receive specific benefits as stipulated in the relevant Law. <sup>9</sup>

It was clarified that only in cases of families with children the SWS may take the necessary measures to protect the children such as providing shelter to the children. <sup>11</sup> The non governmental support services are open to migrants regardless of their status, however, the assistance they can provide is limited due to the restrictions in the public sector/benefits. <sup>12</sup>

Х	In the cases of victims of trafficking, when the victim, after the 2-month reflection period, does not agree to cooperate with the Police, she/he can no longer stay in Cyprus unless if he/she submits an asylum application. That is, the temporary residence permit issued during the reflection period cannot be renewed. <sup>13</sup>

10a	In reference to part 'c' of questions 1-5, in the event that police contact victim support services on the victim's behalf, is there an automatic transfer of the victim's data? <sup>14</sup>	X		The Police automatically transfer the victim's data to the Social Welfare Services in cases of domestic violence (if the victim requests), trafficking and in cases of minor victims. It was clarified that the data transferred to the SWS are mainly the contact details of the person, not information about the incident. Usually more information is recorded by the social welfare officer during the contact with the victim. <sup>15</sup> If the victim support service is non governmental, then the Police does not transfer any data of the victim except from the cases that a victim of domestic violence needs shelter, thus her contact details are transferred to the Association for the Prevention and Handling of violence in the family.
10b	If the answer to 10a above is yes, is the police obliged to obtain the victim's permission/consent for the data transfer?		X	In order to transfer the data to the SWS, the Police is not obliged to obtain any permission/consent from the victim, since the Police only contacts the SWS upon request of the victim.
10c	Is there a legal basis for the communication/transfer of the victim's data? What is it?		X	The procedures regarding the communication of the Police with support services are set both in the Domestic Violence Law¹6 and the Interdepartmental Procedures Manual for the Handling of Cases of Violence in the Family¹7. However, there is no legal basis regulating the transferring of victim's data between Police and support services.

There is no specific body in charge of the overall coordination in relation to victim support services. Each governmental body is responsible of a different aspect of victim support. Namely, at a national level the Ministry of Labour and Social Insurance and specifically the Social Welfare Services, receive referrals of all types of victims on a national level who wish to receive support. The Ministry of Interior, however, is responsible to draw policies, propose legislations and measures in relation to the treatment of victims of trafficking and the shelter for trafficked women.<sup>18</sup> The Ministry of Justice is responsible to draw policies in relation to domestic violence and violence against women.<sup>19</sup>

The study highlights the fact that there is not a unified central data bank for reported cases of domestic violence since different services and departments keep their own statistical data on the matter.

The International Criminal Court (ICC) has created a special unit for victims and witness to provide support before, during and after the trial. Services are delivered by professionals who are often salaried employees of the court, and includes persons with expertise in trauma, including trauma from sexual violence. When providing testimony victims may also have support from family members, psychologists or legal representatives. These specialists are also able to advise prosecutors on appropriate security arrangements for victims and the court must take measures to protect the safety, physical and psychological well-being, dignity and privacy of victims. The statute allows for identities not to be made public, testimony to be provided by electronic means and the hearing to be confidential. The statute also calls for the court to establish principles relating to "reparations to victims, including restitution, compensation and rehabilitation" and to establish a trust fund which "works for victims by mobilizing people, funding opportunities for the benefit of victims and implementing court-ordered reparations awards."

#### 2.9. The role of volunteerism in victim support

From the research carried out in phases 1 & 2, one of the most striking features of the more robust generic victim support systems in Europe is the crucial role played by volunteers.

a. Even though the culture of voluntarism is not so common in Cyprus, many of the non governmental support services in Cyprus are supported by volunteers in order to achieve their aims. One of the first victim support services that introduced voluntarism in this sector was the Association for the Prevention and Handling of Violence in the Family which was established in 1990 by members who were working on a voluntary basis. At the moment, this is the <u>only</u> structure island-wide to provide accommodation to women victims of domestic violence and their children in Cyprus. The helpline and shelter of the Association is at the moment run by 8 paid staff and 35 volunteers. The volunteers have related to the sector professional background on a University level such as social work, psychology, sociology, educators but are also going through the annual training of volunteers of the Association. Their tasks include answering the helpline and providing counselling on the phone, administrative support, logistics and organizing fundraising events. The one to one sessions and psychotherapy are offered only by the paid staff of the Association. Many of the volunteers are providing services as a part of their bachelor or masters practicum in cooperation with their University/Collage.

At the moment, there are indications that the number of persons interested to become volunteers is increasing. This can be attributed to the highly increasing financial crisis and unemployment in Cyprus which is an incentive for persons, especially young, to pursue voluntary jobs that can help them enrich their knowledge and gain experience – thus having more possibilities to be employed in the future. Fewer cases are the ones who volunteer as a part of their free time.

The Cyprus Civil Defence Force which is a service operating under the Ministry of Interior consists in a great extent of volunteers. The Civil Defence's role is to take the necessary measures to protect people and their property during and after a hostile action, natural and technological disaster. It covers all the areas of the Republic of Cyprus and has five departments, First Aid, Welfare, Neighbourhood watch, Communication office, and Search and Rescue. The volunteers are approximately 600 and the permanent staff 35. The volunteers are responsible for the whole operational part of the service while the permanent staff only has a general managerial and supervisory role.<sup>67</sup>

The occupation of social work emerged in Cyprus in 1960, while social work as scientific method started being applied for the first time in 1951 at the first Social Welfare Services office. Social work was legally vested in 2000 through the "Registration of Professional Social Workers Law". Since then and until recently social workers were mainly employed at the Social Welfare Services through the standardized governmental recruitment procedure. The majority of social workers studied at third level education – technical institutes or collages. Only the last five years, social work became part of university curriculum.

## 3.1.1 Please outline who (i.e. state or non-state actor) took the initiative for first setting up victim support services.

The period between the mid 1940's up until the Independence of the Republic of Cyprus in 1960, was the age of a gradual formation of a Social Service Department. The main goal of this Department was the provision of social services to needy families, children, the elderly, offenders, and generally to the vulnerable groups of the population. The creation of such a Department, that would promote the organization, advancement and provision of social welfare services, was considered as a novel idea The Social Welfare Services, as they are known today, were established in 1952 and originally consisted of a small group of 5 Probation Officers. These Officers were appointed in the mid 1940's to keep an eve on minor offenders and supervise the function of the Lampousa's Reform School. Basically, the need for creating a Social Service came from the lack of caring and nursing for children who were deprived of a normal family life. This was an initiative of the state.<sup>78</sup>

Services for victims (services d'aide aux victime, SAV) are members of the INAVEM. 150 associations are adherents to the INAVEM and provide psychological, logistic, financial and legal support to victims .
