1 Legal and policy framework

1.1 National legislation on digital public administration

To the Institute's knowledge, equal access for all or specific groups is not mentioned explicitly in regards to national legislation on digital public services. As part of the common public sector digitalisation strategy 2011-2015, an extensive legal framework on mandatory digital self-service was adopted by the Danish Parliament (*Folketinget*) in the years 2012-2015. The adoption of this framework means that citizens' contact with the public sector must happen online through digital self-services.² In the preparatory works it is emphasized that consideration must be shown to citizens who are unable to acquire IT-competences as well as citizens with special needs such as older citizens, citizens with disabilities or dementia, socially vulnerable citizens, foreign citizens in Denmark and Danes residing abroad.³ If a public authority assess that a citizen is unable to use digital self-servies, then the authority must show the citizen how to apply for social instead. To ensure that these people's rights are respected, the preparatory works further highlight different initiatives established to help the digitally challenged citizens such as informative videos and telephone services, IT-courses for older citizens and one-on-one guidance.

In a public sector digitalisation strategy covering the years 2016-2020 one of the focus areas is also that digitalisation must be for all citizens – including persons with special needs – and that a digital competency lift therefore is a priority.⁴

With the implementation of the eID, NemID – a common secure login on the Internet consisting of a user ID, a password and a code card containing codes (one-time passwords) - it became necessary to use a digital signature to access digital services. The digital signature gives access to Health.dk (*Sundhed.dk*) which is the common digital public health portal from where you can access your health records.⁵ It also gives access to the Citizen Portal (*Borger.dk*) which is the united digital entry to citizens' interactions with public authorities. Through the Citizen Portal you can apply for social benefits and pensions as well as access Digital Post which is a digital letter box for receiving post from public authorities.⁶

To ensure equal access, a person can be exempted from using Digital Post and NemID if said person is covered by one of the grounds for exemption. In this regard you can be exempted if you have a cognitive or physical impairment which prevent you from using Digital Post, if you do not have access to a computer, smartphone or tablet in your home or place of residence, if you are registered in the Central Person Register (CPR) as having left Denmark, if you are no longer registered with permanent residence, if you experience language barriers consisting in lack of Danish language skills, if you experience practical difficulties in obtaining an electronic ID giving access to Digital Post, if your place of residence is located in an area with no internet connection with a calculated download speed of at least 512 kbit/s or if a concrete assessment concludes that there are exceptional circumstances justifying exemption.

The possibility of exemption from Digital Post and NemID does not include exemption from other public self-service solutions. If a person is incapable of using digital self-service options other than Digital Post, one must apply for exemption every single time one finds herself/himself incapable of operating a digital self-service such as applying for social benefits or public statutory pensions through the Citizen Portal.⁸ An application for exemption can be submitted at the local

citizen center (*Borgerservice*) and it is possible to give a representative power of attorney to file an application for exemption on behalf of oneself.⁹

The DaneAge Association (Ældre Sagen) has raised concern about the digitalisation of the public sector¹⁰ since the very limited alternative options can pressure older persons into entrusting contact with the public sector to a legal guardian or a family member which incapacitates the person. Thus, the DaneAge Association calls for a possibility for general exemption from digital self-services to ensure that older people have equal access to public services and do not feel obligated to give up their autonomy.¹¹ In 2015, a similar proposal was rejected by the majority of the Danish Parliament on the basis of the current legislation already having taken into account that some persons are unable to use digital self-services and that a concrete assessment of the person's possibility to use a certain self-service is necessary to ensure flexibility.¹²

In autumn 2021 a transition from NemID to MitID begun. MitID is a replacement for NemID and will mainly work as an app accessible via smartphone or tablet where you will receive a one-time password everytime you login to a public digital self-service. In the preparatory works for the act on the new eID solution it has been emphasized that the development of MitID has taken into account the safeguarding of equal access for persons with disabilities. For instance, MitID is available to the blind and visually impaired through a MitID audio code reader which will read the one-time password out loud and display the code on the screen of the device. Furthermore, MitID is required to live up to the Web Content Accessibility Guidelines 2.1 A+AA (WCAG)¹⁵ as well as national law on web accessibility. MitID is expected to have fully replaced NemID in 2022 and it will still be possibly to seek exemption from using the eID.

In September 2018 the Act on the Accessibility of the Websites and Mobile Applications of Public Organs' Websites and Mobile Applications entered into

force¹⁷ implementing EU Directive 2016/2102 of 26 Oktober 2016 on the accessibility of the websites and mobile applications of public sector bodies.¹⁸ The overall objective of the act is to make it easier for persons with disabilities to use public authorities' websites and mobile applications.

1.2 National policy, strategy or action plan on the digitalisation of public services or digital inclusion

In March 2021, the Danish government launched a digitisation partnership which delivered its recommendations for Denmark's digital future in October 2021.¹⁹ On the basis of the national recovery and resilience plan and the digitalisation partnership's recommendations, a new digital strategy for Denmark will be launched in 2022. The last digital strategy ran from 2016 to the end of 2020 which means that there has been no active digital strategy since the beginning of 2021. The next Digital Strategy is expected to run from 2022-2025. Though a new digital strategy is still pending, digital inclusion will be a theme in the upcoming strategy as it is in the municipalities' current digitalisation program.²⁰

In 2018, a broad political agreement regarding digitalisation-ready legislation was reached²¹ proscribing that digitalisation of the public administration must contribute to greater transparency, better accessibility for citizens and companies, and a more consistent case management. It must further be ensured that the digitalisation respects the citizens' rights under national law and takes care of non-digital citizens as well as citizens with disabilities.²² To guarantee these matters, the agreement sets out seven principles to be followed in all legislation proposed after 1 July 2018. One of the principles establishes that the public administration must continue to offer alternative solutions to citizens who are non-digital.²³ The agreement also introduces a requirement for assessment and description of implementation consequences in legislative proposals. This includes an assessment of the impacts a given proposal will have on citizens' rights.²⁴

1.3 National recovery and resilience plans covering the digitalisation of public services

In the national recovery and resilience plan, the Danish Government presents a new digital strategy to promote the digital reform agenda in Denmark. The strategy will consist of five sub-reforms including creating the digital public sector of the future by continuous modernisation of the digital infrastructure meeting the needs of all citizens and businesses and strengthening connectivity. The national recovery and resilience plan points out that some users still experience that the digital world can be too complex and difficult to navigate and that 23 percent of citizens indicate that they needed help when they most recently used a digital self-service solution. Thus, the plan highlights the importance of promoting digital inclusion and online digital services accessible to all as well as continued investments in and modernisation of our national digital infrastructure and solutions. The plan also emphasises the importance of technological development and digitalisation of society in accordance with democratic core values of coherence, transparency, trust, and equal opportunities.

2 Programmes and practices aimed at ensuring equal access to public services in the digital age

The Ministry of Digitisation facilitates the country wide network called Network for digital inclusion (*Netværk for digital inklusion*). The purpose of the network is to support and improve efforts for citizens who are struggling with digital communication with public authorities. Organisations representing citizen groups with physical and mental disabilities, young people, older persons, non-western immigrants, and socially disadvantaged people or otherwise are working with IT-challenged citizens can become members of the network.²⁹ The DaneAge Association along with 71 other associations are members of the network today.³⁰

The DaneAge Association's IT volunteers offer courses, activities, and events to help older people get on the internet and keep up with digital developments. The

DaneAge Association has more than 1,700 volunteers across the country helping in IT cafés, courses, via IT phone support, or visits to the home.³¹

3 Research and data focused on equal access to public services in the digital age

In April 2021 the Ministry of Digitisation in collaboration with Local Government Denmark published a report on digital inclusion in the digitised society.³² In the report, the five biggest barriers that older persons, persons with disabilities, non-western immigrants, groups of socially disadvantaged persons, unskilled persons, and sick persons are met with when navigating the public digital infrastructure, are described and acknowledged. The five barriers that these groups meet are 1) that the digital solutions do not fit with the their choice of device, 2) they have poor digital skills, 3) they have poor administrative skills, 4) they have poor skills in written Danish, and 5) there are few options for digital alternatives.³³

The report presents five focus points that can be used in the further joint public work with digital inclusion. The focus points include simplifying communication and processes and developing alternative ways to include these groups of persons given that the analogue ways are more or less disappearing.³⁴

From 2018 to 2021, a research project on digital marginalisation of vulnerable older person was conducted at the IT university of Copenhagen with support from the EGV Foundation (Social Inclusion of Older Adults) (*Fonden Ensomme Gamles Værn*). The aim of the project was to examine vulnerable older persons' experiences with and use of digital technologies. The data collection was carried out with a combination of qualitative methods in the form of observational studies and interviews with, among others, citizens and key employees. 36

The second part of the research project – work report 2^{37} - concludes that communication with the public sector in many ways has become more challenging and distancing for many vulnerable older persons. It also concludes that the civil society plays a vital role in making sure that older persons can communicate with

public authorities. 38 The project calls for more empirical research on the subject as well as a common dialogue on how to make sure that everyone is included in today's society. 39
