#### Legal and policy framework 1

#### 1.1 National legislation on digital public administration

According to the Central State Office for the Development of the Digital Society, at the end of 2021, about 1.5 million users were registered in the e-Citizens system, which means that a large part of citizens still use public administration services in the "traditional" way.

National legislation does not recognize the equal right for all to the access to public services undergoing digital transition, including older persons and persons with disabilities, with the exception of Act on the Right to Access Information<sup>1</sup> where it is stated that "the right to access information and reuse information belongs to all users in the same way and under the same conditions".

On 15 July 2014, the Croatian Parliament adopted the Law on the State Information Infrastructure.<sup>2</sup> The act established a central government portal system as a single point of contact in the virtual world. Croatia has a comprehensive framework of laws and regulations in place for exercising eGovernance, which is supplemented by the Electronic Document Act<sup>3</sup>, the Information Security and Confidentiality Act<sup>4</sup>, the Act on the Right to Access Information<sup>5</sup>, the Law on Cybersecurity for Key Service Providers and Digital Service Providers<sup>6</sup> and General Administrative Procedure Act.<sup>7</sup>

Law on Accessibility of Websites and Software Solutions for Mobile Devices of Public Sector Bodies<sup>8</sup> sets out measures to ensure the accessibility of websites and software solutions of public sector bodies to users, especially persons with disabilities.

In 2021, the provisions of the General Administrative Procedure Act<sup>9</sup> have been amended, the main goal of which is to speed up and simplify administrative procedures using information and communication technology, while the use of electronic communication in all phases of administrative procedure should reduce costs for parties and public bodies.

## **1.2** National policy, strategy or action plan on the digitalisation of public services or digital inclusion

The National Plan for the Development of Public Administration 2021-2027<sup>10</sup> envisages "Digital Transformation of Public Administration" as one of its goals. Within the above, it is planned to establish a single contact center for all public eservices in order to provide customer support. In addition, targeted training is envisaged to be conducted to strenghten the digital literacy of public administration officers but also certain groups of users, including older people and people with disabilities.

The Ombudswoman, in her annual report<sup>11</sup>, recommended that all public bodies clearly list the services they provide and provide a brief description of the procedures on their websites and in the premises where they receive citizens.Furthermore, in her annual report, the Ombudswoman recommended that all public bodies clearly list the services they provide and provide a brief description of the procedures on their websites and in the premises where they receive citizens.

## **1.3** National recovery and resilience plans covering the digitalisation of public services

National recovery and resilience plan<sup>12</sup>, the chapter about gender equality and equal opportunities, recognises older people and people with disabilities as vulnerable groups. Moreover, the Plan defines measures to close digital exclusion; infrastructure measures are envisaged that will enable access to very large capacity networks which is expected to have a positive effect on the equal opportunities of all citizens of Croatia. Furthermore, the introduction of a model for hybrid approach to the workplace - smartworking (C2.2. R2-I2)<sup>13</sup> will help to increase the inclusion of people with disabilities in the labor market. Measures

(C1.4. R1-I2)<sup>14</sup> are related to better accessibility of digital transport solutions for people with disabilities. They also include conducting trainings to strengthen their digital literacy. In addition, as part of the digitization of public administration services (C2.3. R2-I2)<sup>15</sup> it is planned to conduct targeted education and training for the formation and strengthening of digital literacy of certain groups of users, which may include older people, people with disabilities, Roma people.

### 2 Programmes and practices aimed at ensuring equal access to public services in the digital age

Public sector bodies are obliged to adapt their digital content and services in accordance with the European standard EN 301 549.<sup>16</sup> To help adapt their pages, public sector bodies can use the Guidelines for ensuring digital accessibility<sup>17</sup> developed by CARNET (Croatian Academic and Research Network). These guidelines contain minimum requirements for digital accessibility and are continuously revised and supplemented by CARNET, with prior consultation with the expert community and relevant stakeholders.

Target groups are persons with visual impairment, persons with hearing impairment and speech-voice disorders, persons with motoric disorders, chronic diseases and multiple difficulties and persons with specific learning disabilities.

In Croatia, there are no such reports on programes and practices aimed at ensuring equal access to public services in the digital age. The only information available in regards to older persons and digitalisation are the ones regarding the use of social media and communications platforms. In 2020, Hrvatski Telekom has launced a National digital education program for the older persons in the cooperation with the Volunteer Center Zagreb. The Program consists of easy-to-understand educational videos through which older persons can easily learn how to use various digital tools that will enable them to be connected with their families and friends. On that occasion, Hrvatski Telekom donated tablets and free internet access to 30 Homes for the Elderly.<sup>18</sup> <sup>19</sup>

# **3** Research and data focused on equal access to public services in the digital age

According to the Ombudswoman<sup>20</sup>, during 2021 her Office received 20 complaints of possible discrimination based on age, and 7 complaints of multiple discrimination, in which age was cited as one of the grounds for discrimination. 6 out of the 27 complaints concerned the area of access to goods and services. It is important to point out that, unless the complaint explicitly refers to age discrimination when it is necessary to state whether it is a young person or an older person, the Ombudsperson's office has no information about the complainant's age.

As for the gender of the complainants, 15 of them were men, 5 women, and the other 7 complaints were sent from other service providers (civil society organizations, anonymous persons, legal entities, etc.)

During 2021, the Ombudswoman received only 3 complaints related to digitized services, all of which were sent by male complainants. Two of them related to the use of digital applications for keeping the list of retained catches and providing these data to the fishing rights holder, stating that the use of digital applications causes potential users the cost of purchasing electronic equipment and paying operators, which discourages people with lower assets. The third complaint was related to the abolition of the portal zdravlje.net for patients and it expressed suspicion of violating the principle of equality of certain categories of citizens, including the elderly. As the mentioned Portal became a part of the e-Citizens portal, it was essentially a matter of improving and upgrading the already existing digital service, which was also implemented in order to protect personal data.

Analysis of public opinion research data and examination of the needs of digital inclusion of vulnerable groups<sup>21</sup> was conducted by University of Zagreb and Faculty of Organization and Informatics Varaždin (FOI) within Digital Literacy Development Network.

Data collection regarding the need for digital inclusion of vulnerable groups was conducted in the City of Zagreb and Zagreb County, Varaždin County and Primorje-Gorski Kotar County. The target groups in this study are people with disabilities, pensioners, residents of rural areas and residents of island areas. Data collection was carried out using the paper-pen method by delivering questionnaires by mail and online. In the empirical part of the research, 540 respondents completed the questionnaire and this number of questionnaires was taken as the final one for conducting statistical analysis.

According to gender, the majority of respondents in the survey were females (63.9%), while a total of 195 respondents (36.1%) participated in males. According to age groups, the age group of 65-74 years prevailed the most, and the age group of 16-24 years the least. Altogether, 57.2% of the participants were older than 55 years old. However, respodents' reponses were processed in bulk and each individual response was not correlated with respondent's age. At this stage we have requested the above data but have not yet receive it.

The research covered several topics including the use of digital public services with the main focus on e-Citizens service. The results show that 54.1% of respondents said that they either do not use or do not need digital public service. The use of the e-Citizens service is not considered necessary by as many as 35.6% of respondents, while them 21.3% said they needed help using it. Most respondents stated that the reason for non-use was that they not have enough knowledge and skills (28,9%). The largest percentage of respondents (36.7%) stated that they use the service to download official forms (via the e-Citizens portal) and download certificates and excerpts from official registers such as COVID-19 certificate, certificate of impunity / residence (33.7%).

Of those who have stated that they use these services, most are satisfied with the way they function (54.2%), the appearance of the interface (53.5%) and they use the service independently (59.1%).
