Introduction



The European Union Agency for Fundamental Rights has been looking at the situation of people with disabilities in Italy.



They have been studying:

People who live in institutions



An **institution** is where people with disabilities live together in a large place away from other people.



What it is like to live in an **institution**



What it is like to live in the community



The **community** is where all different people live close to each other. They live close to their families and friends.

We asked people what it is like to live in an institution and the community.







In Italy some people with disabilities live in institutions.



Most people with disabilities live in the community.



Some people with disabilities have moved from institutions to live in the community.



There are rules in Italy saying people with disabilities have the same rights as everyone else.



There are rules saying children with disabilities should go to school with other children.



There are rules that say people with disabilities have the right to work.



There are rules saying people with disabilities should not live in institutions anymore.



They should live in the community instead.


Living in an institution



People said that living in an institution is very different from living in the community.

In institutions:

- Every day is the same
- People cannot decide what to do each day
 - It is difficult to make friends outside the institution
- It is difficult to have privacy



Living in the community



In the community people can decide what to do each day.



- It is easier to:
 - Make friends



Decide what you need and what you like.




Get the help you need. You don't have to share your support with other people.



People with disabilities who live in the community are happier. They have a better life.

- They can make choices about their lives

People told us lots of things that help:

Rules that say people with disabilities have the same rights as anyone else.



People working in institutions who want to help people with disabilities live in the community.



It is easy for people with disabilities to find a job.



The government makes a plan to help people with disabilities live in the community.

This helps to make more services for people with disabilities.




Politicians understand that living in the community is very important for people with disabilities.

Rules

Sometimes rules don't work.

The government needs to make easier rules.



Some people don't like change

Some people working in institutions don't want to change things.

They don't want some people with disabilities to live in the community.





Jobs

It is difficult for people with intellectual disabilities to find a job.

Families of people with disabilities say that the government does not do enough to help.

Not enough information

People don't have enough information about helping people with disabilities to live in the community.



Families need help

It is difficult for families to help people with severe disabilities at home.



They need more help.

Some families say people with severe disabilities feel more protected in institutions.

Attitudes



An **attitude** is the way that people think about something.



Some people have a bad attitude about people with disabilities. They don't want to talk with them.

They don't want to meet them.

Different types of people

Some people think that moving from an institution to live in the community is not good for:

- People with intellectual disabilities
- People with severe disabilities
- People with disabilities who have lived in institutions for a long time



Some people with severe disabilities say they feel safe in institutions.

They don't want to move to live in the community.

What to do next?



People had lots of ideas about how to help people with disabilities to live in the community.

To help people with disabilities to move from institutions to live in the community we need:


- More help from the government
- More information
- More money





We also need:

- People who work with people with disabilities to speak to each other more
- People working in different parts of government to work together more
- People to speak more about the rights people with disabilities have



More information

People need to get more information so they can help people with disabilities to live in the community.



More money

Sometimes there is not enough money. We need more money to help people with disabilities to live in the community.



Jobs

We need to help people with disabilities to find a job.

Some people are afraid of hiring people with disabilities.

Speak up more

We need people with disabilities and their families to speak up more.



We need:

To ask people with disabilities what they think about living in the community.



- To ask them what they think the government should do to help them live in the community.
- To help people with disabilities to speak up for themselves.

Help during the move

We need help for people with disabilities who move from institutions to live in the community.

It is a big change for people with disabilities and their families.



Better services

Different people with disabilities need different kinds of help.

People with disabilities need to get the right help for them.

The government needs to make sure everyone can use the services they need.
