In Luxembourg, there is no specific statute or legislation for NGOs.⁴ Nevertheless, the Ministry of Foreign Affairs has put in place an 'approval system' (système d'agrément) for NGOs working in development cooperation and humanitarian action.⁵ An NGO wishing to obtain such an approval can send an application to the Ministry of Foreign Affairs. In this context, NGOs are civil society associations characterised by a transnational activity and by a wish to participate in the democratic process.

In Luxembourg, most NGOs are, in terms of legal statute, so-called 'non-profit associations' (associations sans but lucratif, asbl). They must therefore comply with the law on non-profit associations as regards their functioning and the rules regarding the attribution of legal personality.

⁶ While most NGOs have the legal statute of an 'asbl', some are foundations. There are few legal differences between asbl and foundations. For instance, the activities of the NGO Caritas Luxembourg are divided into three legal structures, two of which are "asbl" and one of which is a foundation.

The legal framework for NGOs ('asbl')⁷ in Luxembourg was amended in 2016 with the abovementioned Act of 27 May 2016 regarding the reform of the legal publication system for companies and associations⁸ and its two Grand-Ducal Regulations. Previous laws in the matter dated from 1928 with the Act regarding non-profit organisations and public service establishments,⁹ and from 2002 with the Act regarding the register of commerce as well as of companies and the accounting and annual accounts of companies, and amending certain other legal provisions.¹⁰ Nevertheless, the new legislation does not change anything with regard to the actual standing or the operational space of NGOs, but introduces certain administrative changes in terms of the registration and publication of such entities in the electronic register.

All NGOs must be registered with the Luxembourg Trade and Companies Register (*Registre de Commerce et des Sociétés*, RCS).¹¹ They must be created with at least three founding members (who may be natural or legal persons, other associations or companies). The founding members do not have to pay any social capital.

The statutes of an NGO may be drafted freely by the parties, but they must contain clauses specifying in particular: the name and registered office of the association; its object; the full names and professions, domiciles and nationalities of the founding members; the conditions for entry and exit of members; the powers and methods of convening the general meetings; the methods of appointment and powers of staff members and directors; the maximum rate of contributions that may be paid by members, and; the rules relating to the amendment of the statutes.¹²

The registered office of the NGO must be in the territory of the Grand Duchy of Luxembourg. All documents (invoices, publications, etc.) issued by the NGO must contain the following information: the name of the association, the term 'Non-profit association' or 'absl', the address of the NGO, and its RCS registration number.

An NGO may obtain municipal subsidies by the city in which its head office is situated. Luxembourg NGOs may benefit from a complete fiscal exemption.¹³ They are not allowed to pursue any for-profit activities, such as industrial or commercial activities, and they may not distribute dividends or profits to its members.¹⁴

Persons or companies wishing to donate money to NGOs may benefit from certain tax advantages, including the deductibility of donations for special expenses under sections 109 and 112 of the Income Tax Act.¹⁵

By means of a request addressed to the Ministery of Justice, non-profit associations may request the recognition of 'public utility status' under Article 26-2 of the abovementioned amended Act of 21 April 1928 regarding non-profit organisations and public service establishments. The request is examined by the Ministery of Justice, who verifies whether the association meets the legal requirements. Furthermore, the Ministery of Justice seeks an opinion of the Ministery of Finance and the Council of State. Following these opinions, a Grand-Ducal decree is adopted. 16

2 EU Member State government funding for nongovernmental organisations – trends and developments 2011-2016

2.1 Overall amount of government funding

In Luxembourg, there are no statistics regarding government funding for NGOs working on human rights. This is because there is no specific statute for 'human rights NGOs', and non-profit associations in the country work on a broad set of issues. Human rights may or may not be part of the mandate and/or scope of activities of such associations, but there is no distinction in terms of funding or statute related to what activities an association carries out, as long as they fall under the legislative framework for non-profit associations or foundations.

The only distinction that exists in this field is for such non-profit associations that work in the field of development cooperation and humanitarian action, which can be recognised as 'development NGOs' (see above, Section 1). Again, however, there is no distinction between

development NGOs that include human rights among their mandates and/or scope of activities and those that do not.

2.2 Distribution of government funding

Regarding the distribution of government funding, NGOs may apply for cofunding of projects and may also conclude agreements (*conventions*) with ministries for public funding of activities. There is no specific rule regarding the distribution of such funding, except the fact that "auto-promotion" is forbidden, i.e. an association may not use public money to increase its own visibility (for example to attract private donors), but to promote the cause for which it is working.

One of the interviewed NGOs stated that they do not ask for government funding for advocacy activities.¹⁷

One NGO representative mentioned that certain activities that focus on support and access to information for persons in vulnerable situations are currently being questioned by the government and funding is at risk.¹⁸

2.3 Restrictions (or other changes) on NGO funding from other sources

The interviewed NGOs did not mention any specific restrictions regarding funding from other sources.

Access to the decision-making process for nongovernmental organisations working on fundamental rights

No specific legislation could be identified regarding the access to the decision-making process for NGOs working on human rights.

In practice, there are a few examples of such participation. The general view of human rights NGOs active in Luxembourg appears to be that there is a rather open climate in terms of communication and information flow with and from the government, ¹⁹ and that the possibility exists for at least a limited form of participation in relevant political fora. Nevertheless, although NGOs have the right to assist in certain platforms (as in be present) this cannot be considered a real and active form of participation. Indeed, all too often the viewpoints of NGOs are heard but not taken into account, or NGOs are present but they are not asked or invited to intervene substantively, and some NGOs expressed their concern with the lack of follow up after an exchange or consultation has taken place.²⁰

Inter-ministerial committees with civil society participation

The Luxembourg Ministry of Foreign and European Affairs (*Ministère des Affaires Etrangères et Européennes*) has set up inter-ministerial committees for development cooperation²¹ as well as for human rights.²² These committees foresee a limited participation also of human rights and development NGOs, which are invited to part of the meetings.

In the case of the inter-ministerial committee on development cooperation, it was established in 2012, and was at the beginning limited to government officials only. In 2016, the Circle of NGOs (*Cercle des ONG*) was identified as a civil society representative to be invited to the meetings, and in July 2016 the Circle was granted status as 'active observer' (*observateur actif*) to the inter-ministerial committee.²³ Theoretically, this means that representatives from the Circle are invited to all meetings of the Committee and are granted access to all documents prepared in view of and after such meetings. This promising practice is, however, not yet fully working at the operational level, and parts of the meetings are still held behind closed doors, and relevant documents are often shared too late to allow any meaningful civil society participation. Since 2016, a few other

large NGOs, such as Caritas and ASTI²⁴, have also been invited to some of the meetings on a more occasional basis.²⁵

Regarding the inter-ministerial committee on human rights, it was set up in 2015 with the objective of improving the cooperation and collaboration between ministries with regard to human rights, as well as to strengthen the coherence between domestic and international human rights policy. The committee has the role of ensuring the respect and implementation of Luxembourg's human rights obligations and commitments, and a dialogue with national institutions and civil society organisations working on human rights is explicitly foreseen.²⁶

The committee has so far met five times, and the meetings have been set up in a dual format, whereby the first part of each meeting is reserved for government officials exclusively, and the second part is open to a number of NGOs working on issues related to human rights.²⁷

NGO representatives stated that the possibility of participating in the committee meetings represents a very positive step in the right direction, because it increases transparency, and enables a direct access and a more direct dialogue with government officials.²⁸ It also increases the information flow from government to civil society. Nevertheless, from a perspective of real and meaningful participation of human rights NGOs in the political decision-making process, there is still a considerable margin for improvement.²⁹

The Ministry of Foreign Affairs, which coordinates the inter-ministerial committee, agreed that there is room for improvement and is currently reflecting upon how to enhance the dialogue by, for instance: increasing the number of meetings, which are currently limited to 3–4 per year; changing the format of the meeting by opening it completely to civil society representatives; moving beyond the more formal conversation and finding ways to enable more substantive discussions on the core matters at stake.³⁰

In general, interviewed representatives from both the Ministry of Foreign Affairs and NGOs were positive toward this new form of exchange, and optimistic that it represents the beginning of a closer cooperation. There was a common understanding that the situation is evolving in the right direction, towards a more open space for NGOs to interact with public authorities.

However, there were isolated incidents where the generally positive dialogue had been more complicated. One example was provided by Amnesty International Luxembourg with regard to their research report on Banks, Arms and Human Rights Violations, published in 2016.³¹ The report, which among its key findings showed that Luxembourg had taken little or no measures to expressly prohibit financial operations related to illegal arms or arms destined to illegal use, and suggested that the country had not fulfilled its international obligations with regard to the prevention of serious human rights violations, was met with strong criticism from the government and from some members of parliament, and it was very clear that the report was unwanted and represented a disturbing element.³²

The Convention on the Rights of Persons with Disabilities (CRPD)

Regarding the implementation of the UN Convention on the Rights of Persons with Disabilities (CRPD), the government has formally mandated two institutions (not NGOs) to be in charge of the monitoring. No NGO has been given a similar mission, and NGOs are not formally invited to participate in the policy-making processes regarding the CRPD.

Nevertheless, several NGOs in Luxembourg work for the rights of persons with disabilities, and attempt to strengthen the awareness and implementation of the CRPD. In the framework of their work, government representatives from a number of ministries are regularly invited to participate in meetings and to enter into dialogues with these associations.³³ Such meetings are arranged by Info-Handicap, a Luxembourgish umbrella NGO which serves as a platform for rights of persons with disabilities and which has about 40 member associations. At an informal level, NGOs are also informed of government decisions through consultations with the Ministry of Family (*Ministère de la famille*).

NGOs working for the rights of persons with disabilities express disappointment with the fact that the government has not enabled a serious, regular and compulsory dialogue with civil society, and that the implementation of the CRPD is still taken too lightly.³⁴

Often, this is also due to the lack of persons with disabilities in Luxembourg that are able to represent the cause at a higher level, something which in turn is linked to a certain level of segregation persisting in the national education system, which means that few people attain the level of higher education.³⁵

When there is a dialogue, the claims that come from NGOs are received but not replied to, and there is no follow up afterwards. There is no participation of NGOs in the policy shaping and decision-making process. Indeed, associations working for the rights of persons with disabilities consider that consultation and meaningful participation of persons with disabilities and their associations are among the weakest points in terms of implementing the CRPD.³⁶

In 2011, the government launched a process to adopt a five-year action plan for the implementation of the CRPD.³⁷ Civil society was invited to participate in the process, and a lot of hopes and expectations were raised among the associations working for the rights of persons with disabilities. Nevertheless, the disappointment was significant when the same organisations realised that the government had chosen to leave out important parts of the CRPD, and that no real discussions had taken place. Furthermore, by the end of 2016, it was observed that the five-year plan had only been very partially implemented and that the government appeared not to have taken the issue seriously.³⁸

In 2017, Luxembourg will be up for review before the UN CRPD Committee for the first time. NGOs in Luxembourg are participating in this process and have sent an alternative report to the Committee to express their point of view. They are hopeful that the recommendations from the Committee will help bring a change. Some of their main claims are "calls for more coherence and coordination in implementation of the CRPD, improved communication and increased consultation in decision-making with the persons with disabilities and their representative organisations".³⁹

The Open Government Partnership

On 1 December 2016, Luxembourg's Prime Minister, sent a letter of intention for his country to adhere to the Open Government Partnership (OGP).⁴⁰ The government has committed to developing and submitting a National Action Plan (NAP) for an open government by June 2017. To elaborate the NAP, the Ministry of Foreign Affairs (department for human rights and international organisations) have taken the lead, and on 31 March 2017 it organised a first meeting with stakeholders from other ministries and institutions, as well as civil society representatives, to introduce the OGP and to have an initial brainstorming session.⁴¹ A 'steering committee' will be set up to continue to elaborate the NAP.
