SUBJECT: Annex I - 2020-03 Management Board budgetary transfer

A budget transfer is proposed to the Management Board. This proposal reduces the Staff expenditure (T1) by  $\[ \le 293,391.47 \]$  and the Administrative Expenditure (T2) by  $\[ \le 236,490.09 \]$ , and reinforces the Operational one (T3) accordingly, i.e.  $\[ \le 529,881.56 \]$ . Only amounts above  $\[ \le 2,000 \]$  are detailed below.

#### Title 1 -Staff Expenditure

An amount of €293,391.47 is requested to be transferred taking into consideration the below surpluses that have been identified on several different salaries-related budget lines, as well as on others non-salaries related ones.

#### 1. SALARIES RELATED BUDGET LINES

The **surpluses on four budget items** are the consequence of changes in staffing that occurred throughout the year and the annual salary adjustments calculated with retroactive effect as of 01/07/2020.

**A01100 - Basic salaries** - surplus of €78,720.05

**A01101 – Family allowances** – surplus of €31,705.13

**A01102 – Expatriation and foreign residence allowance** – surplus of €11,489.86

**A01115 - Contract Agents** - surplus of €82,006.36

#### **NON-SALARIES RELATED BUDGET LINES**

#### Surplus(es)

#### **A01110 - Staff exchanges** - surplus of €38,568.20.

The above mentioned surplus was identified following the annual budget revision on the SNE's allowances in relation to the corresponding recruitment plan. The estimated planned budget is higher compared to the actual expected amount to pay.

The Agency has authorised nine SNE and one "cost-free" SNE position.



Four SNE and and one "cost-free" SNE positions became currently vacant, therefore the amount shall be released.

# A01300 - Mission expenses, duty travel expenses and other ancillary expenditure - surplus of €9,353.31

Following the latest revision of the staff mission budget item and taking into consideration much less travel expenses foreseen due to COVID-19 sanitary crisis, especially in Phase-1, the above identified surplus shall be released.

#### **A01500 – Professional training of staff –** surplus of €33,004.15

Following the latest revision of the professional training of staff budget item and taking into consideration much less training expenses expected due to COVID-19 sanitary crisis, the above identified surplus shall be released.

#### A01820 - Other welfare expenditure - surplus of €3,544.41

Following the annual budget revision on the schooling and in particular to fewer school bus services provided for enrolled children of FRA staff members to Vienna International School establishment, the budget needs to be decreased, therefore the above surplus was identified and the unused appropriations shall be released.

#### **A01900 - Legal services** - surplus of €5,000

During the year 2020 the estimated appropriations have been revised, therefore the above surplus was identified and the unused appropriations shall be released.

#### <u>Title 2 –Administrative expenditure</u>

Title 2 is proposed to be decreased by €236,490.09.

#### A02030 - Cleaning and maintenance

The proposed amount of epsilon19,863.07 can be released due to the reduced costs in terms of cleaning services and materials due to the COVID-19 pandemic.

#### A02040 - Fitting-out of premises

The proposed amount of €25,600 can be released as due to COVID-19 pandemic the initially planned fitting out of premises activities were postponed..

#### A02050 - Security and surveillance of buildings

The proposed amount of €14,404.17 can be released as due to COVID-19 pandemic the security services have been reduced.

#### A02100 - Information and communication technology

The proposed amount of  $\le 33,296.56$  can be released due to the less than expected costs to cover new hardware acquisitions and maintenance services as the Agency is implementing the adoption of cloud services.

#### **A02101 – Software development**



The proposed amount of €14,586.80 can be released due to the reduced costs in terms of software development.

#### A02102 - Other external services for data processing

The proposed amount of €3,379 can be released as less services than those initially indicated were offered by DIGIT.

#### A02200 - Technical equipment and installations

The proposed amount of €9,967.50 can be released as the acquisition of certain technical equipment was postponed for 2021 due to the COVID-19 pandemic situation.

#### A02203 - Maintenance, use and repair of technical equipment

The proposed amount of  $\le 3,000$  can be released as no such technical maintenance services were requested throughout the year.

#### A02210 - Furniture

The proposed amount of €36,541.20 can be released as due to the pandemic less furniture acquisitions due took place.

#### A02230 - Hire of vehicles

The proposed amount of €2,000 can be released as due to the pandemic less use of taxi services took place.

#### A02353 - Departmental removals and associated handling

The proposed amount of €38,552 can be released as due to COVID-19 pandemic the initially planned logistic activities linked to the building works did not take place.

#### A02355 - Publications and reproduction of documents

The proposed amount of  $\in 3,001.30$  can be released due to less publications than initially foreseen.

#### A02400 – Postage and delivery charges

The proposed amount of  $\[ < \]$ 7,187.80 can be released. Due to the pandemic, the Agency changed its practices to the electronic sending of documents and hence resulting to less postage costs.

#### A02550 - Meeting expenses

The proposed amount of  $\[ \le 9,823.91 \]$  can be released as the presence to the office and physical meetings were substantially reduces due to the COVID-19.

#### <u>Title 3 – Operational expenditure</u>

Title 3 is proposed to be increased by €529,881.56. In addition, some internal transfers will take place.



#### **B03100 - Equality and discrimination**

This budget line will be increased by €66,484,75 in order to reach the amount of €160,740 to be allocated to project A.1.4, Additional activities in the area of equality and discrimination based on any ground. It intends to cover the costs of translation of the Handbook on European non-discrimination law in five languages, enabling the FRA to have it available in all EU official languages.

# B03211 – Information society and, in particular, respect of private life and protection of personal data

This budget line will be increased by  $\le 62,050.50$  in order to reach the amount of  $\le 114,750.50$  to cover the translations of the Guide to prevent unlawful ethnic profiling, project B.1.1.

#### **B03230 – Judicial cooperation, except in criminal matters**

This budget line will be increased by  $\le$ 61,940.58 in order to reach the amount of  $\le$ 100,000 for the project B.2.4 Procedural rights of children. This will allow not only interviewing professionals but also children.

#### B03300 - Migration, borders, asylum and integration of refugees & migrants

This budget line will be increased by €154,405.73 in order to cover the translations for the third edition of the Handbook on European law relating to project C.1.1, Asylum, Borders and Immigration.

#### **B03500 - Communication and awareness raising**

This budget line will be increased by €185,000 for two projects as explained below:

- €45,000 for the project E.1.2, Raising awareness and effectively promoting rights. This amount is needed to organise the Annual Human Rights Communicators' Network workshop.
- €140,000 for the project E.1.3, Production and dissemination of FRA output. This amount will serve, among others, to upgrade the FRA website to a new version of Drupal, developing and upgrading the e-Learning, e-development of Charter App, provision of original photographs and video clips, and for social media and target audience analysis.

#### **POLICY RELEVANCE and ADDED VALUE of the PROJECT**

This project fiche accommodates requests during the year for additional research, analysis, assistance and support, which are primarily based on FRA's work in the above areas.

Additional activities in the area of "Non-Discrimination" focus on the Agency's task to provide evidence-based assistance and expertise through targeted engagement with key stakeholders, thereby ensuring that FRA evidence informs and feeds into policy processes at the EU and national levels. This can include activities related to equal treatment and all forms of discrimination, including background research relating to Article 21 on non-discrimination of the Charter of Fundamental Rights of the European Union, as well as on discrimination on the grounds of nationality. This will be achieved through a combination of desk research, meetings with stakeholders and awareness raising through participation at relevant meetings, events and conferences, also following up on reports published by the Agency in previous years. In 2020, FRA will continue its close engagement with the EU High Level group on Non-discrimination, Equality and Diversity supporting the work of the Subgroup on Equality Data.

Work undertaken in relation to the above can encompass analysis with respect to gender, age and disability – depending on the nature of specific requests for input. Particularly, upon demand FRA will continue to provide evidence-based advice to the Commission related to the development of the post-2020 EU Disability Strategy and contribute to capacity building activities on independent living of persons with disabilities, based on Agency's multi-annual research on the transition from institutional to community-based care.

- Make findings of FRA surveys and research available to policy makers;

#### POLICY RELEVANCE and ADDED VALUE of the PROJECT

A trust based relationship between police and the population as a whole and in its diversity can help to prevent unlawful profiling. Such trust can also help to increase crime reporting by victims to the police. As a result, police can better protect victims and this ultimately contributes to achieving a just and cohesive society with less tensions. Applied new technologies in this context such as large scale databases and algorithmic profiling bring along new discrimination and data protection risks.

The work of the Agency in this area builds on the quide on preventing unlawful profiling published in 2018, the fundamental rights based police training manual, the projects on biometrics, surveillance and artificial intelligence, as well as data on police stops and searches in EU MIDIS I and II. FRA was consulted on policy level initiatives by the Parliamentary Assembly of the Council of Europe (PACE), which put in place a motion for resolution to prevent discriminatory profiling and by OHCHR Committee on the elimination of racial discrimination (CERD) which drafted a general recommendation on preventing and combating racial profiling.

FRA support aims at strengthening fundamental rights compliance within the areas of criminal and immigration law enforcement, in particular, by advising authorities in Member States on how to avoid practices that risk resulting in unlawful profiling, by assisting to unveil discriminatory profiling on all grounds, including nationality, age and gender, in addition to ethnic origin. In 2019 and 2020 FRA contributed to building capacities of police officers through CEPOL webinars. FRA has further conducted a conference in cooperation with the Independent Police Complaints Authorities' Network (IPCAN) focusing on fundamental rights aspects of related law enforcement work. A workshop with EQUINET looked into ways how equality bodies can be better equipped to combat unlawful profiling.

In 2020 FRA will aim at strengthening the capacity of those equality bodies that are in charge of handling police complaints to step up and harmonize data collection. FRA will continue working with CEPOL on unlawful profiling and it will further engage with the other JHA agencies, EUROPOL and EBCGA and Member States in the prevention of unlawful profiling, particularly in the context of handling large scale data.

#### **POLICY RELEVANCE and ADDED VALUE of the PROJECT**

The directive on procedural safeguards for children who are suspects or accused persons in criminal proceedings (Directive 2016/800/EU), which is part of the Criminal Procedure Roadmap set out in the Stockholm programme, was adopted in 2016, with the transposition deadline having expired on 11 June in 2019. According to Article 25 of the directive, the Commission shall, by 11 June 2022, submit a report to the European Parliament and to the Council on the implementation of this directive.

The directive aims to enhance the right to a fair trial in criminal proceedings across the EU by laying down minimum rules to make sure that the procedural safeguards for children who are suspects or accused persons in criminal proceedings are respected throughout the EU, in accordance with existing international standards and guarantees; in particular those relating to the child's best interests and the child's right to be heard in accordance with Article 24 of the Charter of Fundamental Rights of the European Union (EU Charter) as well as the right to a fair trial and the rights of defence arising from Articles 47 and 48 of the EU Charter and Article 6 of the European Convention on Human Rights (hereinafter the ECHR). By ensuring the minimum standards across the EU in this area, the new rules are supposed to contribute to the strengthening of the Member States' trust in each other's criminal justice systems.

The project, as requested by the European Commission, will complement the Commission's implementation report due in June 2022, further exploring practices and opportunities in the context of the application of the minimum procedural safeguards under the directive, such as the child's right to a lawyer and legal assistance, individual assessment, and safeguards when children are deprived of their liberty. The project will situate its research in a wider context of an important group of rights known as the 'rights of defence' and, in this way, will build on the findings of FRA's previous projects in this area, namely on: the right to interpretation, translation and information; the right of access to a lawyer and the rights of persons requested under the European Arrest Warrant; presumption of innocence; as well as FRA's work on rights of the child, particularly in the area of child friendly justice and mapping minimum ages in judicial proceedings. Apart from the relevant standards of the EU (incl. the EU Charter) and the Council of Europe such as the Council of Europe guidelines on child-friendly justice, due regard will be also given to relevant standards from the United Nations such as General Comment 24 to the UN CRC on children's rights in the child justice system.

#### **POLICY RELEVANCE and ADDED VALUE of the PROJECT**

The project feeds into EU policy files on legal immigration and migrant integration under Article 79 of the TFEU. In 2003, the EU adopted Directive 2003/109/EC on long-term residents. The directive sets out different rights for long-term residents, including their equal treatment with nationals in a number of areas, security of residence status, enhanced protection against expulsion as well as intra-EU mobility. Currently, 10.5 million third-country nationals in the EU-27 are long-term residents. However, only one out of four, enjoys a residence status based on the EU Long-Term Residents Directive. The rest lives in EU Member States with permits issued under national law outside the scope of application of Long-Term Residents Directive. Findings of the FRA's second EU Minorities and Discrimination survey (EU MIDIS II) have shown that having an insecure residence status decreases the level of trust in public authorities and the attachment to the country of residence. The results of this project intend to fill the information gap on the experiences of long-term residents across the EU. They will shed light on how EU Member States implement the relevant EU legislation and why the take-up of

EU long-term residence status is low, illustrating the impact on the rights of long-term residents, as enshrined in EU law, including intra-EU mobility. The research will pay particular attention to fundamental rights challenges for women, children and persons with disabilities. The FRA research will help EU Member States and EU institutions to take informed measures to further their integration and social cohesion policies from a fundamental rights perspective.

The project follows up on FRA's work on the integration of young refugees and on migrant integration more generally. It will help EU Member States and EU institutions to take informed measures to further their migration, integration and social cohesion policies from a fundamental rights perspective. More specifically, this research takes into account the March 2019 fitness check of the European Commission on EU legislation on legal migration and the implementation report of the Long-Term Residents Directive which reveals that several Member States have not transposed properly the equal treatment principle in their immigration legislation. It also reveals that long-term residents in the EU do not make use of the possibility to move and work in other EU Member States (intra-EU mobility). The fitness check highlights the need to improve data collection on the implementation of the EU acquis. Moreover, the new pact on migration and asylum published by the European Commission on September 23 2020 seeks to facilitate the access to the EU long-term resident status for beneficiaries of international protection. It also suggests a revision of the Directive on long-term residents to promote the use of the EU status on long-term residents by third country nationals living in the EU Member States and to strengthen the right to intra-EU mobility.

The European Commission 2016 Action Plan on the integration of third-country nationals requested FRA to "monitor social inclusion and the participation of third-country nationals in society from a fundamental rights perspective".

This project, which will consist in desk research, analysis of existing quantitative data as well as qualitative field research, is a concrete response to this call.

#### **POLICY RELEVANCE and ADDED VALUE of the PROJECT**

EU institutions and Member States have stressed the need to communicate and raise awareness of fundamental rights. The Agency will continue to develop a range of activities to fulfil this need based on its '10 keys to effectively communicating human rights', which guide the Agency in its own communication work. To this end, FRA has set up a 'Communicating rights Programme', also to ensure the mainstreaming of issues and topics related to gender, children and youth, and persons with disabilities in all of the Agency's communication activities.

PRIORITY 1

In 2020, the Agency will further promote and expand its e-Media Toolkit, to build capacity among media professionals in reporting on migration and asylum issues. Media professionals will benefit from face-to-face training or using webinars in the toolkit's application. In addition, communicators from national human rights institutions, equality bodies and civil society organisations will also be invited to make use of the toolkit and its training opportunities. If successful, the toolkit methodology may be used to develop other online training toolkits, for example on communicating rights or the Charter.

FRA will organise two EU Presidency conferences, convening specific stakeholders, in particular senior officials at EU and national level, as well as civil society, on issues related to fundamental rights, which are of particular importance in the EU policy agenda.

In addition, the Agency will follow up on calls to action included in the Chair's Statement of the 2018 Fundamental Rights Forum and start preparations for the Fundamental Rights Forum in 2021(see dedicated project fiche).

The Agency will continue to communicate fundamental rights, based on set communication priorities for 2020 and informed by its survey and research findings. This will include social media campaigns to promote on the one hand the outcome of specific projects and on the other more generally fundamental rights. In this context, FRA has established a closed Facebook group of human rights communicators to exchange information and experiences on human rights communication. The Agency intends to organise and participate at face-to-face meetings of human rights communicators. In 2020, FRA will follow up on the human rights communicators' network meeting of October 2019. In parallel, the Agency intends to explore the potential for developing an online blog where staff will be able to publish blogs not directly related to the Agency's specific outputs. Senior agency staff will moderate this activity.
