For the organization of the foresight workshop, including the travel and accommodation as well as catering arrangements, FRA and its travel agency AMEX (as FRA's processor) might collect from you the personal data described in section 5 via email correspondence with the experts and via the travel agency online booking tool "Neo" (see data protection notice <u>here</u>). Through email correspondence you will provide FRA with the information allowing us to book your flight and accommodation and – where applicable – to reimburse your travel expenses (e.g. since the travel agency cannot book train tickets, experts who travel by train to/from Vienna will be reimbursed by FRA for their travel expenses).
