The purpose of the processing of the personal data is to collect information and data for the purpose of a research project. The European Commission invited FRA to support the second evaluation of the GDPR by providing qualitative data on the experiences and challenges of national data protection authorities when implementing their tasks and mandate as defined in the GDPR. The GDPR prescribes that the Commission regularly evaluates and reviews the application of the GDPR. The first report was published in 2020, and the next evaluation report is due by mid-2024, starting with a first report after two years of application and every four years thereafter. The project will provide evidence-based advice on the experiences of data protection authorities (DPAs). It will support the European Commission's evaluation report on the implementation of the General Data Protection Regulation (GDPR). The project covers all 27 EU Member States. Data will be collected by FRA experts for four selected Member States (Austria, France, Greece and Italy) and the Agency's FRANET framework contractors for all other Member States, through a combination of desk and fieldwork research. The information provided during the interviews (i.e. not including personal data) will feed into the preparation of a report to be published in 2024. In order to carry out interviews with experts, their contact details and background information about their work and professional status needs to be collected.
