1.1.1	police questioning;	a) The police or the investigator of the case <sup>2</sup> who are in charge of investigating the offence at hand are also in charge of determining whether there is a need to provide interpretation. <sup>3</sup> The investigator is either a police officer conducting an investigation in relation to the commission of a criminal offence, or any person appointed by the Council of Ministers or the Attorney General to conduct interviews in relation to the commission of any criminal office.

- b) In practice, the police officer or investigator appointed will speak to the suspect/accused persons in Greek to check whether they understand.<sup>4</sup> If they find that these persons do not understand, then efforts will be made to identify their mother tongue through their nationality and based on languages spoken in the region of their habitual residence. If no interpreter can be found for their mother tongue, then efforts will be made to find an interpreter that speaks a language understood by the suspect/accused which may not be their mother tongue.<sup>5</sup>
- c) The cost of interpretation is borne by the state. The Attorney General's office reports that in private criminal cases the cost is borne by the plaintiff, although this is not foreseen in any law and may in fact contravene the law transposing the Interpretation and Translation Directive, which does not specify that the state bears the cost only if the criminal prosecution is public.
- d) There is no time frame foreseen in legislation or policy; the law provides only that interpretation must be provided "without delay". The Attorney General's office informs that interpretation is provided immediately after arrest, except in cases where the suspect/accused person is a non-national and the offence at stake is "very serious", in which case interpretation is provided from the point of the arrest. However, the law on the rights of persons arrested and detained foresees a rather different procedure: All persons must upon being arrested, be informed by the arresting police officer in a language understood to them the reasons for their arrest and their rights. In case the arresting police officer does not speak any language understood by the suspect/accused, then as soon as the accused/suspect is admitted to the police station, the arresting police officer must inform the person in charge of the investigation so that the latter can make all necessary arrangements without delay in order for an interpreter to come and inform the suspect/accused of his or her rights in a language understood to him or her. The law does not foresee different procedures for offences which are "serious" or less than serious.

1.1.2	• court hearings;	a)The Courts exercising criminal jurisdiction; in the case of execution of a European Arrest Warrant the judicial authority responsible for such execution, i.e. the district judge in the area where the wanted person is or is believed to be situated. <sup>11</sup> In the event that the wanted person's residence is unknown then a judge of the Nicosia District Court, or if the wanted person's whereabouts are known then a district judge in the area where the wanted person resides or where the wanted person was arrested. <sup>12</sup> b) The judge will ask the accused persons if they understand the language of the procedure. The accused persons' lawyers as well as the public prosecutor may also inform the court as to whether the accused person understands or not the language of the procedure, but the Court will have the final say as to whether interpretation is necessary or not. <sup>13</sup> In fact for all procedures inside the courtroom, the Courts in Cyprus invariably provide interpretation to all persons who are not Greek speakers. <sup>14</sup> c) The cost of interpretation is borne by the state. <sup>15</sup> The Attorney General's office reports that in private criminal cases the cost is borne by the plaintiff, <sup>16</sup> although this is not foreseen in any law and may in fact contravene the law transposing the Interpretation and Translation Directive. The Court's Registrar disputed this information and stated that the Court bears the cost of interpretation irrespective of whether the criminal case is a private or a public prosecution. d) There is no time frame foreseen in legislation or policy; the law provides only that interpretation must be provided "without delay". <sup>17</sup> In practice, the interpretation is provided upon commencement of the hearing procedure.
1.1.3	any necessary interim hearings;	a) The same procedure applies in all types of hearings, whether interim or main. The decision as to whether interpretation is necessary is made by the criminal court trying the case. In the case of execution of a European Arrest Warrant, the decision is made by the judicial authority responsible for the warrant's execution, i.e. the district judge in the area where the wanted person is or is believed to be situated. In the event that the wanted person's residence is unknown then a judge of the

Nicosia District Court, or if the wanted person's whereabouts are known a district judge in the area where the wanted person resides or where she or he was arrested.<sup>19</sup>

- b) The judge will ask the accused persons if they understand the language of the procedure. The accused person's lawyer as well as the public prosecutor may also inform the court as to whether the accused person understands or not the language of the procedure, but the Court will have the final say as to whether interpretation is necessary or not.<sup>20</sup>In practice, the Court will ensure that interpretation is provided in all cases, as the right to interpretation has been safeguarded by the Constitution long before the Interpretation and Translation Directive was transposed.
- c) The cost of interpretation is borne by the state.<sup>21</sup> The Attorney General's office reports that in private criminal cases the cost is borne by the plaintiff,<sup>22</sup> although this is not foreseen in any law and may in fact contravene the law transposing the Interpretation and Translation Directive. The Court's Registrar disputed this information and stated that the Court bears the cost of interpretation irrespective of whether the criminal case is a private or a public prosecution.<sup>23</sup>
- d) There is no time frame foreseen in legislation or policy; the law provides only that interpretation must be provided "without delay".<sup>24</sup> In practice, the interpretation is always provided upon commencement of the hearing procedure, but does not extend to any time before or after the court hearing.<sup>25</sup>

1.1.4		a) The police or the investigator of the case <sup>26</sup> who are in charge of investigating the offence at hand are also in charge of determining whether there is a need to provide interpretation. <sup>27</sup>
	Any communication between suspects and accused persons and their legal counsel in direct connection with any questioning or hearing during the proceedings?	b) In practice, the police officer or investigator appointed will speak to the suspect/accused persons in Greek to check whether they understand. If they find that these persons do not understand, then efforts will be made to identify their mother tongue through their nationality and based on languages spoken in the region of their habitual residence. If no interpreter can be found for their mother tongue, then efforts will be made to find an interpreter that speaks a language understood by the suspect/accused which may not be their mother tongue. Legal practitioners confer that the police always finds suitable interpreters, either in the accused/suspected persons' mother tongue or in a language they understand. However the interpretation is used only in order to explain to the accused/suspected persons their rights and to record their testimony and not to the communication between the accused/suspected persons and their lawyers. <sup>28</sup> c) The cost of interpretation is borne by the state. <sup>29</sup> The Attorney General's office reports that in private criminal cases the cost is borne by the plaintiff, <sup>30</sup> although this is not foreseen in any law and may in fact contravene the law transposing the Interpretation and Translation Directive.
		d) There is no time frame foreseen in legislation or policy; national law merely provides that interpretation must be provided "without delay". <sup>31</sup> The Attorney General's office reports that interpretation is provided immediately after arrest, <sup>32</sup> therefore all communications between a suspect/accused and his or her lawyer fall within the scope of the law but communications with one's lawyer prior to the arrest are not covered by the right to interpretation.
1.2	How do authorities ensure interpretation into rare/lesser known languages where no certified interpreters exist?	If no interpreter can be found to provide interpretation in the mother tongue of the suspect/accused person, the competent authority will endeavour to find an interpreter to interpret in a language understood by the suspect/accused. In practice, the competent authority will attempt to ascertain what language the accused /suspected persons understand by just speaking to them. For the purposes of court hearings, lawyers are expected to detect the language spoken by their clients and inform the

	Please cross-check findings from the desk research by consulting relevant organisations and/or practitioners.	court in order to have an interpreter ready. <sup>33</sup> The Court summons interpreters from a list which it compiles and maintains but if none of the interpreters listed there can interpret in the language spoken by the accused or suspected person, then the Court will contact the government's Press and Information office which maintains a larger database with all or most of the interpreters available in the country. <sup>34</sup> As a last resort, double interpretation may be used, i.e. one interpreter interprets from the lesser known language to a better known one such as English and another interpreter interprets from English to Greek.  The police will provide an interpreter for the purpose of taking the accused/suspected person's statement but not for facilitating communication between accused/suspected persons and their lawyers. <sup>35</sup> even though the right to interpretation in communications with their lawyers is foreseen in the law. <sup>36</sup> A list of interpreters is maintained at the central police headquarters, accessible to all police officers through the police's portal. This database currently lists interpreters for 37 different languages, but if the police still cannot locate an interpreter to interpret in an language understood by the accused/suspected person, then they will contact wither the government's Press and Information Office or the Courts in order to locate interpreters. <sup>37</sup> In cases where the immigration police are involved, information regarding languages understood by the accused may be derived from qualifications which the suspect/accused has presented in order to find work in Cyprus or to enrol in a college in Cyprus. For instance, if the documents which the accused had presented to the immigration authorities when applying for a visa included a certification or a declaration of knowledge of English, then the accused/suspect will be presumed to understand English. <sup>38</sup>
1.3	Please describe procedures in place, if any, to ensure that suspects or accused persons have the right to challenge the	The right to orally contest a decision of the competent authority not to provide interpretation is provided in the law, although no particular procedure is foreseen for such challenge. <sup>39</sup> The authority which is competent to examine such contestation is the

same competent authority that rejected the request for interpretation, which is under a duty to record in the minutes of the procedure both the oral challenge as well as its own justified decision on it.<sup>40</sup>

The right to challenge a decision not to provide interpretation does not affect the deadlines applicable for the execution of a European Arrest Warrant, <sup>41</sup> in other words the procedure of execution of European Arrest Warrants will continue irrespective of whether the accused/suspected persons have challenged decisions not to provide them with interpretation.

According to the Attorney General's office, <sup>42</sup> as far as the court procedure is concerned, there is no possibility for interpretation to be denied to an accused or suspect requesting for it, as that would amount to a violation of the Constitution, which provides for the right to an interpreter, <sup>43</sup> and to a breach of the right to a fair trial, foreseen in the Constitution <sup>44</sup> and in a number of international instruments ratified by Cyprus, such as the ECHR. In the unlikely event that a district court refuses to provide interpretation, the accused/suspect may apply to the Supreme Court for a mandamus order ordering the district court to provide interpretation. <sup>45</sup>Lawyers consulted confirmed that the right to interpretation during court hearings is invariably respected by judges. <sup>46</sup>The constitutional right to interpretation covers only court proceedings and does not extend to police investigations or communications with one's lawyer, but other legislation provides for the right to interpretation in communicating with one's lawyer. <sup>47</sup> A refusal to provide interpretation at the stage of the police investigation can be challenged through judicial review of an administrative act under the Constitution. <sup>48</sup> However, no legal aid is provided for these procedures <sup>49</sup> and information about these procedures is not included in the information documents supplied to the suspects/accused. A number of administrative procedures are also in place in order to challenge acts or omissions of the police in general, such as

Yes the law allows the use of remote interpretation technologies, unless the physical presence of an interpreter is necessary to secure the right to a fair trial. <sup>54</sup> The law does not provide an exhaustive list of criteria as to the factors deemed necessary in order to secure the right to a fair trial, but states that it is necessary to ensure in particular that the quality of the interpretation is such so that accused or wanted persons understand the case against them and can prepare their defence. However this provision does not preclude the other prerequisites for a fair trial which are foreseen in article 6(3) of the European Convention on Human Rights, which are copied almost verbatim into the Cypriot Constitution. <sup>55</sup> There is no express provision as to the stages at which technologies may be used, but in the absence of exclusion it may be presumed that this applies to all stages

This document must set out the reasons for the arrest and the criminal act which the arrested persons are accused of, the right to a lawyer, access to legal aid, the right to translation and interpretation, the right to remain silent, the right to access to documents relating to the court case against them, the right to inform consular authorities and other persons, the right to emergency medical care, the maximum period of detention and the right to challenge their arrest and detention.<sup>66</sup>

An elaborate document of rights has been drafted, for use by the police in order to inform persons arrested of their rights, in line with the above legislative provision. <sup>67</sup> In practice, however, the police hands to persons arrested a document of rights that is significantly shorter (one page) and contains only basic information about the right to legal representation and other basic rights. The longer document is not yet used because it still in the process of being translated into languages other than Greek, but the police will engage an interpreter to explain its contents to the accused or suspected persons. The short document of rights is available in several languages. <sup>68</sup>

In spite of the legislative provision, in practice the police does not supply translation of any documents, although the interpreter invited by the police to assist with the taking of the statement by the accused or suspected person will also provide an oral summary of essential documents. Oral translation of documents is usually done by the accused or suspected person's lawyer.<sup>69</sup>

No particular procedure is foreseen in order to determine whether oral translation or oral summary of documents may be provided instead of written documents. The decision to provide information orally rather than in writing is made by the competent authority at the particular time, being the police or the appointed investigator during the phase of the police investigation, or the Court during the judicial procedure. The only precondition for this determination is that the oral translation or oral summary must not prejudice the right to a fair trial. <sup>101</sup> There is no policy or guidelines as to how this decision is to be made, which is left to the discretion of the authority exercising competency at the particular phase of the procedure.  In practice, no written translation of any documents is provided. Outside the court rooms, lawyers will translate the essential documents for their clients orally. Inside the courtroom. Oral translation of written documents is provided by the Court's interpreter. <sup>102</sup>

### 2.3

Please describe procedures in place, if any, to ensure that suspects or accused persons have the right to challenge the decision that no translation is needed? Please cross-check findings from the desk research by consulting relevant organisations and/or practitioners.

National law provides for the right to orally challenge a decision of the competent authority not to provide translation although no particular procedure is foreseen for such challenge. The authority which is competent to examine such challenge is the same competent authority that rejected the request for translation. The right to challenge a decision not to provide translation does not affect the deadlines applicable for the execution of a European Arrest Warrant, in other words the execution of European Arrest Warrants will continue irrespective of whether or not the accused/suspected persons have challenged decisions not to provide them with translation.

Depending on the circumstances, a refusal to provide translation may, in addition to violating the law transposing the Interpretation and Translation Directive, violate the constitutional right to a fair trial. In Cyprus, constitutional rights are actionable per se<sup>107</sup> but additional procedures are also foreseen in the Constitution. In the case of a district court refusing translation, the accused/suspect may apply to the Supreme Court for a mandamus order ordering the district court to provide the translation. The refusal of the police to provide translation of essential documents at the stage of the investigation can be challenged through judicial review of an administrative act under the Constitution. However, no legal aid is provided for these procedures and information about them is not included in the information documents supplied to the suspects/accused.

Yes		There is no express provision in national legislation for translation of all documents that a suspected or accused person is asked to sign, however this can be implied from the general right to translation of all documents which are essential in order for this person to have a fair trial. 111  In practice, accused or suspected persons are asked to sign their statement in their mother tongue or in another language they understand; this will subsequently be translated into Greek but the accused or suspect will not be required to sign the Greek translation of their statement. Other documents, such as the waiver of the right to interpretation or translation or the declaration that a particular lawyer's services are no longer required may be signed in Greek, following an oral summary provided by the interpreter or the accused's lawyer, as the case may be. 112 Although it is a generally accepted and respected principle that no person should be required to endorse the contents of a document he or she does not comprehend, in practice there are 'grey areas' where suspected or accused persons speak a little Greek and police officers ask them to sign a document in Greek which they do not understand, on the false promise that this will secure their release. 113 There have been cases reported where persons in police custody were asked to sign a withdrawal of their asylum application in Greek. 114  Examples of documents which an accused or suspected person may be asked to sign while in police custody are attached to the long document of rights which has been prepared for handing to persons in police custody, but has not been translated yet: a form stating that the signatory no longer wishes to receive the services of a particular lawyer, confirmation of receipt of the document of rights and statement as to whether the accused or suspected person wishes to be examined by a doctor or not.

d) Which professional qualifications are needed by:	Brief Description:  In order to be listed in either of the two registers a degree in interpretation is required. Yes		Apart from a duty of confidentiality contained in national law, as detailed in the following paragraph, there are no requirements or procedures to ensure the independence of interpreters or translators. An interpreter's independence is usually tested in practice and persons found to lack independence are removed from the registry. There are no criteria in order to test the interpreters' independence and there is no testing done on a case-by-case basis. Instead, interpreters will be removed from the list if accidentally found to be biased or to have an interest in the case or otherwise conduct themselves in an inappropriate manner. There have been cases where interpreters were found both by the Courts and the police to engage in practices during interpretation which were inappropriate and they were immediately replaced. Lawyers also report that in some cases the interpreters used in procedures involving asylum seekers were found to be connected to the embassy of the country of origin of the asylum seeker.

Yes	National legislation provides for the right of accused or suspected persons to orally challenge the adequacy of a translation or an interpretation in order to safeguard the conducting of a fair trial. The competent authority must instantly decide on the claim and record in the minutes of the procedure both the claim and its own reasoned decision. In the event that the competent authority accepts the claim of the accused or suspected person, then it must take all necessary measures for providing translation or interpretation in accordance with the law. <sup>140</sup> In practice, no special procedure is foreseen in order for accused or suspected persons to complain about the quality and independence of interpretation or translation, although this may happen unofficially particularly where quality is concerned.  During police investigations, the accused or suspected persons can complain to the investigating officer about the quality of the interpretation. The police officer in charge may or may not replace the interpreter, based on whether or not they deem that the complaint has substance or not. If the complaint is directed against an interpreter whom the police know from previous collaborations to be good, it is likely that the interpreter will not be replaced. Complaints of lack of independence are more difficult to substantiate, but if they can be proven (e.g. the interpreter is an employee of the embassy of the country that has requested the extradition of the accused or suspected person) then the police are very likely to replace the interpreter immediately. <sup>141</sup> During court hearings, the accused may complain to the judge orally and directly that the quality of the interpretation is unsatisfactory, in which case the judge will instantly instruct the Registrar to replace the interpreter with another. 	a) suspect or accused persons with physical impairment or disability;	Yes	National law provides that the right to interpretation includes "appropriate assistance" such as the use of sign language for those suspected or accused persons with a hearing or a speech problem. <sup>145</sup> The law offers no additional examples of what other "appropriate assistance" is entailed in the right to interpretation. However, the law on persons with disability safeguards the right of persons with disability to access to information and communication with special means where this is deemed necessary, especially for certain groups of persons with sensory disabilities. <sup>146</sup>

comes to be in possession of new material which it intends to use in the procedure, the accused must again be given access to this new material. <sup>159</sup> The derogation of article 7(4) of the Directive on the Right to Information is copied verbatim into national law. <sup>160</sup>

The scope of the law providing for the right to information does not extend to persons not placed under arrest, who are merely invited for questioning.

The criminal procedure law provides that criminal investigators may request any persons they believe to be aware of facts concerning an offence under investigation to attend any place and at any time in order give a statement. The investigators record the statement and then present it to the person to read and sign. If the person refuses to sign it, the investigator will sign it instead, marking the reason for the person's refusal if this is known. A statement that is proven to have been signed voluntarily by the person can be presented in court for the purpose of a criminal procedure. <sup>161</sup> It may be inferred from this provision that the statement can be presented in Court only where the investigator can prove that the person signed the statement in full understanding of its contents, either because the statement was recorded in a language understood by this person or because interpretation was provided.

b) The information provided in (a) above, first paragraph, need only be provided orally in a language understood to persons arrested and detained. However the police is also under a duty to provide a document of rights in a language understood to the persons arrested and detained, setting out the right to access a lawyer, any right to legal aid and the preconditions for such legal aid, the right to translation and interpretation, the right to remain silent, the right to access prosecution documents, the right to inform their consular authorities and other persons, their right to access emergency medical care, the maximum period in detention before appearing in court and the right to challenge the legality of their arrest and detention. If this document is not available in a language understood to persons arrested and detained, its contents are orally explained to them and the document must be supplied to them in a language they understand without unjustified delay. <sup>163</sup>

	The document of rights setting out the above rights is currently only available in Greek, although its translation into 16 languages is currently under way. 164  In practice, the police do not provide written translation for the arrest warrant, the detention order or the affidavit based on which the arrest warrant and detention order were issued. The police interpreter and/or the accused persons' lawyers supply the persons accused or suspected with an oral summary of these documents. Their consent will accelerate the procedure but the decision to consent cannot be revoked subsequently.  Persons who do not consent to their surrender have the right to a hearing before the Court.  For persons arrested under a national arrest warrant the letter of rights provides:  The right to be informed in a language they understand the reasons for their arrest or detention and the act which they are alleged or accused of having committed;  The right to receive assistance from the police in contacting a lawyer;  For persons who have difficulties in exercising their right to communication due to an intellectual or physical disability, the right to assistance in order to exercise such right from a state social worker or a medical worker whose services must be made available immediately or as soon as possible after their arrest;  The right to be supplied with a list of all registered lawyers and their contact details;  The right to confidential interviews with their lawyers any day and time in a private space which is not visible or audible to any member of the police and to exchange oral or written confidential instructions;  For persons under 18 to persons who do not fully understand their rights as a resu

- The right to free interpretation to assist in communications with their lawyers, who is under a duty of confidentiality as regard the content of that communication;
- The right to free translation of all essential documents (arrest warrant and or detention order, the indictment, any court decision or order within the procedure or any other document deemed essential by the competent authority acting wither on its own initiative or following a justified request from the arrested persons or their lawyers). In some cases, an oral interpretation or an oral summary may be provided instead of a written translation;
- If the arresting police officer does not speak a language understood to the arresting persons to inform them of their rights upon arrest, information must be supplied as soon as possible and in any case before questioning starts;
- The right to interpretation with a doctor in case medical care needs to be provided, if the doctor asks for it;
- The right to remain silent;
- The right to access essential documents (arrest warrant, detention order, the application and the sworn statement on the basis of which the arrest warrant) was issued in order to challenge the legality of the arrest or the detention. In the event that the case is referred to the Court, the right the access statements and testimonies acquired during the investigation of the case;
- The right to inform a person, such as a member of their family or their employers, of their arrest. This right may be restricted temporarily);
- The right to contact their consular authority or embassy;
- For persons under 18 the right to contact their parents or guardians and to inform them of their arrest and the place of their detention;
- The right to communication may be restricted for up to 12 hours from arrest if there is reasonable suspicion that the exercise of this right may lead to the destruction or hiding of evidence relating to the case, prevent the arrest or detention of another person or lead to another person's escape, lead to the commission of another offence or to the death or bodily injury of any person, or damage the interests of the Republic or the constitutional or public order or interfere with the delivery of justice;
- For persons who cannot exercise the right to communication without assistance due to a physical or intellectual disability, the right to exercise this right with the assistance or in the presence of a state social worker or medical worker, who must be placed at their disposal as soon as possible after arrest or within 12 hours.
- For persons who due to an intellectual disability do not understand or cannot be informed of their rights to communication, their right to have a relative contacted in a language understood to the relative, regarding their arrest and the place where they are detained;
- The right of foreigners to contact their consular or diplomatic authority as soon as practicable after the arrest in the presence of the police and in the event that there is no consular or diplomatic mission of their country in Cyprus then the office of the Ombudsman.
- The right of persons who due to an intellectual disability do not understand or cannot be informed of their rights to communication, the right to have their consular or diplomatic mission or the Ombudsman informed by the police.
- The right to emergency medical treatment by a doctor of their choice (in which case the cost is borne by the persons arrested themselves) or by a state doctor;

- The right to be medically examined or treated in a private space not visible or audible by the police unless the police has reason to believe that the bodily integrity of the doctor is at risk in which case the medical examination will take place in a place visible (but not audible) to a police officer of the same sex as the detained person;
- For persons under 18, the right to have their parents or guardians attend every medical examination or treatment;
- The right to interpretation in the communication between detained persons and the doctors, provided the doctors request for it;
- The right to be presented before a judge within 24 hours from arrest, where a hearing will be heard to decide on the continuation of their detention or their release;
- The right to be visited daily by a relative or another person of their choice and in the case of persons under 18 by their persons for a maximum of one hour each time in a private space within the detention centre in the presence of a police officer;
- In the case of foreigners, the right to be visited daily for maximum one hour by members of their consular or diplomatic mission in Cyprus and in the event where there is no such consular or diplomatic mission of their country in Cyprus the right extends to international or national human rights organisations
- The right to exchange letters with their lawyers which will not be opened or read by the police except in exceptional circumstances where the police has cause to believe that the envelope contains in illegal object in which case the letter is opened in the presence of the detainee;
- The right to exchange letters with the European Court of Human Rights, the Attorney General, the Ombudsman and any international or national human right organisation with competence to investigate allegations for human rights violations without having these letters opened by the police;
- The right to exchange letter with relatives, friends or other persons on the condition that these will be checked by the police in the presence of the detainee and be confiscated if they are found to enclose an illegal object or if they place the security of the detention centre or other detainees at risk or the content is otherwise criminal or is likely to obstruct the investigation of offences;
- The right not to be subjected to torture or inhumane or degrading treatment;
- The right to dignified treatment;
- The right to occupy a cell of a reasonable size with essential facilities and conditions of hygiene, sufficient light and ventilation and suitable recreational equipment;
- For detainees under 18, the right to occupy ells separately from other detainees;
- The right to occupy cells separately from detainees of the opposite sex;
- Women detainees have the right to treatment that does not directly or indirectly amount to sexual harassment or moral degradation;
- Women detainees have the right to breastfeed and to reside with their babies in their cells at their own cost;
- Women detainees are entitled to goods of personal hygiene or they are entitled to be supplied with such goods of their own choice at their own expense;
- Women detainees who are pregnant are entitled to arrangements so as for their pregnancy not to be adversely affected;

According to the police, for non-Greek speaking persons in detention, its contents are orally translated by the interpreter engaged by the police to assist with the taking of the statement. There are no procedures in place to verify if the language is indeed sufficiently simple and whether its contents have in fact been understood by the suspect/accused person.

In case the arrest is made with an arrest warrant issued by the Court, then the arrest warrant, which must be shown to the person arrested, will also mention briefly the act for which the person is being arrested. <sup>199</sup>
3.2	At which stage of the proceedings is the information provided? Please crosscheck findings from the desk research by consulting relevant organisations and/or practitioners.	If the arresting police officer speaks a language that is understood by the persons arrested, then the information about the reason for their arrest will be provided upon the arrest or as soon as possible after the arrest. 		their arrest and the act they are being accused of as soon as possible and in any case before questioning begins. <sup>200</sup> This provision is normally implemented without problems. <sup>201</sup> If the person is not arrested, then the police investigator will ask the person to visit the police station for questioning. During the questioning, the investigator records the statement and then presents it to the person to read and sign. If the person refuses to sign it, the investigator will sign it instead, marking the reason for the person's refusal if this is known. A statement that is proven to have been signed voluntarily by the person can be presented in court for the purpose of a criminal procedure. <sup>202</sup> It is therefore up to the investigator to ensure that the person giving the statement understands its contents in order to secure his or her signature on the statement. 4.1	What material evidence can be accessed by suspected or accused persons (e.g. documents, photographs, audio, video, summaries)?	National law does not describe in great detail the type of material that accused persons can have access to. Criminal procedure rules provide for access to "essential materials" which it defines as the arrest warrant, the application and the affidavit on the basis of which the court orders were issued. These materials clearly do not include photographs or videos or audio material. Accused persons are also entitled access to "testimonies and documents" acquired during the investigation of the case as well as to "new material" acquired by the prosecution which will be used in Court. Although the law is silent on whether

Please cross-check findings from the desk research by consulting relevant organisations and/or practitioners.	photographs, video oraudio material are included in the definition of 'testimonies and documents', it may be inferred that to the extent that photographs, audio, video and other material can be also be presented in court as testimony, 208 the right to access testimonies cannot be interpreted as excluding those.  The law requires that essential materials are supplied to the accused persons or their lawyers "promptly". 209 Although no interpretation of this term is provided in law or in case law, it may be interpreted to mean that the documents must be supplied on time to enable the accused persons to prepare their defence and/or to challenge the legality of their arrest and detention. Given that the first appearance before the court in order to obtain a detention order is within 24 hours from arrest, it is possible to conclude that the documents needed for accused persons to challenge their detention must be supplied early in these 24 hours. In practice, the arrest warrant and the documents on which the arrest was issued are supplied to the accused persons' lawyers as soon as they arrive at the police station where their clients are detained. 210
4.3	Under what circumstances is access to material refused? Who takes the decision of refusal?	Provided the right to fair trial is not adversely affected, access to part of the testimonies and documents acquired in the process of the investigation may be refused if such access is likely to put at risk the life or fundamental rights of another person or in the case that such refusal is considered absolutely necessary for the protection of important public interest or where access is likely to interfere with the conducting of an investigation or is likely to seriously damage national security. The refusal decision is taken by the competent authority at the time, being the police or the investigator at the stage of police questioning or the Courts at the stage of the hearing. Where the refusal decision is taken by the police or the investigator, this is subject to judicial review. Where this decision is made by the courts, it is subject to reversal by a higher court.

A breach of this duty entitles the suspected or accused person to file a lawsuit for compensation against the state and against the member of the police or the prison staff or the director of the detention centre and claim fair compensation irrespective of whether or not the breach of this duty has caused any nominal or monetary damage or loss. <sup>217</sup> Police officers who are found to be in breach of any of their duty to provide information to persons arrested or detained or who violate any of the other rights of detainees are guilty of criminal and disciplinary offences. <sup>218</sup> However, unless the suspected or accused person commences a private criminal case against such police officer, which can at any time be interrupted by the Attorney General, the discretion as to whether a public prosecution is to be initiated rests with the Attorney General. <sup>219</sup> Complaints against police officers in breach of their duties may also be filed with the Ombudsman <sup>220</sup> and with to the Independent Authority for investigating Complaints against

	a) information on procedural rights		National law regulating the rights of persons arrested and in detention provides that every time information is provided to an arrested person under this law, this must be recorded in the relevant investigation file, marking also the date and time of providing such information. <sup>228</sup> The investigation file must also be informed every time an arrested person demands to exercise any of the rights foreseen in the law, with date and time of the exercise of the right. The file must also be updated every time a right was not exercised, noting also the reasons for such non-exercise. <sup>229</sup> The waiver of any of the rights foreseen under this law must also be recorded in the investigation file and the arrested persons will be asked to sign this waiver; in case they refuse, the waiver will be signed by the investigator. <sup>230</sup> The law covers the right of persons arrested to be informed immediately after their arrest in a language understood to them the reasons of their arrest and detention and the act which they are accused of, the right of access to a lawyer and to legal aid, the right to interpretation and translation, the right to remain silent and the place of their intended detention. The law does not require that the accused acknowledges in writing receipt of the letter of rights.
