In October 2010, the Telemadrid TV Channel had broadcasted a report entitled "Twelve magnets of jhaa in Spain" (Los doce imanes de la yihad en España). It linked two well-known Muslim leaders based in Catalonia with "Islamist" terrorism. The report contained images and opinions linked to terrorist attacks such as the twin towers in New York or the bombings of trains in Madrid. The report made reference to the existence of active jihadist cells without identifying if the claimants did belong to these terrorist cells, or if the claimants were targeting or radicalising activists terrorist. | The Supreme Court ruled against Telemadrid TV Channel for attacking the honor of two religious leaders.
