The Supreme Court declared that the party "Spartiates" does not fulfil the criteria for participating with a ballot at the European Parliament Elections due to its ties with the Golden Dawn members that had been convicted as a criminal organisation for various crimes including racist violence, attacks against migrants, anti-migrant speech, etc.	The party was barred from participating in the 2024 EU Elections.	The Supreme Court decided that the party "Spartiates" did not fulfil the criteria of the law, given that one of its members was a founding member the criminal organisation Golden Dawn and had been convicted for various crimes including racist violence, anti-migrant speech, xenophobia, online hate speech, incitement to violence, etc. It therefore, could not participate in the 2024 EU elections.	The Supreme Court recalled its previous decision (95/2023) for the 2023 national elections, where the same founding Golden Dawn Member attempted to run as an MP candidate with the party "ELLINES". The Court noted that a party that is aligned with the Golden Dawn ideology does not respect democracy, wishes to abolish its institutions and the rule of law with the use of force, by promoting intolerance and xenophobia and condoning human atrocities. "In the present case, it appears that the Spartiates party, whose real leader is [...], convicted [...] for the offence of belonging to and directing the criminal organisation "Golden Dawn" [...] promotes a policy that does not respect democracy and aims to weaken and dismantle the democratic constitution and the institutions of the rule of law, in particular by using violence or inciting violence and justifying it, promoting totalitarian ideologies, disseminating racist and intolerant ideas and xenophobia, condoning crimes against humanity, hatred against individuals and groups, actions and declarations that threaten the peaceful coexistence of social groups in the country. "
