Christoffer Badse position with JUSTITIA (2024 -) an independent legal think tank is at the level of Chief Legal Consultant working with analyses and advocacy on issues relating to the principles of the rule of law, vulnerable groups, structures and processes of a democratic state and fundamental rights.

Mr. Badse is (2024) studying Diploma of Leadership, which will be finalised in 2025.

Mr. Badse position with UNICEF DANMARK (2022 – 2024) was at the level of Senior Legal Advisor working with legal monitoring and advocacy in relation to a wide range of challenges to domestic implementation of the rights of the child in Denmark and Greenland (climate, digital issues, rule of law and participation) and reporting to the UN regarding obstacles and progress and cooperating with civil society organisations and other stakeholders.

Mr. Badse has held various positions at THE DANISH INSTITUTE FOR HUMAN RIGHTS – Denmark's National Human Rights Institution (2003 – 2022), including 7 years as department director for the legal NHRI monitoring department of the institute, where the mandate as the NHRI of Greenland and the cooperation with the Greenlandic Council for Human Rights also was placed.
