SUBJECT : Implementing rules of the Staff Regulations

THE EXECUTIVE BOARD OF THE EUROPEAN UNION AGENCY FOR FUNDAMENTAL RIGHTS,
HAVING REGARD to the Council Regulation (EC) n° 168/2007 of 15 February 2007 establishing the European Union Agency for Fundamental Rights (FRA), and in particular Article 24 thereof,

HAVING REGARD to the Staff Regulations of officials of the European Union and the Conditions of employment of other servants of the European Union as laid down by Council Regulation (EEC, EURATOM, ECSC) n° 259/68, and in particular Article 110(2) of the Staff Regulations,

After consulting the Staff Committee and subject to final adoption of the implementing rules by the Commission,

Whereas:

- (1) Regulation (EU, Euratom) No 1023/2013 of the European Parliament and of the Council of 22 October 2013 amending the Staff Regulations of Officials of the European Union and the Conditions of Employment of Other Servants of the European Union introduces, with effect from 1 January 2014, significant structural changes to the applicable legal framework.
- (2) It is therefore necessary to adapt the relevant implementing rules to this new legal framework.
- (3) It is necessary to adopt the implementing rules listed in Annex I with an earlier implementation date than that foreseen under Article 110(2) of the Staff Regulations in order to ensure business continuity,


HAS DECIDED AS FOLLOWS:

Article 1

The Agency shall adopt the implementing rules adopted by the Commission to give effect to these Staff Regulations, and listed in Annex I, with a date of entry into force 01 January 2014.
