### ONLINE PROGRAMME

Findings of the European Union Agency for Fundamental Rights (FRA) and the European Commission confirm the underutilization of the EU Charter for Fundamental Rights. The imperative to bolster the Charter's effective application is recognized in the "Strategy to strengthen the application of the Charter of Fundamental Rights in the EU", adopted by the European Commission in 2020, as well as in the subsequent Council conclusions on strengthening the application of the Charter of Fundamental Rights in the European Union. The "Annual EU CharterXchange" is an initiative of the FRA together with the European Commission to increase the exchange of knowledge and experience and foster collaboration among experts, policymakers, and stakeholders through a regular forum dedicated to enhancing the application of the rights enshrined in the EU Charter.
