Information has also been taken from secondary sources such as the 2009 APAV study on Victims in Europe.¹ While phase 2 of the project was divided into two parts, focusing firstly on generic victim support services and secondly on specialised areas of victim support, this third phase of the project, comprised of Parts A and B, will focus principally on the structure or lack thereof of generic victim support services; although a limited number of questions relate to specialised areas of victim support. For this part, please provide detailed, concise answers. Generally, crisis accommodation is accessible without obstacles, as victimisation is sufficient reason for provision of services, but transition to long-term accommodation, that is – to safe houses tends to be more problematic because of financial constraint. The organisations, however, reported that they try to obtain donations for food and other necessities and to provide for the regularisation of legal status of victims. ¹⁶

In Slovenia, there are no bodies or ministries with the overall or coordinating role in organising victim support services. The relevant ministries address issues within their competences. (Please see the above comments for more details)

3. What is the legal basis for the type of victim support model that exists in your country (e.g. is it stipulated somewhere in a legal instrument that victim support services be state-run; state-funded etc.?)

Specific legislation governing work of victim support services have not been adopted in Slovenia. These services are mainly regarded as social welfare services aimed at preventing and eliminating social distress and difficulties faced by individuals, families and population groups. The principal law governing this field is the Social security Act (*Zakon o socialnem varstvu*).²² The law stipulates that services may be provided and programmes may be implemented, on not-for-profit basis, by both the public and private sector. Although not explicitly stated by the law, these services and programmes may also target victims of violence and crime. In practice, Social work centres, which are public bodies, and non-governmental organisations provide the relevant services. Services provided by the Social work centres are funded by the state, but the state also provides, on the basis of public calls, for considerable funding of programmes implemented by NGOs. For instance, the area of family (i.e. domestic violence), including assistance to victims of such a type of violence, is an area most comprehensively addressed in the current legislation. The Family violence Act (*Zakon o preprečevanju nasilja v družini*) stipulates that Social work centres shall have the coordinating role in dealing with individual cases, and that state shall plan funds for activities in this area, including for activities carried out by NGOs.²³ Generally, NGOs are established as societies or institutes in accordance with the Societies Act (*Zakon o društvih*) or the Institutes Act (*Zakon o zavodih*), respectively.²⁴ Specific measures such as payments of compensation to specific groups of victims, as set out in the Crime victims compensation Act (*Zakon o odškodnini žrtvam kaznivih dejani*),²⁵ and provision of free legal aid governed by the Free legal aid Act (*Zakon o brezplačni pravni pomoči*),²⁶ are funded by the state.

2	Is there a separate definition of 'vulnerable victims' (as separate from the main or generic definition of 'victim')?	In terms of criminal legislation, there is no explicit separate definition of vulnerable victims. The Criminal procedure Act, however, defines certain specific measures which are only applicable to certain groups, thus indirectly recognising vulnerability of these specific groups. These include particularly children (e.g. considerate examination of minors – if required, in presence of a pedagogue or a similar expert, prohibition, for certain crimes, of the direct hearing of a minor below the age of 15 and instead the reading of the minutes from the investigation phase, continuous presence of an attorney for children victims of certain types of crimes, the presence of trusted person during procedures). The latter measure also applies to victims of violence. Additionally, when a victim acts as witness, they may be granted certain additional measures if disclosure of their personal data or identity represents serious danger to their life or body (e.g. deletion of some or all personal data from the criminal life, taking of their testimony using technical devices, inclusion in witness protection programme). ⁹⁴ The Prevention of family violence Act, a piece of civil legislation governing actions of various organisations when dealing with the mentioned type of violence, lays down special protection of children against violence. A child shall be considered a victim if only present at the scene of violence. Special care and provision of assistance shall also be granted to elderly, persons with disabilities and person who are not capable to take care for themselves. ⁹⁵

2.6.4 Rights of victims at trial

The International Criminal Court (ICC) has created a special unit for victims and witness to provide support before, during and after the trial. Services are delivered by professionals who are often salaried employees of the court, and includes persons with expertise in trauma, including trauma from sexual violence. When providing testimony victims may also have support from family members, psychologists or legal representatives. These specialists are also able to advise prosecutors on appropriate security arrangements for victims and the court must take measures to protect the safety, physical and psychological well-being, dignity and privacy of victims. The statute allows for identities not to be made public, testimony to be provided by electronic means and the hearing to be confidential. The statute also calls for the court to establish principles relating to "reparations to victims, including restitution, compensation and rehabilitation" and to establish a trust fund which "works for victims by mobilizing people, funding opportunities for the benefit of victims and implementing court-ordered reparations awards."

In late 1980s, first tangible developments in regard to victim support services took place upon initiative of civil society organisations working on issues of gender-based violence and violence against children, particularly in family environment. The work of these NGOs was instrumental in adding the victims' perspective to the public agenda and, generally, the provision of victim support services in Slovenia is still heavily oriented towards victims of family (i.e. domestic)violence. These organisations were started as projects of volunteers, but, In the last decades, these organisations mainly underwent a process of professionalisation and their projects are recognised and funded as public social welfare programmes. However, they are still highly dependent upon volunteers. Indeed, the Ministry of Labour, Family, Social Affairs and Equal Opportunities, which co-funds these initiatives through public calls, encourages the inclusion of volunteers and awards additional points, in public calls, to organisations which continuously employs services of volunteers. 153 In 2011, the ministry cofunded 22 programmes of maternity homes, shelters and safe houses with 110 employees and 175 volunteers who contributed a total of 28.181 hours of voluntary work, of whom one-third performed professional tasks in the field of social care. The ministry further co-financed 15 programmes of psychosocial assistance to victims of violence with a total of 37 staff and 149 volunteers who provided 11,641 hours of voluntary work, of whom 40% performed professional work in the field of social protection. 154 In 2012, for example, the telephone helpline aimed at children and women who have been victims of violence had two employed persons and 53 volunteers who provided 3,583 hours of counselling voluntary work. 155

In the 1960s, when Slovenia was still a part of the former Yugoslavia, the first social work centres were established. The role of these public institutions was to address social hardships faced by individuals including those facing victimisation. At the time, these centres were not properly sensitised and failed to develop methods to effectively deal with victims of family violence, or children who were subjected to sexual abuse. Today, there are 62 social work centres throughout Slovenia, ensuring good geographical coverage. Social work centres are public social care institutions providing services such as first social assistance, personal assistance, and assistance for families. The centres also run intervention services which intervene in urgent and immediate cases offering first social assistance and immediate accommodation of victims in crisis centres. There are fourteen such intervention services spread evenly across all regions. Some centres also run youth crisis centres, crisis centres for women and children, victims of violence, and safe houses. The same as the NGOs, social work centres are oriented towards servicing children and adult victims of family (i.e. domestic violence). In time, it was observed that that additional institutional support to address the needs of victims was required and, in 2008, the first comprehensive victim-related piece of legislation was adopted. The legislation governs the prevention of family violence and, generally, grants the social work centres coordinating role when dealing with cases of family violence.

In Slovenia, neither attempts to set up generic victim support services nor debates on the need to establish such services could be identified in Slovenia. The current victim support system, composed of services offered by social work centres and NGOs, is heavily oriented towards provision of support to victims of family (i.e. domestic) violence, which, generally, disproportionately affects women and children. This reflects the voice of a strong civil society movement from 1980s, of which an important part was the feminist movement. Indeed, in late 1980s, first tangible developments in regard to victim support services took place upon initiative of civil society organisations working on issues of gender-based violence and violence against children, particularly in domestic environment. In 1989, feminist activists set up a telephone help line for women and children, victims of violence and in 1990s several other victim support NGOs were established. The work of these NGOs was instrumental in adding the victims' perspective to the public agenda. They also played a significant role in the development of legislation. Today, many of their projects are recognised and funded by the state as public social welfare programmes (e.g. psychosocial assistance to victims, crisis centres, safe houses). In addition to this, social work centres set up a network of intervention centres and also operates crisis centres and safe houses. The last decade also saw establishment of organisations specialised, for example, for support of victims of THB and road traffic accidents.
