Decision of the Director in respect of the establishment of the Selection Committee for the post of Information and Communication Officer, advertised through an external selection procedure, ref. no FRA-TA-COMOFF-AD5-2022, and an internal mobility recruitment procedure, ref. no FRA-TA-COMOFF-AD5-AD6-2022

HAVING REGARD: to the Council Regulation (EC) No 168/2007 of 15 February 2007 establishing a European Union Agency for Fundamental Rights (hereafter FRA), and in particular Article 15 according to which all staff matters fall into the responsibility of the Director;

HAVING REGARD: to the Executive Board's decisions 2015/01 on General Implementing Provisions on the procedure governing the engagement and use of temporary staff under Article 2(f) of the Conditions of Employment of Other Servants of the European Union (CEOS).

HAS DECIDED:

Article 1 - Nomination of Selection Committee

- A selection Committee is appointed with the purpose of determining which candidates fulfil the requirements detailed in the Job Profile of the vacancy Information and Communication Officer, advertised through an external selection procedure, ref. no FRA-TA-COMOFF-AD5-2022, and an internal mobility recruitment procedure, ref. no FRA-TA-COMOFF-AD5-AD6-2022, creating a shortlist of candidates to be invited for an interview, deciding on the suitability of candidates for the post, and making relevant recommendations to the Director.
