# 1. Slovenia

The country overview provides a descriptive analysis of the available official and unofficial data. 'Official data' refers to those collected by law enforcement agencies, authorities that are part of criminal justice systems and relevant state ministries. 'Unofficial data' refers to those collected by civil society organisations, including Jewish community organisations. All data presented are based on the countries and organisations' own definitions and categorisations of antisemitism. Some of these draw on the IHRA Working definition of antisemitism, which was endorsed by all EU member states, except Malta. Albania, North Macedonia and Serbia also adopted the IHRA Working definition on antisemitism. <sup>(i)</sup> Where available, the country overview provides a breakdown of the data by month following 7 October 2023, showing stark increases in recorded antisemitic incidents following the Hamas attacks and the ensuing military intervention in Gaza.

This publication is part of a larger series of overviews of antisemitic incidents. FRA and its predecessor (the EU Monitoring Centre on Racism and Xenophobia) have monitored antisemitism since 2004.

## 1.1. Official data

The Government of the Republic of Slovenia adopted the Strategy of the Republic of Slovenia on Combating Antisemitism until 2033 at its 85th regular session on 21 December 2023. During the aforementioned year, the Slovenian police investigated three criminal offences of Public Incitement to Hatred, Violence or Intolerance under Article 297 of the Criminal Code (hereafter: Article 297 of the KZ-1) relating to antisemitism (two online).

Two offences were investigated by the police before the Hamas attacks on Israel (one offence occurred between 1 January 2023 and 8 February 2023, and another on 25 August 2023), while one offence was committed after the Hamas attack on Israel (between 15 and 16 November 2023).

In 2024, one criminal offence of Public Incitement to Hatred, Violence or Intolerance under Article 297 of KZ-1 related to antisemitism, that took place online, was dealt with.
