### 1. Impact of the cost-of-living crisis and rising poverty in the EU

## 1.1. Legal measures impacting on vulnerabilities of persons affected by the rising costs of living and energy.

Several legal measures have been introduced aimed at reducing the pressure caused by rising energy prices:

Firstly, the Law on Measures to Reduce the Extraordinary Increase in Energy Resource Prices came into effect on 29 January 2022. The law provides for termed support measures that reduce the negative impact on households and the national economy caused by the extraordinary increase in the prices of energy resources<sup>1</sup>. The support is applicable to households which use electricity, natural gas, wood briquettes, wood pellets or firewood, or the centralized heating service for heating. The support offered varies depending on the source of energy used in the household and has been provided for purchases that were made between 1 May 2022 and 30 April 2023. In addition to compensation for heating costs, all households have been compensated for the increase in the price of electricity for the first 100 kWh each month by applying a fixed fee of 160 EUR/MWh, with the state compensating the remaining difference from the market price.

Secondly, on 20 September 2022, the Government of the Republic of Latvia approved amendments to the Cabinet of Ministers' Regulations of 28 September 2010, No. 906 "Rules for Sanitary Maintenance of a Residential House", temporarily allowing the lowering or reduction in the hot water temperature for the 2022/2023 heating season, creating considerable savings in the long term.<sup>2</sup>

Thirdly, the Government of the Republic of Latvia also approved amendments to the Cabinet of Ministers' Regulations of 28 September 2010, No, 907 "Rules on Inspection, Maintenance and Regular Repairs of a Residential Building" on 20 September 2022, stating that during the period from 1 October 2022 to 30 April 2023, a manager of a residential building must provide appropriate heating system settings so that the air temperature in apartments does not exceed +19 °C, and cannot be lower than +18 °C in the room with the lowest air temperature.<sup>3</sup>

Fourthly, with respect to support for entrepreneurs, legal entities were fully compensated from 1 October 2022 to 30 April 2023 for the electricity system service fee, i.e. the distribution and transmission tariff costs for all system operators. In addition, support measures for energy-intensive manufacturing companies were provided in the form of a grant (donation) from 1 February 2022 until 31 December 2022. Grant support to compensate for the price increase of natural gas and electricity resources for an enterprise was set at up to 30% of the attributable costs for natural gas or electricity, but not exceeding 2 million euros in total for one enterprise. In total, 50,000,000 EUR were allocated for these support measures from the state budget.<sup>4</sup>

Fifthly, on 22 August 2023, the Government of the Republic of Latvia approved amendments to the Regulations of the Trade Service of the Protected User. A payment reduction of up to EUR 25 will be applied to all groups of protected users (in total, more than 160,000 people, including poor or low-income households, families caring for a child with a disability, families with many children or persons with severe disability)<sup>5</sup> from 1 August 2023 to 31 December 2023.<sup>6</sup>

Finally, as regards the heating season 2023/2024, the Ministry of Climate and Energy of the Republic of Latvia developed the Law on Energy Supply Cost Support which entered into force on 8 December 2023. The support will be provided for compensating the costs of energy resources for households with a low and medium-low income level in situations where the prices of energy resources are extremely high. Support will be determined in a targeted manner - for specific groups of households with a low and medium-low income level, that is, households whose monthly expenses per member for housing could make up 30% of the household's income. The support is not planned to be applied permanently - throughout the heating season, but to be granted in situations where an extraordinary increase in the price of energy resources is detected in the market (stock exchange). 8

In addition, on 23 November 2023, the Parliament adopted amendments to three different laws related to the energy sector: Electricity Market Law, Energy Law, and Law "On Public Service Regulators". According to the amendments, the Parliament has approved medium and long-term solutions for limiting the rapid increase in electricity distribution tariffs for the following years. This is aimed to ensure a more sustainable approach and predictability of changes for the population in the future. The changes in the laws entered into force on 1 January 2024.

## 1.2. Policy measures impacting on vulnerabilities of persons affected by the rising costs of living and energy.

There are three public authorities sharing responsibility for policy development that impacts on the vulnerability of persons affected by rising living costs:

- 1. the Ministry of Economics of the Republic of Latvia;
- 2. the Ministry of Climate and Energy of the Republic of Latvia;

### 3. the Ministry of Welfare of the Republic of Latvia.

In 2022, Latvia faced a rapid increase in inflation. The government implemented various support measures to reduce energy resource price growth (discussed in the previous section) so as to decrease consumer price growth. The Ministry of Finance of the Republic of Latvia assessed that these support measures may have caused the slowdown in consumer price growth. <sup>10</sup> Despite the fact that the inflation rate is continuing to decrease in 2023, it can be argued that relatively high prices for utilities, food, electricity and heat, as well as water supply, will place significant pressure on household spending, especially on low income households. <sup>11</sup>

The Central Bank of Latvia has claimed that the decrease in the inflation forecast for 2023 was mainly determined by lower energy and food prices and assumptions about the development of these prices in the coming years. The inflation forecast for 2023 has been lowered to 10.0% (-0.9 percentage points compared to the forecast provided in December 2022), for 2024, to 2.7% (-1.7 percentage points), and for 2025, to 2.6% (-0.4 percent points). <sup>12</sup>

As regards the assessment on the actual impact and effectivity of the measures taken to address the rising costs of living and evergy, the inflation in Latvia decreased to 1.0% in annual terms in November 2023, which was the lowest increase in consumer prices in more than two and a half years. Inflation in the second half of this year decreased a little faster than expected, and therefore the average increase in consumer prices in 2023 will be 9.0 - 9.1%.

### Policy measures addressing rising living and energy costs

In 2023, a total of more than 820 million euros has been planned to be diverted from state budget support instruments to various support programs. <sup>14</sup> As summarized in the "Measures to Tackle Energy Poverty and Rising Energy Prices: Latvia" <sup>15</sup> report provided for the European Commission, government support measures to specifically combat energy poverty by directly improving the affordability of energy, can be classified into two main categories:

- 1. Specific income support measures to help people cope with high energy prices (e.g. heating allowances):
  - 1.1 State allowance for the compensation of energy costs;
  - 1.2 Protected user support;
  - 1.3 Support for households using electricity for heating;
  - 1.4 Support for households using pellets and briquettes for heating;
  - 1.5 Support for households using firewood for heating;
  - 1.6 Support for households using propane-butane gas or fuel diesel for heating;
  - 1.7 Support for the compensation of central heating service costs.
- 2. Caps on energy prices or reduction in energy tariffs:
  - 2.1. Support to compensate for the increase in the price of electricity;
  - 2.2. Support for households using natural gas for heating.

Four main measures can be highlighted with regard to government support measures to cushion the impact of high inflation in general (and indirectly combat energy poverty),:

An increase in the statutory minimum wage was provided from 1 January 2023 (from 500 EUR to 620 EUR). Reacting to rising costs of living, on 14 November 2023, the Government adopted the changes in the national minimum monthly wage, namely, as

of 1 January 2024, the national minimum monthly wage is increased from 620 euros to 700 euros. 162. The indexation of pensions.

Taking the significant rate of inflation into consideration, starting from 1 October 2023, an index of 1.0640 is being applied to all state pensions - retirement, disability, survivor's pensions and benefits. In 2023, the size of pensions and compensation or part thereof, not exceeding 609 euros, will be revised, i.e. 50% of the average insurance contribution salary within the country for the previous calendar year. This means that the entire pension amount and remuneration will be indexed if it does not exceed 609 euros. On the other hand, a part of the allocated amount will be indexed - the already mentioned 609 euros for those pensions and benefits that are greater than 609 euros. The increase will depend on both the amount of pension and compensation, and the applicable index. Exceptions are: the politically repressed, people with group I disabilities and participants in the cleanup of the consequences of the Chernobyl nuclear power plant accident, for whom the entire amount of the pension will be indexed.<sup>17</sup>

- 3. The housing benefit calculation from 1 October 2022 to 31 May 2023. 18
- 4. In 2024, mortgage borrowers are compensated for the total interest payment of 30% of the loans.

On 6 December 2023, the Parliament approved amendments in the Law on Consumer Rights Protection stating that compensation of interest payments will apply to mortgage loans for which the contract was concluded until 31 October 2023 and the balance of which does not exceed 250 thousand euros.<sup>19</sup>

### Support measures for vulnerable groups of persons

From 1 July 2023, support for orphans, and children left without parental care after reaching the age of maturity, has been increased. The size of the benefits is now tied to the median minimum income and will be reviewed annually. This was foreseen by the amendments to the Cabinet of Ministers' Regulations No. 857 "Regulations on Social Guarantees for Orphans and Children left Without Parental Care who are in Out-of-home Care, as well as after the End of Out-of-family Care" of November 15, 2005, which were adopted by the government on 27 June 2023.<sup>20</sup>

In addition, social benefits were granted automatically from 1 November 2022 to 31 May 2023 to various low-income groups, the amount of which depended on their income. <sup>21</sup> From 1 October 2022 to 30 April 2023, people with low income were able to receive housing benefits by applying to local governments. <sup>22</sup>

From 1 January 2024, the amounts of the minimum income thresholds are increased. They apply to recipients of state social security benefits, recipients of minimum age, disability and survivor's pensions, recipients of social assistance in the municipality, as well as orphans and children left without parental care who have reached the age of majority. As the Ministry of Welfare of the Republic of Latvia and the European Commission jointly implement the reform of the minimum income thresholds included in the European Union's Recovery and Resilience Mechanism plan, which determines the commitment to promote the reduction of income inequality, 100,000 residents will feel a positive impact.<sup>23</sup>

Also, from 1 January 2024, the amount of care allowance will be increased by 100 euros to 413.43 euros per month for people with disabilities who are over 18 years of age and

whose disability is caused by an illness from childhood.<sup>24</sup> In addition, from 1 January 2024, the supplement to the family state allowance for a child with a disability will be increased from 106.72 euros to 160 euros per month.<sup>25</sup>

### Projects and funds available for energy efficiency

Several initiatives may be listed with regard to available funds and projects related to optimising energy costs:

- 1. Latvia has outlined significant funds for achieving climate goals (676.2 million euros or 37% of all RRF funding) within the Recovery and Resilience Facility (RRF). Significant investments are planned in the field of energy efficiency - in the insulation of multi-apartment buildings and increasing energy efficiency throughout Latvia. Investments in electricity networks and infrastructure are also planned, which will potentially reduce the price of electricity for consumers by 3-5%. In addition, significant investments are planned for increasing the energy efficiency of companies. Entrepreneurs will be given the opportunity to create energy efficiency projects for business infrastructure with the help of financial instruments.<sup>26</sup> Unfortunately, the implementation of projects has been delayed due to the development of national regulations. In 2023, several calls were announced regarding the improvement of municipal buildings and infrastructure, promoting transition to the use of renewable energy technology and improving energy efficiency, and the purchase of zero-emission vehicles necessary for the implementation of municipal functions and the provision of services.27
- 2. The Central Finance and Contracts Agency (*Centrālā finanšu un līgumu aģentūra*) announced an open selection of projects with the support of European Union

funds, for the installation of centralized heating connections in residential houses up until the 25 July 2023. Three million euros of funding from the European Regional Development Fund (ERDF) were allocated in the first call for the selection of objectives.<sup>28</sup>

3. In addition, the Central Finance and Contracts Agency announced an open selection of projects in which 3.5 million euros of ERDF funds were earmarked until 25 September 2023, for the improvement of household heating systems.<sup>29</sup>

In 2023, several large-scale infrastructure projects were carried out aimed at the improvement of energy efficiency. For example, a new boiler house was opened in Jūrmala on 3 March 2023, where thermal energy is being produced using a local energy resource - wood chips,<sup>30</sup> and the improvement of energy efficiency in educational institutions in municipalities<sup>31</sup>.

At the moment, the television channel has appealed the decision to the administrative court. From the publicly available case-law database, it is possible to identify (even though the name of the company is anonymised) that the decision No. 436/1-2 of the NEMMC has been upheld by the first instance court.<sup>37</sup> The judgment is appealed and is under the review of the Administrative Regional Court.

Secondly, on 18 May 2023, the NEMMC decided to punish the independent internet news portal "TVNET GRUPA" with a EUR 8500 financial penalty.<sup>38</sup> As explained in the 29-page long decision, it was due to several reasons, including insufficient accuracy and neutrality.<sup>39</sup> As reasoned in the NEMMC decision, the problematic of the violation is related to the fact that the hosts – journalists – were not diligent enough and did not explain to the auditoria the wrong usage of the term "deportation" by their guest.<sup>40</sup> The term "deportation" is very painful to Latvian society due to Soviet repressions against Latvians.<sup>41</sup>

Latvian Media Ethics Council immediately objected the decision of the NEMMC stating that the punishment imposed on TVNET is disproportionate and not democratic.<sup>42</sup> Even the new President of the Republic of Latvia who is active on his X (Twitter) account objected the decision of the NEMMC stating

On 16 April 2023, Latvian society was shocked by the murder of a woman committed by her former spouse in front of their child in the city of Jēkabpils. <sup>47</sup>

Fierce public debate started after more information was revealed: the police, prosecuting and judicial authorities were aware of the situation of the woman – the woman reported to the police several times that she was stalked, harassed, and threatened by her former spouse for a long time. There were also reports from her relatives, friends, and colleagues to the competent authorities. Several administrative offence proceedings and criminal proceedings were initiated against the former spouse, but nothing, in fact, prevented him from the murder.<sup>48</sup>

Disproportionate use of law enforcement measures (surveillance, police violence, unlawful arrest etc.)

This tragedy triggered fierce public debate (articles in journals, TV discussions, interviews with politicians etc.) about domestic violence and the inability of law enforcement institutions to identify and handle these types of crimes. Initially, law enforcement institutions started to blame each other. However, the politicians and highest authorities, including the Council of Justice<sup>49</sup> admitted systemic problems in the protection of victims of such crimes and undertook collective responsibility.<sup>50</sup>

The President of the Republic of Latvia sent to the Prime Minister a letter requesting to pay a just compensation of EUR 50 000 to the minor child of the victim for the inability of the state to protect the mother's life.<sup>51</sup>

Even though there is the necessary legislation in place, this particular case highlighted the more substantive problem in law enforcement – the negligence in the field of law enforcement.

Although this case does not concern excessive use of force or special equipment, it still is connected with policing and the safety of democratic society. It illustrates how inactivity of the police can make the society to feel threatened. The debate this horrible murder caused, on the other side, showed that this is a topic that the society cares for.

## 2.2. Legislative and policy measures having an impact on the freedom of assembly/association/expression of civil society actors.

As for the freedom of expression and access to information, it must be stressed that these freedoms in Latvia are constitutionally and legislatively safeguarded (Article 100 of the Constitution (*Latvijas Republikas Satversme*)<sup>56</sup>). Access to information is guaranteed by the Freedom of Information Law.<sup>57</sup> In April 2023, the parliament amended some provisions of the Freedom of Information Law that raised objections from NGOs and the Ombudsman. Namely, the Freedom of Information Law qualifies different categories of information that shall be considered as "restricted access information" (that, however, is still available to the public if there is a good reason). However, the parliament decided that one of the categories named "Information for Official Use Only" ("informācija dienesta vajadzībām") must be requalified as a "state secret." Thus, the "information for official use only" that used to be only "restricted access information" in the future will be a "state secret" and thus less accessible to the public.

These amendments were objected to by the Latvian Association of Journalists which insisted that the legislative process should be slowed down and such important amendments should be discussed more extensively. <sup>58</sup> Also, the Ombudsman stated that the amendments were adopted too speedy and without sufficient consultations with NGOs. <sup>59</sup> However, it should be noted that according to Article 18 of the State Secret Law <sup>60</sup> administrative courts have the competence to review these types of cases (refusal to issue the Information for Official Use Only) and, moreover, are competent to verify if the qualification of the information as "Information for Official Use Only" is justified.

Thus, the current legislation provides balancing measures and safeguards for the freedom of expression.

As mentioned in Chapter 2.1., in 2023 the parliament of Latvia adopted a new Law on the Municipalities, <sup>61</sup> inter alia seeking to facilitate the participation of civil society in local decision-making processes (see above). However, the Riga City Council (the capital city and the biggest city of Latvia) increased considerably the minimum threshold for initiating public consultations, <sup>62</sup> thus making initiation of public consultations less available for civil society. This was objected to by the NGO (Transparency International LATVIA) which considered the high minimum threshold provided by the Riga City Council as disproportionate, unreasonable, and contradictory to the new Law on Municipalities. <sup>63</sup>

In 2023, there were no amendments to the Law on Meetings, Processions, and Pickets.<sup>64</sup> Thus, the existing laws in relation to the freedom of assembly are stable and have not been amended.
