1 Regulatory environment for the work of non-governmental organisations

It has been reported that, up to 2012, 73.3 % of nongovernmental organisations (NGOs) in Ireland are registered as having charitable status and governed by the Charities Act 2009. ⁴ Little information is available on the precise configuration of the remaining 26.7 %, although at the time of

as Civil Rights and Advocacy. Information on the number of these groups with charitable or non-charitable status is unavailable.⁵

NGOs, voluntary or community organisations who do not have charitable status are not subject to regulation under the Charities Act. However, they are also precluded from applying for charitable tax exemption on funds received. According to Revenue, the absence of profit motivation does not automatically make a charity entitled to charitable tax exemption. Organisations whose state purpose is as a not-forprofit will be governed under legislation governing the actions of incorporated or unincorporated bodies.

Under Irish law, an organisation that operates a registered charity must be constituted and operated exclusively for charitable purposes. In addition, it is a basic principle of charity law that an organisation's objectives must be expressed in precise rather than broad or vague terms. This identifies as clearly as possible a recognised charitable purpose.⁶ Organisations not registered for charitable purposes are not so constrained.

Specific tax exemptions available

The Charities Regulatory
Authority was created to secure
compliance by charities with their
legal obligations and also to
encourage better administration
of charities. It is considered best
practice for charities to abide by
the provisions of the act.

Part 4 gives investigative and protective powers to the Charities Regulator. This includes the capability to impose sanctions if a charity breaches certain obligations such as the requirement to keep proper accounts or to submit its annual

		Negative outcomes:
		It has been noted that the advancement or promotion of human rights is not listed as a 'charitable purpose' for the purposes of the act. In December 2015, following a review of the operation of the act, an Oireachtas (parliamentary) Sub Committee recommended that the act be amended to include "the advancement of human rights" in its list of charitable purposes as noted in Section 3 of the Act. The act has yet to be amended.
2. Registration imposes a light administrative burden. However, the legislation enables NGOs and other stakeholders to register and record lobbying activity in a transparent manner, accessible to the public. The purpose of the act is to provide for a publicly accessible webbased register of lobbying to make information available to the public on the identity of those communicating with designated public officials on specific policy, legislative matters or prospective decisions. The act also specifically provides for: the Standards in Public Office Commission (SIPOC) to be the

It is estimated that almost three quarters of charities in Ireland are companies limited by guarantee, without a share capital (CLGs). Most of the remainder of charities are established as charitable trusts or unincorporated associations and the 2014 Act does not apply to such companies. The act provides for the following changes to the operation of CLGs: • Compliance statement − where both the balance sheet is greater than € 12.5 million and turnover is greater than € 25 million, a CLGs will be required to include a compliance statement in the company's report of directors (part of the CLG's financial statements) confirming that the directors have: (1) Drawn up a compliance policy

- Number of members of CLG reduction in the number of required members of a CLG from seven to one.
- Name of CLG a CLG will be required to end its name with 'Company Limited by Guarantee' or 'CLG'.
- Articles of Association table C (which currently sets out model articles for a CLG) will no longer exist. Instead, certain default provisions under the 2014 Act will apply to the internal administration of a CLG, save to the extent that a company's articles of association provide otherwise. Existing memorandum and articles of association will continue to apply. However, certain provisions will be deemed to be 'struck-out' by virtue of having been superseded by the 2014 Act. It is considered that interpreting this document could prove cumbersome.
- Audit Exemption CLGs will be entitled to avail of an audit exemption under the 2014 Act if they fall within the group company or small company exemption, although one

member can object and insist that statutory auditors are appointed. The availability of this audit exemption to CLGs will not change the condition imposed by the Revenue Commissioners (re CHY charities) that the accounts must be audited where the annual income exceeds € 100,000.

 Fiduciary Duties of Directors – the 2014 Act, codifies for the first time in Irish law the fiduciary duties of directors of an Irish company (section 228).

2 EU Member State government funding for nongovernmental organisations – trends and developments 2011-2016

2.1 Overall amount of government funding

Figures relating to overall funding from government sources of NGOs, or community and voluntary organisations are not readily available. According to information published, funding for community and voluntary organisations fell significantly in the period 2008–2014, down 41 %. It was noted that in the same period, government spending fell by 7.1 %, the benchmark figure against which all other programmes may be measured. During this time, voluntary social housing fell 50 %, local community development 43 %, youth organisations 44 %, sports grants 60 %, drugs prevention 37 %, the Family Support Agency 32 %, rural disadvantage 100 %, urban disadvantage (RAPID) 80 %, probation services (mainly delivered by voluntary and community groups) 35 % and funding of migrant organisations 65 %. It was also noted that the process of reducing the voluntary and community sector was gradual. Front line services were reduced with interns or job activation staff often taking their place.

Temporary contract staff were not renewed, salaries were frozen or reduced. Charges were made for services, while staff and volunteers were redeployed to fundraising to take more money out of ever more financially-depleted communities. In his report, the estimated total employment in the voluntary and community sector in Ireland will have fallen from 53,000 at the benchmark year of austerity, 2008, to 36,000 by the end of 2015, down about 31 %.

The period 2011 to 2016 was a very challenging one for the public finances in Ireland. It is estimated by the Wheel (an umbrella organisation for charities in Ireland) that 60 % of the funding for the Irish community and voluntary sector comes from the public purse. During the period, many organisations in receipt of statutory funding saw their allocations cut, with many organisations reporting budget reductions of between 10 % and 20 % over the period. There were however organisations that saw their funding remain largely unchanged, while in still other cases entire programmes were terminated (such as the Community Development Programme). So, the situation is very mixed. In recent years, public funding has stabilised with budgets generally beginning to see small rises in certain sectors.

2.2 Distribution of government funding

It is difficult to reach conclusions about the distribution of funding between these headings, as the state generally does not provide funding for anything other than service provision. The SSNO or Scheme to Support National Organisations (see below), has been maintained year on year and this has been a very welcome development to the sector as it is one of the few schemes that supports advocacy activity by charities. There is some evidence that increasing use is being made of binding service level agreements by state agencies which specifically preclude the use of state funds for advocacy purposes, and this is a trend that will need to be monitored to ensure the continuing ability of civil society organisations and NGOs to advocate as appropriate.

Scheme to Support National Organisations in the Community and Voluntary Sector

On 13 June 2016, the Minister for the Environment, Community and Local Government, announced funding of \in 16.409 million over the coming three years to 70 national community and voluntary organisations (a full list of recipients is available on the website). ¹¹ Funding to national community and voluntary organisations under this scheme is to cover core costs such

as staff, administration and ongoing running expenses. The organisations included operate in the health, disability, homelessness, children and young persons, older persons, equality and social inclusion sectors, amongst others.

2.3 Restrictions (or other changes) on NGO funding from other sources

As noted above, the period 2011 to 2016 was a challenge for public finances – it was also a challenge for fundraising from the public, which many organisations report dropped significantly over the period. Additionally, there have been two significant negative developments in Ireland: The Atlantic Philanthropies¹² and The One Foundation¹³ – two very large private philanthropic donors – have ceased grant-making activities (they were fixed time frame funds) and this has had a big impact on the non-statutory funds that are now available to the sector. There have been a number of scandals relating to poor governance practice in certain charities that have dented public confidence in the NGO sector and resulted in a negative impact on donations from the public. All in all, the NGO sector faces a very challenging time on the funding front in the five-year period ahead.

3 Access to the decision-making process for nongovernmental organisations working on fundamental rights

chairman. It was established to consider and make recommendations on nine separate topics relating to Irish constitutional reform. During deliberations, NGOs were invited to make submissions and, in some cases, appear at the convention to brief members on issues under consideration. The outcome of the deliberations led to the holding of two constitutional referenda in May 2015 – Provision for Marriage Equality for Same Sex Couples (passed) and Lowering the Age Limit for Presidential Candidates (defeated). To facilitate the inclusion of civil society, three public meetings of a network of civil society and other interests were held during the summer of 2013.

In November 2016, a second draft National Action Plan was published by the Department of Public Expenditure and Reform. The plan was drafted following a call for public engagement through a series of public consultation measures between August and September 2016. These measures included specifically,

1 Initial Consultation

A national communication campaign, which included two Facebook campaigns, one targeting young people aged between 18 and 25 years and another targeting citizens around the country with an interest in politics and community. Other interested parties were contacted by email and telephone. Additional methods used to promote and raise awareness of the

consultation included a dedicated web page as well as press and radio advertisements. A phone line was available for citizens to ask questions and to make submissions.

2 Online Portal.

An online portal was set up to allow for consultation by written submission. The portal was located at www.ogpireland.ie.

3. Civic Forums

Two civic forums were held in September 2016. To obtain further input and insight from civil society. These were held on Wednesday 14 September 2016 in Kilkenny and on Tuesday 27 September 2016 in Dublin. The forums were attended by 15 and 23 participants respectively.

The government has also committed to establishing an Implementation Review Forum intended to allow people to see how their contributions to the draft plan are reflected in implementing the commitments in this

plan. The first
Implementation
Review Forum is
scheduled to take
place in April 2017.

4 Further information

In 2012, a company that had created a database of information about Irish non-profits closed due to lack of funding. The Irish Non-profits Knowledge Exchange (INKEx) was a repository for regulatory and voluntarily disclosed information, and the only centralised hub for such data of its kind in Ireland. The organisation collected data from NGOs and charities throughout Ireland, publishing its data to improve transparency and disclosure in the sector.

Data collected included information on funding in the sector, including salaries and expenditure. The company also sought to identify trends within the sector. A report using information obtained from INKEx was commissioned by The Wheel, a representative organisation for the charity sector, and published in partnership with Crowe Horwarth, a leading accountancy and advisory firm in Ireland. The report details information and trends spanning 2009–2012.¹⁴

Thanks to the INKEx project we know that in 2009 there were at least 11,700 organisations employing over 100,000 people, involving over 560,000 volunteers in their work, and managing turnover of \mathfrak{C} 5.75 billion. 15
