Part I: National standards

1. Cells

a. Cell space

There are no defined national standards for minimum cell space in m².

The cells of Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*) are compatible with the CPT standards of 6m² for a single occupancy cell. The CPT report on Luxembourg of 2003¹ notes that the single² cell's surface is 12 m², and it includes an intercom, a bed (bunk bed), a table, a W.C., a closet, and two chairs suitable for a maximum of two detainees.

The preventive detention centre (*Centre pénitentiaire d 'Uerschterhaff – CPU*), constructed in 2022, comprises four buildings (100 detainees each). In each of the buildings, there are three types of cells: single cells with a surface of 11 m² (for most of the inmates); 60 double cells with a surface of 16.5 m² and 4 double cells for persons with reduced mobility with a surface of 18.5 m².³ These cells are equipped with a toilet and washbasin, a free television, a kettle, an alarm clock, and a small fridge free of charge.⁴ Showers, an equipped kitchenette, activity rooms, a telephone booth, a laundry room, and offices complement these cell spaces. Each double cell has a partitioned toilet to provide some privacy.⁵

The official presentation video from the Preventive detention centre (*Centre pénitentiaire d 'Uerschterhaff - CPU*) shows an individual cell⁶ of 11 m²⁷ with its facilities.⁸ These standards meet the minimum requirements under the Dorobantu ruling of the EU Court of Justice. The European

Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) (2023) confirmed cell standards and conditions of common space as adequate.⁹

In the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*) there are only individual cells. The cellular space at the facility is between 9.25 m² and 14.5 m².

b. Access to natural light and fresh air, cell equipment, furniture, and facilities

In detention facilities during the night, the cells are equipped with a lighting system (Article 116)¹⁰

In each cell in the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*) there is a large window which can be opened for ventilation¹¹.

Regarding the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*), all the cells have a large window with a ventail for natural ventilation and a curtain, and the bars are arranged horizontally rather than vertically, which is less intrusive.¹² The accommodation units' flat roofs contain an open-air courtyard accessible via a staircase outside the unit. The courtyards, which have a surface area of 150 m², are screened, open to the air, and equipped with a covered area for protection from the weather.¹³ However, the Luxembourgish government has been criticised for poor windows and was recommended to install windscreens during lousy weather.¹⁴

In the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*), a ventilation system is installed for fresh air in cells, and windows can be opened in a tilted position. An air extraction system is installed in most of the rooms.¹⁵

c. Video-surveillance of cells

Under the Act of 20 July 2018, the security of prisons is the responsibility of the director of the centre in question (Article 36).¹⁶ There are specific national provisions on presence/absence of the video-surveillance inside the cells¹⁷ except for two observation cells where there is a permanent video surveillance.¹⁸ These two cells are used for the confinement of inmates in a state of agitation. Video surveillance is located in the hallways of the facilities and their medical units.¹⁹

The Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*) has only 4 cells equipped with permanent video surveillance, mainly for medical purposes (Article 30(c)).²⁰

At the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*), no cells allow permanent video surveillance of the inmate.²¹

menant à cette unité. Il convient de remédier à cette lacune.²⁴

Authorities of the Penitentiary Administration of Luxembourg confirm the fact that video surveillance is not foreseen in the cells. In fact, in the Luxembourg closed detention centre (Centre pénitentiaire de Luxembourg- CPL) only has 6 cells allow permanent video surveillance²⁵, and this is mainly for medical purposes, namely 4 cells in section G1 (infirmary) and 2 cells in section P2 (psychiatry) (Article 30).²⁶

2. Allocation of detainees

a. Geographical allocation

There are no geographical allocation criteria as the Grand Duchy of Luxembourg is a small country (2.586 Km², 80 km long by 35 km wide). The country has three main detention facilities. Each facility accommodates different types of detainees and has a different concept, geographical allocation is not taken into account.

b. Allocation within detention facilities

In Luxembourg, the legal framework defines the allocation of detainees within the detention facilities. Detainees are allocated to establishments and wards according to the prison regime to be applied to them, considering their gender, personality, the reasons for their detention, and, as far as possible, their age and previous record (Article 137).²⁷ Male convicts and minors may be transferred to the Givenich agricultural prison for appropriate penological treatment (Article 18 (2)²⁸ and Article 137 paragraph 2²⁹; Article 674 (2).³⁰ However, such transfer is a discretionary decision, assessed on the basis of legal criteria

such as the offender's personality, behaviour and evolution in the prison environment (Article 673 (2)³¹) and may therefore be reverted (Article 674 (3)³²) (as in the court decision of 2023³³ and 2024).³⁴

Detainees in pre-trial detention are separated from convicted detainees in different detention facilities. The first ones are placed in the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*), and the convicted persons are placed in the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg- CPL*) and Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*). Even before the construction of the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*), the applicable regulations indicated that in the measure of possible, pre-trail detainees must be separated from convicted detainees (Article 10).³⁵

la matière et étendre ce droit à tous les personnes détenues de la prison.³⁶

According to the authorities of the Penitentiary Administration of Luxembourg, convicted persons are often placed far from their families and complain about this. To compensate for this, the persons have access to videoconferencing with their families, and families coming from afar have the possibility of staying for the visit beyond the maximum duration of one visit, which is one hour. National authorities confirm that there is no possibility of geographically distributing detainees to facilitate their reintegration, as there is only one closed penitentiary centre for convicted persons. However, detainees can apply to serve their sentence in another EU member state under EU Framework Decision 2008/909.

The Authorities of the Penitentiary Administration of Luxembourg confirm that since the opening of the Preventive detention centre (Centre pénitentiaire d'Uerschterhaff – CPU) the principle advocated by the European penitentiary rules of separating detainees from convicted individuals is generally respected. However, as a penitentiary centre housing detainees, it happens daily that detainees change from status detainees to convicted individuals. It is specified, however, that in such cases, convicted detainees are transferred to the Luxembourg closed detention centre (Centre pénitentiaire de Luxembourg- CPL), which accommodates, among others, male convicted detainees. This transfer usually takes place within two working days following the judicial decision that has become final. Under Article 113 of the Code of Criminal Procedure³⁸, the accused person may request provisional release.³⁹ The authorities note that throughout this process, the members of the psycho-social-educational service supervise the detainees to facilitate their detention and easier reintegration later on.

3. Hygiene and sanitary conditions

a. Access to toilets

The toilets are located in every cell, so detainees (pre-trial and convicted) have access all day long.

In the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*), each cell (1-2 persons max) is equipped with a toilet and a washbasin; double cells have partitioned toilets.⁴⁰

b. Access to showers and warm and running water

Under the national legislation personal hygiene is required of all inmates (Article 270).⁴¹ The detaining centres have suitable facilities within the assigned time daily (Article 270). Detainees must go to the bath or shower at least once weekly (Article 272).⁴²

The pre-trial detainees have access to showers in each unit of the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*).⁴³ The same happens with the units for the convicted detainees in Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg- CPL*) and the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*).

c. Access to sanitary products

Detainees receive necessary sanitary products free of charge (Article 270).⁴⁴ Detainees may be provided with electric/disposable shavers (free of charge) (Article 271). The detainees can buy other articles from the canteen (Article 253).⁴⁵ Purchases are made once per week.⁴⁶

In the preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*) each detainee receives a hygiene kit (4 rolls of toilet paper, 1 toothbrush, 1 toothpaste, 1 soap, 1 shower gel, 1 razor (if needed), 1 dish soap, 1 sponge, garbage bags) once a month. Additionally, detainees can exchange their towels every week, and bed linens are changed twice a month. Last, pre-trial detainees receive laundry products upon request, as they can access a communal washing machine.⁴⁷

d. Hygienic conditions in cells

The national law states each detainee has an individual bed with the necessary bedding that is changed regularly to guarantee the detainee's health (Article 259).⁴⁸

The doctor of the facility provides a report (every 3 months) regarding the hygiene and cleanliness of the establishment and detained persons; 3) the sanitary installations, heating, lighting and ventilation of the cells and the establishment; 4) the quality and cleanliness of detained persons' clothing and bedding (Article 89).⁴⁹

Authorities of the Penitentiary Administration of Luxembourg confirm that convicted inmates are provided with necessary hygiene products. Sanitary products are distributed once a month, and toilet

*paper once a week. All inmates have access to toilets and showers; each inmate has a toilet in their cell and daily access to a shower.*⁵¹

*Authorities of the Penitentiary Administration of Luxembourg confirm that each cell has an individual toilet at the Semi-open prison in Givenich (Centre pénitentiaire de Givenich - CPG). Regular inspections and adequate maintenance are carried out to prevent health issues. Showers are communal. Inmates have daily access to showers. The showers are well-maintained and clean, and there are enough of them to avoid long waits.*⁵²

4. Nutrition

a. Quality and quantity of food

The detainees receive meals three times a day (breakfast, lunch (12-13h) and dinner (17-19h)⁵³ of sufficient nutritional value to maintain their health and strength (Article 251). Unless under special sanctions, detainees can buy food in the canteen (Article 253).⁵⁴

b. Drinking water

Every detainee has access to water as much as they need (Article 251).⁵⁵

c. Dietary requirements

The director sets the diet's composition under the supervision of the prison health service (Article 251).⁵⁶ Religious regimes are considered as much as possible (Article 251). Sick detainees with a prescription receive special dietary food (Article 252).⁵⁷ Supplement food may be provided to the sick detainees who are required to perform work and to detainees performing heavy work⁵⁸ (Article 252).⁵⁹

Authorities of the Penitentiary Administration of Luxembourg confirm that inmates receive various dietary options. In the Luxembourg closed detention centre (Centre pénitentiaire de Luxembourg - CPL), the following diets are offered: normal, Muslim, fat-free, vegetarian, vegan, low-fat, low-calorie, salt-free, potassium-free, peanut/nut-free, ground, lactose-free, fish-free, gluten-free, diabetic, pregnant, suicidal, hunger-strike, and residue-free. Furthermore, authorities adhere to the national dietary recommendations of the Ministry of Health. The average inmate receives 2,750 kcal/day; the Ministry of Health recommends 2,200-2,800 kcal/day for men and 1,800-2,300 kcal/day for women.⁶⁰

Authorities also note that the Preventive Detention Centre's (Centre pénitentiaire d'Uerschterhaff – CPU) health service is also responsible for food hygiene, thus allowing for control over the quality, quantity, preparation, and distribution of food. With a medical prescription, inmates can follow a different diet provided by the CPU.⁶¹

5. Time spent outside the cell and outdoors

a. Time spent outdoors

In all penitentiary centres, inmates are generally placed in communal life (Article 29 (1).⁶² Except when persons are placed in solitary (confinement) cells (Article 29 (2).⁶³

The detention centre offers an "open door" regime during which detainees can leave their cells and move freely within their unit during the day.⁶⁴ Detainees are allowed to walk in the open air for at least one hour and a half every day (Article 274).

In the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*), the pre-trial detainees have 1 hour 50 min of walking time in the courtyards located on the roofs of the wings of their respective units.⁶⁵

b. Time spent indoors

According to the Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) (2023), in Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*) detainees benefit from an "open door" regime during which they could leave their cell and move freely within their unit during the day. The CPT also noted that the detention regime in Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*) had improved since the transfer of pre-trial detainees to the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*). As a

result, they benefit from increased visiting hours, sports, and activities.⁶⁶ The open-door regime (afternoon until 9 pm)⁶⁷ also applies to the women's ward (Block F).⁶⁸

Detainees may be authorised, while in their cells, to engage individually in activities of their choice as long as they do not trouble order and security (Article 319).⁶⁹

In the Preventive detention centre (*Centre pénitentiaire d 'Uerschterhaff - CPU*), the cells are kept open from 8 a.m. to 9 p.m., during which the detainees may move freely within their living unit, i.e. in the corridor and the two standard rooms, the telephone room, and the shower. The cells are closed only during the distribution of meals and medication.⁷⁰

c. Recreational facilities

The law states that all measures are taken to provide detainees access to culture and other appropriate activities to promote their integration (Article 28 (1)).⁷¹

Detainees may gather in small groups for certain activities or to play games (without "profit" objective) (Article 318)⁷², which includes social games, as well as cards, which could be bought at the kiosk inside

the establishment⁷³. For security reasons, chess is not allowed.⁷⁴ Additionally, sports sessions and competitions may be organised by the detention centre director with the possible assistance of persons or teams from outside (Article 317).

Detainees are allowed to watch TV (they have to pay a caution for the TV set and a monthly fee) and listen to radio programs approved by the director (Article 320).⁷⁵

Each establishment has a library with books, newspapers, and journals⁷⁶ (Article 321 and 324).⁷⁷ Each detainee is entitled to 5 books per week. Detainees may also request books beyond the centre's catalogue (Article 324-325).⁷⁸

According to the legal framework, a portion of the detained individual's daily routine is allocated for physical exercise, overseen by a designated instructor. (Article 28 (1)⁷⁹ (Article 273).⁸⁰

The Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*) has an extensive sports hall and a large central courtyard with a sports field. All are modern and well-equipped.⁸¹ Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg- CPL*) also has an extensive sports hall.

d. Educational activities

To develop socio-educational competencies, detention centres provide various educational sessions, study circles, and other activities by professionals outside the centres (Article 317).⁸² This applies to conferences, film screenings, theatrical performances, and musical concerts.

Detainees who do not speak the languages of the country are provided with language classes (Article 28).⁸³

In the Preventive detention centre (*Centre pénitentiaire d 'Uerschterhaff - CPU*), the defendants attend school (basic instruction course and general secondary education preparation course) for one hour and forty minutes a day, three times a week. The defendants can learn French and Luxembourgish and are sometimes allowed to use the computer.⁸⁴

After release, detainees can acquire or develop the necessary knowledge to better adapt to society. This is why the prison administration promotes the education and vocational training of detainees under the Public Prosecutor Office (Article 313).⁸⁵ Detainees (convicted and minors) can finish primary and secondary education (Article 314).⁸⁶

Regarding vocational training, the detainees have access to all facilities compatible with the discipline and security requirements (Article 313).⁸⁷

Detainees can follow correspondence courses at their expense (Article 316, par. 2).⁸⁸

Women at Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg- CPL*) can learn languages and computer science in a specific classroom. They can pass their baccalaureate, but they do not have access to university courses.⁸⁹

However, the CPT criticises the fact that female detainees placed in solitary confinement had no right to school or activities. They were also denied access to the library or work.⁹⁰ Furthermore, the CPT noted that that went against the law of 2018, which stipulates that solitary confinement must not negatively affect an adapted activities programme.

In the case of minor detainees in Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg—CPL*), they can attend school beginning at 8:30 a.m. for two hours per day in the common room four mornings per week. During these classes, the instructor teaches French, Luxembourgish, German, and English and general notions of mathematics, history, natural sciences, and computers.⁹¹ During the time of school, the minors have internet access.⁹²

In general, the CPT recommends that the Luxembourgish authorities continue their efforts to increase activities for detainees at the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg-CPL*). The aim should be for each detainee to be able to spend a reasonable part of the day, eight hours or more, outside their cell, engaged in motivating activities of a varied nature: work, study, sport, and leisure activities, adapted to the needs of each individual and in particular of women.⁹³

Regarding the daily routine of the convicted persons in the Luxembourg closed detention centre (Centre pénitentiaire de Luxembourg - CPL), the authorities of the Penitentiary Administration of Luxembourg confirm that most inmates work during the day. After work, inmates participate in courtyard walks and sports activities, attend school, or visit other inmates, spending very little time in their cells. If inmates do not work, the cell door opens at midday and closes at 9:00 pm.⁹⁷

6. Solitary confinement

a. Placement in solitary confinement

Detained people may be put into solitary confinement under certain legal conditions. In this context, they are separated from others into their cells, without prejudice to a programme of adapted activities (Article 29(2)).⁹⁸ The following groups may be put into solitary confinement on the basis of an individual decision:

- (a) detainees waiting for trial by decision of the judge (Article 29(2)(a)⁹⁹);
- (b) detained persons who, because of their personality or behaviour, are unfit for community living (Article 29(2)(b)¹⁰⁰ (as in court decision of 27 March 2023,¹⁰¹ as well as 6 September 2023,¹⁰², 5 March 2024¹⁰³), but only for as long as this is the case (Article 29(2)(b)¹⁰⁴ (also court decision of 5 March 2024)¹⁰⁵;
- (c) Minors, as well as pregnant or breastfeeding women and mothers with infants, but only if solitary confinement is manifestly in their interest or if the circumstances described under (b) apply (Article 29(3)).¹⁰⁶

Detained persons whose behaviour is likely to 1) endanger their own or other persons life or physical integrity , 2) seriously and imminently jeopardise the order and security of the prison centre may be temporarily placed:

- (a) in a single cell;
- (b) in a security cell specially equipped to prevent acts of vandalism, aggression, and self-aggression; or
- (c) in an observation cell in which the detained person is under permanent video surveillance. (Art 30(1).¹⁰⁷

The duration of the placement is limited to strictly necessary. It may be at most twenty-four hours unless it is extended by the reasoned decision of the director of the penitentiary centre for periods of twenty-four hours (Article 30 (3).¹⁰⁸

b. Monitoring of detainees

A person may be temporarily placed in an observation cell (*cellule d'observation*) under video surveillance (Article 30(1)(C).¹⁰⁹

The placement in solitary confinement in a punishment cell may only be imposed with the doctor having examined the prisoner and certified in writing that the latter can withstand it (Article 200 par. 1).¹¹⁰

The doctor visits the detainees undergoing this disciplinary measure at least twice a week (Article 201 par. 1).¹¹¹ The punishment is suspended if the doctor finds that its continuation is likely to compromise the physical or mental health of the prisoner (Article 201 par. 2).¹¹²

According to the 2021 Annual Report of the Ombudsman of the Grand Duchy of Luxembourg, 424 persons were placed in solitary confinement during 2021 (this reflected a clear increase of 39,5% compared to 2020). The average time of placement in confinement was 56 hours, with a minimum duration of one hour.¹¹³

The CPT has considered that confinement to an individual cell is the most severe sanction (Article 32 (3) 9)¹¹⁴ and can be imposed for a maximum of 14 days, during which time detainees may continue to enjoy their rights to visit and correspond with others and to go outside (but on their own) (Article 32 (4)).¹¹⁵

Authorities of the Penitentiary Administration of Luxembourg confirm that there are no cases of constant extension of solitary confinement periods in the Luxembourg closed detention centre. They further confirm that solitary confinement is used as a disciplinary sanction for a maximum period of 14 days and as an administrative measure for up to one month. In the latter case, solitary confinement may be extended by a reasoned decision. However, extensions are very rare.¹²¹

Furthermore, authorities emphasise that the well-being of inmates placed under the cellular regime is sufficiently monitored, as the doctor must examine the inmates subjected to the cellular regime without delay and no later than 24 hours after placement, and thereafter at least once a week. Additionally, the doctor must submit a report to the director of the Preventive detention centre (Centre pénitentiaire d'Uerschterhaff - CPU) whenever they believe that the physical or mental health of an inmate has been or will be affected by any aspect of the regime or by the extension of the placement under the cellular regime. Moreover, access to healthcare remains guaranteed during cellular isolation.¹²²

Authorities of the Penitentiary Administration of Luxembourg confirm that in the Semi-open prison in Givenich (Centre pénitentiaire de Givenich - CPG), the practice of isolating inmates in solitary confinement does not exist. However, withdrawal from individual and communal activities can be imposed for disciplinary reasons. After working and training hours, the inmate is confined to their cell (from 4:30 PM to 6:30 AM). The confinement hours for inmates with a semi-liberty work contract are adjusted according to their work entry and exit times.¹²³

7. Work and education of detainees to promote social reintegration

a. General measures to promote social reintegration

According to the Act of 20 July 2018 reforming the prison administration, the prison administration provides psycho-social monitoring and socio-educational supervision for all detainees (Article 21 (1).¹²⁴

The law also states that the psychosocial and socio-educational services shall coordinate the development and implementation of the voluntary integration plan (Article 21 (2).¹²⁵ Each convicted detainee is offered a voluntary integration plan to determine the measures to be taken during detention to promote integration (Article 21 (3).¹²⁶

Thus, detained individuals are actively encouraged to participate in a voluntary reintegration program tailored to their triumphant return to society (Article 27(1).

The voluntary integration plan is drawn up as soon as the sentence is final, with the convicted detainee's participation and coordination with the probation officer of the central social assistance service responsible for the convicted person (Article 21 (4).¹²⁷ The content of the voluntary integration plan may include:

1. programs to develop the offender's employability skills and work attendance.
2. education or training programs.
3. psychosocial follow-up and socio-educational supervision programs.
4. psychotherapeutic or psychological follow-up programs;
5. compensation and reparation for the harm caused to victims.

This voluntary integration plan can also include other aspects (Article 21 (6)¹²⁸ and it shall be periodically reviewed and adapted, depending on the execution of the sentence, the active participation of the convicted person, and his progress (Article 21 (6).¹²⁹ The "Good Life Plan" and the "Voluntary Integration Plan" are the reference tools to guarantee the coherence and continuity of the various services that work with the detainee. The integration advisor in co-production with the prisoner draws them up. When a prisoner is transferred from one penitentiary centre to another, the new professionals consider these working tools, and all the data is collected in the prisoner's social integration file.¹³⁰

In the case of detainees at the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*), the director of the prison may authorise temporary accompanied outings for convicted detainees when it is in the interests of their integration for them to take part in psychological or psychotherapeutic

follow-up measures or educational, socio-pedagogical, sporting or cultural activities, work, training or teaching activities organised outside the prison or to carry out administrative procedures with a view to their release. The prison director determines the duration of the temporary accompanied outing but may not start before 6.00 a.m. and end after 10.00 p.m. (Article 21 (7).¹³¹

Penological treatment consists of individualised work carried out by the Prison Service with the detainee during his stay in prison. This treatment is adapted to the prisoner's needs, resources, and interests. In this sense, it is a differentiated treatment. Each detainee is automatically accompanied by an integration counsellor from the Psychosocial and Socio-Educational Service (SPSE). Depending on their needs and choices, other professionals may also monitor them.¹³²

Penological treatment comprises an "assessment" component and an "intervention" component. The prisoner's participation in the assessments and interventions is voluntary. The assessments provide a multi-dimensional and multi-perspective analysis of the inmate's needs and resources and enable the professional staff and the detainee to work together to set the objectives to be achieved through interventions appropriate to the inmate's situation.¹³³ The interventions offered to detainees increase the opportunities for exchange and reflection with them and develop their responsibility and capacity to act.¹³⁴

According to the legal framework, all the detainees of the different prisons are placed under a regime known as the "common regime," which allows them to live and associate in common and working areas and take part in activities organised by the centre (Article 29 (1).¹³⁵

b. Access to work

Convicted persons in detention are required to perform the work assigned to them. Age, sex, physical and mental capacities, health, and personality are considered when assigning work (Article 27(1).¹³⁶ An unjustified refusal to do the assigned work may result in disciplinary action. Work and other activities offered as part of the voluntary integration plan are reimbursed based on the principle of equivalent pay (Article 28(1).¹³⁷

Work is optional for all other detainees (e.g., provisional detention, etc.) (Article 27(1)).¹³⁸ Pre-trial detainees must apply with a request to the prison's director (Article 288).¹³⁹ The remuneration is fixed by a Grand-Ducal Regulation, which indicates that the salary is fixed by the Minister of Justice (Article 300).¹⁴⁰ The salaries can increase with time.¹⁴¹

c. Access to education

As part of the voluntary reintegration program, detainees are strongly urged to enhance their skill sets. Within the prisons, all measures are taken to provide primary education to the detainees to promote their integration(Article 28 (1)).¹⁴²

Detainees receive access to primary education, engage in physical activities, participate in cultural events, and undertake other relevant activities to facilitate their transition back into the community. (Article 28)¹⁴³

After release, detainees can acquire or develop the necessary knowledge to better adapt to society. The prison administration promotes education and vocational training of detainees (Article 313).¹⁴⁴ Detainees (convicted detainees as well as minors) can finish primary and secondary education (Article 314).¹⁴⁵

In the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*), accompanied detainees can assist in educational, socio-pedagogical, sporting, or cultural activities outside the detention centre leading to their release_(Article 21(7)).¹⁴⁶

Detainees may pursue vocational training and education by distance, provided these do not overlap with their work hours (Article 316).¹⁴⁷

Detainees can follow correspondence courses at their expense (Article 316, par. 2).¹⁴⁸

In the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff – CPU*), education service plays a crucial role in the rehabilitation of the inmates. The training courses are based on two pillars, each designed to provide significant benefits:

- Introductory instruction courses: These are aimed at beginners in French literacy and those who have been literate in German or French and wish to improve their basic skills (reading, writing, arithmetic, and navigating an increasingly digital world).
- Preparatory pathway for general secondary education: This is a modular education system, including courses in Allux (German with Luxembourgish connotations), French, general culture (Geography, Ethics, Computer Science, and Science), and Mathematics. The English language instruction is also planned. The modular education system allows for consideration of the individual's profile and pace. Upon successfully completing a module, the person is granted a report detailing their competencies.¹⁴⁹

8. Healthcare

a. Access to healthcare

Every detained person has the right to an adequate and appropriate right to the health care best suited to their state of health. The prison staff ensures that the health care provided to each detained person is equivalent to that to which they would be entitled in the absence of imprisonment. Medical services are provided by respecting proportionality: what's needed and should be given in the most efficient way

possible, following medical rules and ethics. The prison administration organises access to healthcare and covers the related costs and expenses (Article 26(1)).¹⁵³

b. Availability of medical staff

Medical staff in establishments consist of a general practitioner, a dentist, a doctor specialising in psychiatry or neuropsychiatry, and nurses (Article 28).¹⁵⁴ The general practitioner is responsible for the centre's health service (Article 29).¹⁵⁵

Approved doctors have the authority to request assistance from medical specialists for the examination and treatment of detained persons (Article 31).¹⁵⁶ Each establishment has an infirmary (Article 32), which includes premises for medical consultation and treatment, storage and preparation of medicines, and a diet adapted to the needs of inmates, patients requiring psychiatric treatment, and chronic patients. Additionally, the infirmary must provide facilities for medical consultation and pharmacy (Article 33).¹⁵⁷

Although the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*) does not have an infirmary, nursing care, including consultations, is provided thrice daily for six hours. A general practitioner is usually available for consultations on Wednesday afternoons. Suppose the general practitioner cannot come to the Semi-open prison in Givenich. In that case, the transport service organises transfers to a medical centre in the region every Monday, Friday, and Wednesday. The transport service also takes inmates to appointments with specialist doctors on weekdays. For mental health support, a psychiatrist is available for consultation on Mondays. Additionally, psychiatric nursing staff from the penitentiary psychiatric medical service are present at the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich – CPG*) for two hours each day, ensuring continuous support. The neighbouring municipality has a rescue unit (*Corps grand-ducal d'incendie et de secours*) coordinating ambulance and fire services. In case of emergency, there is direct access to the ambulance.¹⁵⁸

c. Medical examination upon admission

The doctor assigned to the institution checks each person who is detained soon after they arrive (within 24 Hours)¹⁵⁹ and continues to check them regularly as needed. These check-ups are essential for finding any physical or mental health issues, separating those with contagious diseases, identifying any problems that might affect their reclassification, and figuring out what kind of work each person can do (Article 83).¹⁶⁰

d. Preventive care

According to Article 84,¹⁶¹ the doctor in charge is responsible for monitoring the physical and mental health of individuals admitted to the establishment. The doctor should ideally examine those who complain of illness or are reported ill on the same day. The frequency of the doctor's visits depends on the patient's condition and needs.

e. Specialised care

The doctor of each facility must examine each inmate after their admission and as often as necessary thereafter, particularly to detect any physical or mental illnesses and take appropriate measures. This includes ensuring the separation of inmates with contagious diseases, identifying any physical or mental impairments that could hinder reintegration, and determining each inmate's physical capacity for work. Additionally, the doctor is responsible for monitoring the physical and mental health of those admitted to the facility, promptly examining those who report illness and conducting regular check-ups as needed (Article 83-84).

The doctor provides written certificates detailing the health status of examined individuals, including essential information for the inmates' penological treatment, rehabilitation, and re-education when requested by the establishment's management. Without prior authorisation from the general management, the doctor is forbidden from issuing certificates to inmates, their families, or their legal representatives (Article 87).¹⁶²

In the preventive detention centre (*Centre pénitentiaire d'Uerschterhaff – CPU*), the psychiatric care of inmates is provided by the penitentiary psychiatric medical service (SPMP), which is present every day, including holidays, Saturdays, and Sundays, from 6:30 AM to 9:30 PM. Medical on-call duty is also ensured during this time. The penitentiary medical service (SMP) provides somatic care and has a pharmacy. In addition, the SMP offers general medical consultations every weekday for at least 6 hours

per day on the premises and is available for telephone consultations 24/7, ensuring the inmates' health needs are met promptly and effectively. The commitment to comprehensive healthcare is further ensured by providing specialized medical consultations, including dentistry, ophthalmology, infectious disease, and biomedical expertise, ensuring that all aspects of inmate health are addressed. Healthcare staff is also present at the premises 24/7. Additionally, a physiotherapist is present every weekday from 8:00 AM to 5:00 PM. There is also an X-ray service within the CPU.¹⁶³

f. Treatment of the detainee's choosing

A detained person may be treated at the detention centre by the doctor of their choice (26(2). Depending on the seriousness of the situation, the person may be transferred to the hospital by professionals either from the centre or from the hospital (Article 26(3)).¹⁶⁴

According to the authorities of the Penitentiary Administration, proportionality is taken into consideration regarding access to healthcare. Furthermore, a convicted person may request to see a doctor at lunchtime. Every person has a sufficient and appropriate right to the care best suited to their state of health.¹⁶⁷

9. Prevention of violence and ill-treatment

a. Protection from violence by prison staff

Several provisions of the amended Grand-Ducal Regulation of 24 March 1989 and the 2018 law stipulate the duty of the penitentiary staff to abstain from any act that could harm the detainees and the duty to rescue or protect the detainees in case of need (Article 50 and Article 52).¹⁶⁸

In carrying out these duties, prison officers may only use the physical and material means of restraint at their disposal in self-defence, attempted escape, invasion, or attempted invasion to compel a detained person to behave by the law and the instructions of prison staff by inhibiting or restricting his capacity for movement, to overcome the resistance of a detained person by violence or physical inertia to orders

given, or when it is a question of protecting the detained person against themselves. The choice and use of means of restraint must be justified, limited in time, and proportionate to the facts (Article 43 (1).¹⁶⁹

The Director of the Prison Service may decide to set up a task force within each prison. This group consists of prison officers specially trained in the use of physical restraints. Their task is to intervene in incidents or situations that can no longer be carried out by other prison officers who are not members of the group.

b. Protection from violence by other detainees

Prison officers are responsible for

- (a) supervising and supervising detained persons;
- (b) ensuring the smooth running of detention;
- (c) ensuring respect for the physical integrity of detained persons, staff, and third parties present;
- (d) ensuring the security and safety of the prison to which they are assigned (Article 42).¹⁷⁰

The physical means of restraint include:

- a) metal or synthetic handcuffs, shackles, and any other means of restraint;
- b) truncheons and defence batons;
- c) devices acting by the remote projection of natural or synthetic pepper substances designed to have an inhibitive effect on persons;
- d) firearms and non-firearms with non-penetrating ammunition, and
- e) firearms with penetrating ammunition (Article 43(3)).

Prison officers are authorised to use firearms with penetrating ammunition only in legitimate self-defence to prevent escapes and invasions outside the facilities. Their use must be authorised in advance by the director of the penitentiary centre and approved by the director of the penitentiary administration (Article 43(4)).¹⁷¹

According to their procedure, an inmate who claims to have been the victim of violent treatment by a member of staff may complain to management. A thorough investigation is then launched.¹⁷⁶

Authorities of the Preventive Detention Centre (Centre pénitentiaire d'Uerschterhaff – CPU) further specify that when an inmate claims to have been a victim of violence, the staff member who witnessed it or first became aware must prepare an incident report. The same procedure applies if a staff member notices injuries or signs of violence on an inmate or hears about it from others. The inmate is invited to the infirmary for an examination, and the doctor issues a medical certificate documenting the presence or absence of injuries. An internal investigation is opened, and management reports the incident to the State Prosecutor, including all relevant information and documents. Copies of the medical certificate and photos are provided to the inmate or their lawyer upon request.¹⁷⁷

10. Contact with the outside world

a. Visits

The legal framework regulates detainees' visiting rights (Articles 23 and 24¹⁷⁸; Article 228 to 243¹⁷⁹). The detained persons are encouraged to maintain and improve social relations with their close relatives insofar as they appear desirable in the interests of all parties (Article 217).¹⁸⁰

The procedure for obtaining authorisation to visit varies according to the status of the detainee receiving the visit. The visit permits for convicted detainees are granted by the director of the prison where the person in question is placed (Article 23 (1)).¹⁸¹ Visit permits for pre-trial detainees must be authorised by the investigating judge and granted by the prison director (Article 23 (1)).¹⁸²

Pre-trial detainees and minors can receive a visit from any person with a visit permit (Article 228).¹⁸³ Unless otherwise stated, such visit permit is only valid for a half-hour visit on the day indicated on the permit (Article 228).¹⁸⁴

Convicted individuals can receive visits from their parents and direct relatives, their legal guardian, spouse, siblings, uncles, and aunts, upon providing proof of the visitors' identity. Visits from any other individuals require prior authorisation from the director, who informs the social defence service (*service de défense sociale*). The director may issue permits to any person for visits to convicts, even outside the regular visiting days and hours. (Article 229).¹⁸⁵

The visits may be prohibited or restricted by decision of the Director in the interests of good order and the safety of the prison and third parties, or if there is a risk that the convicted person's integration may be compromised (Article 23(4)¹⁸⁶ as well as court decision of 5 April 2024).¹⁸⁷

Furthermore, convicted persons punished by placement in a solitary cell may not receive any visits during the execution of this disciplinary sanction (Article 230).¹⁸⁸

At the semi-open Givenich penitentiary centre (*Centre pénitentiaire de Givenich*), visits are automatically organised in the form of temporary outings from the centre (Article 23(3)).¹⁸⁹

For sick detainees who are not able to move, the visit can exceptionally take place in the infirmary (Article 232).¹⁹⁰

Visits occur in shared visiting rooms, individual visiting rooms or specially adapted individual visiting rooms, depending on the detainee status (Article 232).¹⁹¹ Visits take place in shared visiting rooms in the presence of a warden whose task is to prevent any improper contact between the visitor and the prisoner. If visiting rights are abused, fraud is committed, misconduct occurs, or any other incident occurs during the visit, the warden may terminate the interview, remove the inmate, and expel the visitor (Article 233).¹⁹²

Foreigners can receive the visit of diplomatic representatives of their country of origin without the warden's presence (Article 235).¹⁹³

Judicial authorities, the Ombudsman and Ombudsman for Children and Youth (*Ombudsman fir Kanner a Jugendlecher- Okaju*), Members of Parliament, persons duly delegated by these authorities and institutions, consular and diplomatic agents of other countries, as well as staff of the prison administration and the central social assistance service, shall have free access to prisons and communication with detained persons for the performance of their duties or the accomplishment of their tasks (Article 24(1)).¹⁹⁴

The members of philanthropic or charitable works or associations (e.g. Luxembourg Prison Visitors Association - ALVP)¹⁹⁵) may be authorised by the Public prosecutor to visit convicts freely and in individual visiting rooms. The Director may also grant the same right to visit a convicted person to a

teacher, a private correspondence teaching institution member, or a technical instructor in the interests of the convicted person's vocational training (Article 238).¹⁹⁶

b. Correspondence

Convicted persons (subject to authorisation), as well as pre-trial detainees (*les prévenus*), may correspond in writing with any person of their choice (Article 25(1)).¹⁹⁷ The number of letters each detainee can write is unlimited (Article 220).¹⁹⁸ The detainees may obtain paper for correspondence from the canteen. However, in case a person is unable to obtain their correspondence paper, it is provided to them free of charge (Article 222).¹⁹⁹ Postage fees are the responsibility of the sender (Article 222) In case the detainee cannot read, a member of the centre would assist them write or read their correspondence, upon request (Article 220). All mail may be subject to control, except exchange correspondence the letters between detainees and their lawyers or national or international administrative and judicial authorities. When the prison administration decides to withhold an inmate's mail, it notifies them of the decision (Article 25(1-2)).²⁰⁰

Any money attached to a letter is given to the accountant to be credited to the inmate's account. All the other objects, such as photographs and postage stamps, are placed in the personal file (Article 225).²⁰¹

Convicted detainees and, subject to authorisation by the magistrate, pre-trial detainees may correspond in writing with any person of their choice. Except for correspondence between detainees and their lawyers or national or international administrative and judicial authorities, mail sent or received by detainees may be checked and retained by the prison administration. Mail sent or received by accused persons shall be communicated to the competent investigating judge by the procedures that s/he shall determine. When the prison administration decides to withhold a prisoner's mail, it shall notify the prisoner of its decision (Article 25)²⁰² (Article 218).²⁰³ There is no limitation on the number of letters

that a detainee can write or receive (Article 218 and 220).²⁰⁴ The detainee must buy the paper and the stamps (Article 222).²⁰⁵ In general, the prison staff would open all letters not coming from the investigation judge, ministries, public prosecutor, diplomatic representations, or lawyers (Article 223)²⁰⁶ or national /international administrative judicial authorities (Article 25(1)).²⁰⁷ The same happens with packages. The prison Director or a staff member delegated by them performs control and censure (Article 225).²⁰⁸

The CPT states that pre-trial and convicted detainees can now enjoy visits, as well as videoconferencing with their lawyer. It is also considered positive that visits have been maintained with relatives during periods when detainees were subject to disciplinary sanctions. However, at the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*), videoconference calls were only allowed if the detainee's family lived more than 250km away²⁰⁹ from the prison. This limitation is not justified and should be lifted.

c. Visits with children

Convicted individuals can receive visits from their parents and direct relatives (*leurs parents et alliés en ligne directe*), such as parents, siblings, children, and grandparents, upon providing proof of the visitors' identity (Article 229).²¹⁰

The visits with minors must be accompanied by an adult with parental authority or an adult possessing a power of attorney issued by the child's guardian. The adult must provide a family record book or birth certificate to prove their relationship with the minor. Only a maximum of two visitors per visit, including the minor, are allowed.²¹¹

Authorities of the Penitentiary Administration of Luxembourg facilitate communication with the outside world. Detainees can make contact with the outside world by mail, telephone, and visits. Detained persons are entitled to unsupervised visits at the Luxembourg closed detention centre. Authorities provide necessary facilities and adequate conditions for meeting with visitors. In the Luxembourg closed detention centre, a visiting room is set up for visits with young children, equipped with toys and carpets. Inmates whose families live far away have the right to communicate with their families by videophone.²¹⁴

The general concern is that the Act of 20 July 2018 was published, but the Grand-Ducal Regulation still needs to be approved. So, the Grand-Ducal Regulation of 24 March 1989 continues to apply. In this sense, the Consultative Commission on Human Rights criticises, when commenting on the draft of the new Grand-Ducal Regulation aimed at replacing the Grand-Ducal Regulation of 24 March 1989, that the list of people who may benefit from unsupervised visits seems to be limited to people who may be part of the detainee's family in the broadest sense of the term, and wonders "whether it would not have been possible to also allow them with close friends, as stable relationships are not limited to family and marital relationships".²¹⁵

In addition to the limit on the number of people who can benefit, the duration of unsupervised visits per month is minimal, which is highly regrettable. For example, "the time limit is set at 8 hours per month, at one hour per supervised visit, and slightly more for unsupervised visits and visitors who have to travel a certain number of kilometres (more than 100km). Maintaining this type of restriction can generate a certain degree of isolation among detainees and thus run counter to maintaining family and social ties.²¹⁶ This situation worsens when considering children who need to have a regular link with their parent who is in prison and need to adapt to the environment of the prison. Furthermore, although improvements are underway, the premises for unsupervised visits still need to be adapted to the needs of families and children.

11. Special measures for female detainees

a. General conditions of detention for women and girls

The national law states that the men's section and the women's section are distinctly separate (Article 7).²¹⁷

Moreover, at the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*) only adult women serve their sentences. Therefore, a particular focus is laid to ensure equal treatment between women and men. Women have the same opportunities (workshops, activities, classes, etc.) as men.²¹⁸

b. Separation from men

Women and male detainees are located in different places of detention establishments (Bloc F in Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*) and in a house in a Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*)).²¹⁹

c. Hygiene

No specific provisions are foreseen for women; under the national law, detainees are provided with toiletries for their health and cleanliness free of charge.

d. Healthcare

At the Luxembourg (closed) detention centre (*Centre pénitentiaire de Luxembourg - CPL*), gynecological care is provided at the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg- CPL*). The gynecologist usually comes 4 to 5 times a year, either at the request of the patient, the general practitioner or the infirmary.²²⁰

e. Pregnancy and women with babies or young children

When a doctor confirms a pregnancy, the woman receives a medical certificate with the delivery date (Article 130).²²¹ In case of emergency, the Director orders the detainee's transfer to the nearest

maternity hospital. Consultations and monitoring of pregnancy are conducted in accordance with conditions outside the detention establishment and take place in maternity wards.²²²

In the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*) the women's section is equipped with 2 mother-baby cells²²³.

When a detained woman has given birth in the establishment, the establishment's Director declares the birth to the competent civil status officer. The place of birth is not mentioned in the birth certificate (Article 130).²²⁴

At the Semi-open prison in Givenich (*Centre pénitentiaire de Givenich - CPG*) only small children accompanying their incarcerated mothers are admitted to the CPG. In this case, a baby crib is set up in the mother's room, and the stairs are arranged so that a child cannot fall. If needed, necessary measures are taken to organize appropriate supervision for the mother and her child (monitored by the national child welfare agency, arranging a spot in a daycare to prevent the child's isolation, etc.).²²⁵

*In its opinion of the Grad-Ducal Regulations draft, the Consultative Commission on Human Rights criticised the lack of legislative proposals regarding women in criminal detention facilities. More specifically, the CCHD noted that pregnant women and those with young children should avoid imprisonment whenever possible, with the option of transferring them to the semi-open prison in Givenich if needed. If they must be detained, efforts should be made to ensure appropriate conditions, including medical care, food, delivery conditions, and physical and psychological support for the child's development, especially regarding emotional bonding. Luxembourg legislation should incorporate rules favouring pregnant or breastfeeding women and young children staying with a parent. Additionally, attention should be given to the general situation of women in prisons to prevent discrimination or unequal treatment in activities and freedoms granted.*²²⁸

12. Special measures for foreign nationals

a. General measures for foreign nationals

Detainees of foreign nationality may communicate freely and without the presence of a guard in the individual visiting room during working hours with the diplomatic and consular agents of their country, even though, as a punishment, the prisoner is deprived of the proper visitation unless the ban on communication has been ordered by the investigating judge (Article 235).²²⁹

The CPT stated that foreign nationals represent 75% of the detainees in the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg- CPL*).²³⁰

The usual rules for detainees apply to foreigners detained in Luxembourg (Article 331).²³¹

Regarding diplomatic representatives' visits, the foreigner has the right to receive the visit of their diplomatic or consular representative (even if the detainee is punished), and this visit is done in a separate room without a warden except if the investigation judge forbids it (Article 235 par. 1).²³² The same happens with the correspondence of these diplomatic representatives in which the correspondence cannot be subject to censorship (see above). Also, detainees who are nationals of a State that does not have diplomatic or consular representation in Luxembourg, as well as detainees who are refugees, may be visited by a representative of any other national or international authority whose task it is to protect them (Article 235 par. 2).²³³

Nevertheless, the most important example is the enforcement of sentences and communication (see also interpreting and translation). Convicted foreigners residing illegally in Luxembourg and under a removal order or an entry ban may, under certain circumstances, benefit from early release. The Criminal Procedure Code (Article 686 (1)²³⁴ establishes that non-resident foreign offenders may be released from prison without probation²³⁵ if they already served part of their sentence (Article 686 (1)²³⁶ and are eligible for conditional release. Early release leads to an entry ban (Article 112)²³⁷ to enter Luxembourg territory. If these offenders are found on Luxembourg territory while the ban applies, the remaining sentence will be enforced without further hearings or formalities (Article 686 (2).²³⁸

The General Public Prosecutor's Office determines the conditions for early release, which usually include that offenders must pay the expenses for their trip back to their country of residence, the costs of their trial, and all or a part of the fine. The payment of civil damages may also be required. Furthermore, they can be banned from national territory for up to 10 years.²³⁹ The Probation officer can be requested to submit a report on the offender prior to the release.²⁴⁰

b. Interpretation and translation

Indirectly, the Act 20 July 2018 states that "when the detainee has not mastered basic education, including the languages used in Luxembourg, priority shall be given to learning them, as determined by the voluntary plan." (Article 28 (2).²⁴¹

However, the use of languages in prisons is regulated by the amended Grand-Ducal Regulation of 24 March 1989. This regulation states that "in case of absolute necessity, if the detainee does not speak or understand one of the languages of the country and if there is no one on-site capable of providing a translation, the director may call upon the services of an interpreter." Also, it states that "visits and correspondence with foreign nationals may be conducted in their language" (Article 331).²⁴²

Finally, this regulation states that letters written in a foreign language may be translated for the abovementioned checks (Article 331).²⁴³

The prison administration shall bear the costs of the interpreter and translation (Article 331).²⁴⁴

Authorities of the Penitentiary Administration of Luxembourg facilitate communication for foreign nationals with the outside world. For instance, foreign inmates make extensive use of videophone technology to communicate with their families. Authorities note that the families of inmates who come from far away can stay for longer than the normal maximum duration of the visit. Inmates also have access to international television channels.²⁴⁶

Authorities of the Preventive Detention Centre (Centre pénitentiaire d'Uerschterhaff – CPU) note that, whenever possible, they try to group the detainees by nationality to facilitate their integration within the detention sections.²⁴⁷

The Consultative Commission on Human Rights, in their opinion on the proposed Grand-Ducal Regulation made certain remarks regarding the foreign population:

One of the principal problems encountered by foreign detainees who need to speak the country's languages is access to information, which is conditioned on access to interpretation.²⁴⁸ Recourse to interpretation is only possible if there is no other person at the premises capable of ensuring the interpretation (Article 331).²⁴⁹ In reality, the prison staff communicates with the foreign detainee through another detainee, which compromises the detainee's private life and personal information.²⁵⁰ Also, there is a risk of influencing the detainee by another co-detainee or a false translation.²⁵¹

Even though some information can be provided without the presence of an interpreter, it is indispensable that the majority of information be transmitted in order to guarantee their detainee's understanding, especially when dealing with disciplinary sanctions, searches, discussions with the socio-educative team, and medical consultations.²⁵² The Consultative Commission on Human Rights proposes that if the interpreter is not in situ, other means, such as videoconference or telephone, can be used.²⁵³

The presumption of the risk of absconding when the foreigner does not have a legal residence in Luxembourg raises the percentage of the foreign population in Luxembourgish prisons. The

Consultative Commission on Human Rights recommends that this presumption be limited, as it has been recommended at the international and European levels.²⁵⁴

Maintaining family contacts for foreign detainees is limited. Even though the Consultative Commission on Human Rights (CCDH) recognises that Luxembourgish prisons allow longer visit times and videoconferencing, it recommends that the government and the prison administration find alternatives to make telephone contact more accessible, as it is too expensive for some detainees.²⁵⁵

Finally, the Consultative Commission considers that the placement of detention cannot be considered as an obstacle to detainees accessing their rights. For example, the detainees can apply for international protection or a residence permit and have administrative support.²⁵⁶

The Commission also criticised the practice of placing foreign detainees who are going to be liberated and who do not have a residence permit in administrative detention for the removal of the territory without giving them time to prepare mentally and juridically.²⁵⁷

13. Special measures relating to detention of children and young adults/juvenile detention regime

a. Age groups

The national framework regards minors under 18 at the time of the offence and thus referred to the Youth Court (Art 6).²⁵⁸

Furthermore, in cases where a minor over 16 years old has committed an infraction and a "normal" measure is considered inadequate, the judge can decide that the case should be treated in a regular (adult) tribunal. In such cases, the minor can be convicted and sentenced to a regular prison sentence (Article 32).²⁵⁹

b. General measures for detained children and young adults

During the proceedings, the juvenile court may take the necessary custodial measures regarding the minor (Article 24). If absolutely necessary, the minor may be held in temporary custody in prison for a maximum of one month. The minor is then held in isolation from adult detainees and is subject to a special regime which is determined by the prison administration regulations (Article 26).²⁶⁰

Also, if there is no appropriate placement in existing institutions due to the inappropriate behaviour of the minor, the minor could be placed in the detention/state disciplinary institution (Article 6).²⁶¹

Luxembourg has been reviewing child protection reform. The outstanding bill n°7991²⁶² aims to align the child protection system with the international standards.²⁶³ According to the reform, deprivation of liberty will become a measure of last resort, as well as children who have been convicted or sentenced may no longer be placed in an adult penitentiary but will be detained in a "juvenile penitentiary".²⁶⁴

c. Separation from adults

Minors who are detained in the penitentiary centre benefit from a particular regime, which is different from the adult detainees (Article 138).²⁶⁵ The regimes of defendants and minors are distinct from those

of convicted persons (Article 138).²⁶⁶ Children of young age/small children are not placed in solitary cells unless in the children's best interest (Article 29 (3)).²⁶⁷

In the detention centre, the minor is held in isolation from adult detainees and is subject to a special regime which is determined by the prison administration regulations (Article 26).²⁶⁸

The Penitentiary Administration of Luxembourg emphasises that the duration of a minor's incarceration at the CPL is kept to a strict minimum. Minors in detention facilities receive daily school classes. Each minor is supervised by an educator from the State socio-educational centre (Centre socio-éducatif de l'Etat), who collaborates with them to develop a (n) (integration) project.²⁷³

14. Special measures to protect detainees with disabilities or serious medical conditions

a. Care in detention

The Code of Criminal Procedure states that the State Prosecutor-General take account of the following criteria when applying the procedures for the enforcement of sentences: the sentenced person's personality, state of health, living environment, behaviour and progress in prison, efforts to achieve integration, prevention of re-offending, objective risk of absconding, the sentenced person's attitude towards the victim and the victim's protection and interests, and compliance with the voluntary integration plan (Article 673).²⁷⁴

The Act of 20 July 2018 does not contain any explicit provision on specific measures for detainees with disabilities or serious illnesses. It only states that every prisoner has the right to sufficient and appropriate care that best corresponds to his health (Article 26 (1)).²⁷⁵

The Grand-Ducal Regulation of 24 March 1989 states that detainees with mental health cannot be maintained in prison, and they must be placed in closed psychiatric establishments or services (Article 268).²⁷⁶

In case of non-insane detainees who present symptoms of mental imbalance or psychopathic traits that prevent them from adapting to the internal order of the establishment may be transferred, upon the advice of a doctor, to a particular section of the Luxembourg prison infirmary (psychiatric annexe), where they receive appropriate treatment according to the indications and under the supervision of a

doctor specialising in psychiatry. In this annex, patients are placed under the supervision of a nurse; they may be engaged in activities or work appropriate to their condition (Article 269).²⁷⁷

Regarding non-voluntary placement, the Act of 10 December 2009 contains several guarantees for the patient. The judge must be informed in writing on the same day of involuntary admission, and it will verify if the formal requirements have been complied with but may also rule on whether the admission for observation is justified and decide whether to place the person under observation or discharge of the person admitted. The attending physician must request medical admission and decide on the appropriateness of continuing hospitalisation in a second report before the end of the observation period (Article 16).²⁷⁸ Before making his decision, the judge must hear the patient in question, who may - in theory - be assisted by a lawyer and a support person (Article 11, 12, 13, 18, 21 and 30).²⁷⁹

Finally, work is another area in which health and infirmity are taken into account. In Luxembourg, detainees legally required to work and may only be exempted because of their age, infirmity or, on medical prescription, their state of health (Article 290).²⁸⁰

b. Continuity of care

According to national authorities, often, stationary or outpatient care by an external organisation to a Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg –CPL*) is arranged during incarceration. There, each detainee receives a prescription for their medication and can request a copy of their medical record.²⁸¹

There is an agreement between the health service at the Preventive detention centre (*Centre pénitentiaire d’Uerschterhaff –CPU*) and the Registry (*Greff*), stipulating that upon receiving information about the release or transfer of an inmate to the CPL, immediate notification is sent to health service members. This enables them to promptly initiate necessary measures for follow-up care or, at the very least, to issue a medical prescription.²⁸²

c. Reasonable accommodation and accessibility

In the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*), at least one cell (18 m²) is for individuals with limited mobility or a physical handicap.²⁸³ Also, in the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*), the CPT reported that the prison is going to implement access to the central court, which is equipped with a sports field for individuals with physical disabilities or limited mobility.²⁸⁴

*The Penitentiary Administration of Luxembourg assures that, to the best of their ability, prison facilities are adjusted to suit inmates with physical disabilities. A specific section within the Luxembourg closed detention centre (Centre pénitentiaire de Luxembourg - CPL) has been renovated to cater to elderly inmates. Additionally, the prison psychiatric service oversees the welfare of inmates grappling with mental health issues.*²⁸⁶

*Authorities of the Preventive Detention Centre (Centre pénitentiaire d'Uerschterhaff – CPU) note that for inmates suffering from a serious illness or disability, the daily presence of the penitentiary medical service allows for regular monitoring, ensuring that inmate care is guaranteed at all times. Additionally, if somatic care is needed that cannot be provided within the preventive centre, a transfer to the hospital is ordered on the attending physician's advice.*²⁸⁷

*The Penitentiary Administration of Luxembourg acknowledge that in the context of the Semi-open prison in Givenich (Centre pénitentiaire de Givenich - CPG), individuals with disabilities face specific challenges and considerations. At the core of the Semi-open prison in Givenich is the goal to equip inmates for future social reintegration. This involves enabling their involvement in activities beyond the facility, such as administrative tasks, job searches, and housing inquiries. However, this objective hinges on the inmates' ability to operate with a certain level of autonomy. While the Semi-open prison in Givenich has made strides in accommodating individuals with reduced mobility, including those using wheelchairs, there is still room for improvement in terms of overall accessibility. The absence of a permanent infirmary at the CPG also underscores the need for inmates to be self-sufficient in managing their hygiene needs. Furthermore, the rural location of the Semi-open prison in Givenich and its semi-open structure pose additional considerations for individuals with disabilities. Representatives from the general prosecutor's office must evaluate whether convicted individuals, including those with disabilities, can fulfil their sentence requirements autonomously, including participation in outings from the Semi-open prison in Givenich. For individuals with mental disabilities, the Psychosocial and Socio-Educational Service (Service Psychosocial et Socio-Educatif – SPSE) closely monitors their well-being and guides them as needed. This may involve referral to psychiatric services within the Semi-open prison in Givenich or to specialized services outside the facility to ensure their needs are adequately addressed.*²⁸⁸

The Consultative Commission on Human Rights criticised that measures foreseen in the Act of 20 July 2018 regarding persons with physical disability or limited mobility were not taken.²⁸⁹ It insists that, based on the United Nations Convention on Persons with Disabilities, the prison administration must include adequate training adapted to their handicap.²⁹⁰ It also insists on the fact that persons with a psycho-social handicap are in isolation and should not use handcuffs with deaf persons so they can communicate using sign language and provide accommodation, adapting the communication and access to work.²⁹¹

15. Specific measures to protect detainees with special needs or other vulnerabilities

a. Protection of LGBTI detainees

Neither the Act of 20 July 2018 nor the amended Grand-Ducal Regulation of 24 March 1989 nor the proposed new Grand-Ducal Regulation contains specific provisions for detained LGBTI people.

b. Protection of trans detainees

The Act of 20 July 2018 provides for the possibility of derogating from the incarceration of convicts at the Luxembourg closed and Givenich penitentiary centres in order to ensure non-discriminatory treatment about specific categories of inmates, in particular, because of their sex or age (Article 7 (1) b).²⁹² The detention regime is defined by the Director of the penitentiary centre and applies to detainees, taking into account their gender, the reasons for their detention, and, as far as possible, their age, personality, and previous history. Also, the legal framework provides for detainees to be allocated

to establishments and quarters per the prison rules to be applied to them, considering their gender and age²⁹³ (Article 137).²⁹⁴

During the visit of the CPT visit in 2023, there were no transgender detainees in the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*) or Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*). However, in the report of the CPT, it is mentioned that in the past, the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*) held a transgender detainee who underwent gender-affirming surgery. The authorities mentioned that first, the detainee was placed with the men based on their original sex. Then, the person was transferred with the convicted men in a vulnerable situation or under protection, and later, the detainee was placed in a cell in the institution's infirmary.²⁹⁵ Regarding this point, the CPT considers that transgender persons should be accommodated in the section of the prison corresponding to their gender identity²⁹⁶ or, if exceptionally necessary for security or other reasons, in a separate section which will best ensure their protection. In the latter case, they should be offered activities and association time with other detainees of the same gender with whom they can identify.²⁹⁷

In the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*) it is possible to separate transgender persons from others.²⁹⁸

c. Protection of other vulnerable detainees

The CPT report (2023) notes instances when convicted men in vulnerable situations can be separated; in some circumstances detainees could be placed in a cell in the institution's infirmary (see above in the section regarding trans detainees)²⁹⁹

CPT also emphasised the importance of training of professionals. In its report the CPT underlines the fact that officers (especially newly recruited) underwent trainings for assessing the risks posed by new arrivals and their needs, including in terms of vulnerability and protection.³⁰⁰

In the opinion to the draft of the Grand-Ducal regulations on the organisation of internal prison regimes, the Consultative Commission on Human Rights (*Commission consultative des Droits de l'Homme - CCDH*) emphasised the need to consider “gender, sexual orientation, age, origin, philosophical or religious convictions or disability of those incarcerated, adopting measures to the needs and protection of the concerned persons to avoid the risk of human rights violation”.³⁰¹ Thus, the Consultative Commission points out the drawback of the current legislation and urges to take into account their needs and specificities in the formulation of future law.³⁰²

The Authorities of the Penitentiary Administration of Luxembourg confirm their commitment to ensuring the rights and well-being of all individuals within the facilities, including those who identify as members of the LGBTIQA+ community. They emphasise that, for convicted persons who have declared themselves as such, a thorough assessment is conducted on a case-by-case basis. This evaluation takes into account various factors, including necessary security considerations, the preferences of the individual, and any medical or psychological advice obtained. Similarly, for transgender persons, the Penitentiary Administration recognises the importance of addressing their specific needs with sensitivity and respect. Decisions regarding their treatment and accommodations are made on an individual basis, considering factors such as security requirements, the expressed preferences of the person, and professional guidance from medical and psychological experts.³⁰⁵

Regarding LGBTIQA+, the Consultative Commission on Human Rights has criticised the proposed Grand-Ducal Regulation; it has not foreseen anything relating to gender identity, sexual orientation, and intersexuality or can be protected from any breach of privacy and security of the persons concerned.³⁰⁶

16. Specific measures to address radicalisation in prisons

a. General measures to prevent radicalisation

There are no national standards referring to de-radicalisation.

b. Risk assessments

Besides the standard assessment performed for every inmate entering the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*), there is no uniform evaluation process for inmates either suspected or convicted of terrorist offences.³⁰⁷ Each situation is approached on a case - by- case basis. The psycho-social-educational service and potential external interveners monitor these inmates closely outside the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff — CPU*). In order to detect signs of radicalisation among detainees, the emphasis is laid on specialised training provided to professionals working in the facilities. This measure has been implemented in 2016.³⁰⁸

Semi-open prison in Givenich safeguards vulnerable individuals by actively monitoring interactions between inmates and staff. Personnel promptly address identified vulnerabilities and remain accessible for assistance. Protective measures, such as relocating harassing or threatening inmates (i.e., to the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg - CPL*)), are implemented when necessary, with an initial focus on encouraging positive behaviour among all inmates. Additionally, Psychosocial and Socio-Educational Services (*Service Psychosocial et Socio-Educatif*) organise discussion groups, prevention initiatives, and mediation interviews to tackle instances of harassment or violence, both verbal and physical.

c. Training of staff

Every individual admitted to service within any of the three Luxembourgish penitentiary centres participates in a one-day training session on radicalisation as part of their training. This training is conducted by "respect.lu".³⁰⁹ Furthermore, the Penitentiary Training Institute (IFP) provides an additional two-day training session on radicalisation, specifically in the penitentiary setting.³¹⁰

d. Deradicalisation measures

There are no standardised programs with specific de-radicalisation measures. Instead, external interveners offer each inmate measures tailored to their needs by the Psychosocial and Socio-Educational Service (*Service Psychosocial et Socio-Educatif - SPSE*) if necessary.³¹¹ In previous years, the government foresaw specific de-radicalisation measures for persons in detention facilities.³¹² For instance, it foresaw training and raising awareness campaigns in the facilities and measures to engage in dialogue. For that, the authorities have kept contact with relevant national actors. They also foresaw

a possibility of engaging relatives and close by to implement de-radicalisation measures. However, up until now, there have not been any requests for such measures.³¹³

The Penitentiary Administration of Luxembourg is dedicated to identifying initial signs of radicalisation within detention facilities. They ensure that an Imam is consistently available at the Luxembourg closed detention centre (CPL) to observe detainees. If the Imam notices any alarming behaviour, they notify management immediately for intervention. In cases of suspected radicalisation, thorough discussions are held with the Imam to address concerns effectively.³¹⁴

17. Inspections and monitoring

a. Inspections

The Ombudsman is the national preventive mechanism (Article 2) and is responsible for the external monitoring of places where people are deprived of liberty. In this capacity, they are responsible for

monitoring and evaluating these places throughout the country (Article 3).³¹⁵ The Ombudsman visits the premises with or without prior announcement (Article 4(1)).³¹⁶

b. Access to detention facilities by national authorities

Judicial authorities, the Ombudsman and the Ombudsman for Children and Youth (*Ombudsman für Kanner a Jugendlecher - OKAJU*), Members of Parliament, as well as persons duly delegated by these authorities and institutions, consular and diplomatic agents of other countries, as well as staff of the prison administration and the central social assistance service, shall have free access to prisons and communication with detained persons for the performance of their duties or the accomplishment of their tasks. (Article 24).³¹⁷

c. Access to detention facilities by international bodies

Consular and diplomatic agents of other countries have free access to prisons and communication with detained persons to perform their duties or accomplish their tasks. (Article 23(1)-24).³¹⁸

Under the European Convention for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment, the CPT delegation periodically visits Luxembourg. The latest, sixth visit was carried out in spring 2023.³¹⁹

Regarding access for inspection by monitoring bodies, the Authorities of the Penitentiary Administration of Luxembourg confirm that the Ombudsman has 24/7 access to inspect or check detention facilities. Additionally, the penitentiary administration maintains an internal inspection and surveillance department, enabling the monitoring of detention conditions across various penitentiary centres.³²⁰

18. Access to remedy

a. Legal remedies

According to the 2018 law, detainees can appeal any decision made by a prison centre director to the director of the prison administration. They must write this appeal within eight working days after the prison centre director informs them of the decision. If the prison centre director doesn't decide, they must appeal within three months after three months have passed since the prisoner asked the latter for a decision. The deadlines for appeals and making the administrative appeal do not prevent the decision from being carried out (Article 34).³²¹

All decisions made about detainees by the director of the prison administration under the 2018 law can be reappealed before the Chamber for the enforcement of penalties of the Appeal Court. This appeal must be made in writing within eight working days following communication of the decision of the director of the prison administration to the prisoner (Article 35(1)³²² and court decision of 28 February 2023)³²³). In the absence of a decision from the director of the prison administration, the appeal to the Chamber for the enforcement of penalties of the Appeal Court must be made within three months after three months have passed since the administrative appeal was brought before the director of the prison

administration, failing which it will be inadmissible. Appeals brought directly against a decision by a prison centre director are also inadmissible (Article 35(1)).³²⁴

b. Legal assistance

The law guarantees the lawyer's access to a detainee (Article 24 (2)).³²⁵

Lawyers from the Luxembourg Bar Association (*Barreau de Luxembourg*) have the right to talk privately with suspects, minors they are defending, and detainees being deported without a guard present during work hours. They can also visit convicted individuals under the same conditions, as long as the convict has filled out a form provided by the prison beforehand. This form, which doesn't ask about the reasons for the visit to protect lawyer-client confidentiality, must be presented during the visit (Article 240).³²⁶

EU lawyers who are not members of the Luxembourg Bar Association can only visit detainees in the presence of a Luxembourgish lawyer or with special permission. A judge can grant this permission if the person is still under investigation, by the state prosecutor if they are awaiting trial, or by the state attorney general if they are already convicted. In all cases, the visiting lawyer must prove their membership in a bar association from an EU country (Article 241).

Confidentiality is assured in correspondence between a detainee and their lawyer. Under Articles 226-227, letters sent between detainees and their lawyers in sealed envelopes must be checked. They are sent or delivered to their recipient promptly if it is clear that they genuinely intend for the lawyer or come from them. For this purpose, important information must be written on the envelope to show the identity and professional address of the recipient or sender. Letters from the lawyer must have the lawyer's signature on the envelope, except for the mention of "lawyer's mail," or they can be personally delivered by the lawyer to the State Attorney General or the director. Checking suspicious packages and letters follows a procedure decided by the State Attorney General in coordination with the president of the Bar Association.³²⁷

The CTP (2023) expressed concerns about the expensive phone calls in the visited prisons, including charges for contacting their lawyer. Regarding solitary confinement at the Preventive detention centre (*Centre pénitentiaire d'Uerschterhaff - CPU*), detainees complained of being unable to make phone calls, including to their lawyer, during the initial days. While acknowledging the need for restrictions in some cases, the CPT stresses the importance of such communication and recommends limitations be strictly necessary and brief.³²⁸

c. Request and complaints

The detained person is required (in written form) to appear before the director of the prison in matters of discipline. The detained person has not less than twenty-four hours in which to prepare their defence. Before the director or the delegate, the detained person submits their observations. The statement is attached to the report (Article 33 (6-7)³²⁹ Decisions made by prison governors regarding detained persons can be appealed to the Director of Prison Administration. Appeals must be submitted in writing within eight working days of the governor's decision notification or, if no decision is made, within three months after three months have passed since the initial request to the governor. These appeal deadlines do not suspend the effect of the original decision.(Article 34).³³⁰

However, CPT 2023 notes instances when a disciplinary measure was carried out before the appeal deadline expired. Several detained persons told the delegation there was no point in making such an appeal. Moreover, the appeals lodged with the Luxembourg closed detention centre (*Centre pénitentiaire de Luxembourg- CPL*) were very few, and all of them resulted in the initial decision being upheld.³³¹

d. Independent authority

Articles 2 and 3(1) outline the procedure for filing complaints with the Ombudsman. Anyone who believes that a relevant authority has not fulfilled its duties or has violated applicable laws, can submit a written or oral complaint to the Ombudsman. However, before making a complaint, they must first attempt to resolve the issue through administrative channels with the relevant bodies.³³²

Regarding access to remedies for detainees, the Authorities of the Penitentiary Administration of Luxembourg confirm that detainees can submit written complaints to the prison management and receive a written response. Detainees regularly utilise this complaint mechanism. In cases where detainees are dissatisfied with the response they receive, they can file an administrative appeal with the director of the penitentiary administration.³³⁵

Key facts of the case	The applicant was placed in solitary confinement on 29 January 2024 due to several disciplinary incidents, in particular for having made serious threats against several prison officers. His behaviour following placement in solitary confinement was correct and there were no incidents. Nonetheless, the Director of the Prison Service decided to extend the applicant's solitary confinement on 29 February 2024. The decision was based on the fact that the applicant could not be integrated into any ordinary section of community life, either because of problems with fellow inmates or because of a conflictual relationship with certain members of the prison staff. The applicant appealed this decision on 1 March 2024.
Main reasoning/argumentation	The Court starts by reminding that the detainee is automatically placed under community living if the conditions for solitary confinement are no longer met. These require that the detainee is unfit for community living because of his personality or behaviour. The Court then notes that (i) the behaviour as such of the applicant during his placement in solitary confinement was not open to criticism and (ii) the extension of the latter was based on general considerations of internal organisation of a transfer of the applicant to an ordinary section of the prison. In this context, the Court concluded that the conditions that led to the applicant being placed in solitary confinement no longer persisted. The extension of solitary confinement was therefore no longer justified in the light of the conditions laid down in the law.
Key issues (concepts, interpretations) clarified by the case	The key legal question clarified by the case consisted of the permissible grounds for maintaining a detainee in solitary confinement.
Results (sanctions) and key consequences or implications of the case	The Court upheld the appeal and ordered that the applicant be placed under community living.

	<p><i>"It is clear from the information submitted for the assessment of the Chamber for the enforcement of penalties that the conditions that led to the placement of PERSON1 in solitary confinement no longer persist. On the contrary, it follows both from the position of the Director of the Luxembourg closed detention centre of 29 February 2024 and from the assessment report of 26 February 2024 by the officer of the CPL's Psycho-social and Socio-Educational Department that PERSON1.)'s conduct as such during his placement in section E is not open to criticism, but that the proposal to extend his solitary confinement is based rather on general considerations relating to the internal organisation of a transfer of the applicant to an ordinary section. The Chamber for the enforcement of penalties therefore agrees with the Public Prosecution Service's finding that, on the basis of the evidence submitted for assessment, continued solitary confinement is no longer justified in the light of the conditions laid down in this respect by the aforementioned Article 29(2) (...)".</i></p>
