Adoption of Management Board budgetary transfer 2024-Subject: 01 and Amendment n.1 of the Programming Document

THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR FUNDAMENTAL RIGHTS

HAVING REGARD to Management Board decision of 17 May 2019 on the Financial Rules applicable to the budget of the Agency (hereinafter referred to as the 'Financial Rules'), and in particular article 32 paragraph 3 thereof,

HAS DECIDED AS FOLLOWS:

SUBJECT:	Annex I – 2024-01 Management Board budgetary transfer

A budgetary transfer is proposed to the Management Board. This proposal reallocates funds from Title I – Staff expenditure amounting to $\[\le 251,650$ to Title III – Operational expenditure, as well as reshuffles funds within Titles I, II & III. Amounts smaller or equal to $\[\le 2,000$, as well as decimal values are only indicated in Annex II.

Title I - Staff expenditure

Following a first budget revision, taking into consideration changes in planned and actual staffing throughout the year as well as requests for unpaid leave, part-time working and the impact of the salaries increase which was lower than expected, resulted in the following surpluses of salary related budget lines:

- A01101 Family allowances
 This item is proposed to be decreased by €141,000.
- A01102 Expatriation and foreign residence allowance
 This item is proposed to be decreased by €5,000.
- A01110 Staff exchanges
 This item is proposed to be decreased by €15,000.
- A01112 Contract Agents
 This item is proposed to be decreased by €24,000.
- A01184 Temporary daily subsistence allowances
 This item is proposed to be decreased by €2,500.

A01113 - Trainees

Following a first budget revision, this item is proposed to be increased by €2,500 by reshuffling funds within Title I.

A01190 – Salary weightings

Following a first budget revision, this item is proposed to be increased by €16,000 by reshuffling funds within Title I.

A01200 – Recruitment expenses

The amount of €15,000 is proposed to be released due to a lower number of translations than originally forecasted.

A01203 - Removal expenses

Due the result of the maximum amount set for removal expenses granted by PMO to the departed staff, this item was found to be surplus of €10,000.

A01500 – Professional training of staff

Due to more online trainings, which are less expensive than in-person ones, the amount of €5,000 was identified to be surplus.

A01660 - External services

The final amounts to be paid are less than forecasted. Therefore, the surplus of €4,650 is proposed to be released.

A01810 - Social contacts between staff

The actual expected amount to be paid will be less than those initially forecasted. Therefore, this item is proposed to be decreased by €15,000.

A01820 - Other welfare expenditure

Following the annual budget revision on schooling, in particular to one-time fees in relation to new enrolments, this item is proposed to be increased by €17,000.

A01830 - Early childhood centres

Following last year's MB Decision in December, adopting a revised policy on the education and childcare costs, eligible FRA staff with children below the primary school age are automatically entitled to "pre-school" education allowance, which cannot be waived to a statutory allowance. Therefore, this item is proposed to be decreased by €50,000.

Title II – Buildings, equipment and miscellaneous expenditure

A02020 - Water, Gas, Electricity and Heating

Following a price increase of the monthly advance payment of electricity and heating, this item is proposed to be increased by €72,966.

A02353 – Departmental removals and associated handling

This item is proposed to be decreased by €72,966. This amount was found to be in surplus considering that costs for services related to moving out of the current premises is not expected to be contracted in the current year.

Title III – Operational expenditure

B03000 - Data & Digital

The budget of the project B.2.1 Online content moderation - supporting implementation of the Digital Services Act (DSA) is proposed to be increased by €115,000. To support the fundamental rights compliant implementation of the DSA, FRA will provide an analysis of fundamental rights standards in EU law, including case law, to provide guidance in relation to online platforms' conduct. This will be complemented by a review of available empirical evidence and studies on risks to fundamental rights.

B03010 - Justice & Security

The budget of the project B.1.6 Digitalisation of justice: fundamental rights guidance is proposed to be increased by epsilon111,000. This amount will allow to enhance the robustness and extend the geographical scope of FRA's research by adding two more member states to the fieldwork research phase.

B03500 – Communicating Rights – Media & Events

The project D.1.2 Fundamental Rights Forum is proposed to be decreased by €50,000. Most of the services needed for the implementation of the FRF event were covered by budget from the previous year.

B03700 - Human Rights structures & mechanisms

The project C.1.3 Providing assistance and expertise on the EU Charter of Fundamental Rights is proposed to be increased by €60,000. In a first phase, the Agency will collect basic information on national impact through its network of National Liaison Officers and National Human Rights Institutions with a view to provide a general overview of the existence of human rights impact assessments and legal scrutiny systems referring to the Charter. Based on this initial mapping, it is then planned to conduct in-depth field research through FRANET in up to 10 selected countries with well-developed systems. The research will entail interviews with relevant legal practitioners to identify drivers and obstacles for encompassing

and efficient impact assessments/legal scrutiny offering entry points for Charter related compliance checks.

B03800 - Performance Monitoring and Evaluation

The project E.1.1 Performance, Monitoring and Evaluation is proposed to be increased by €6,650. This amount was used for the external evaluation of the Fundamental Rights Forum 2024, which was contracted directly within this project instead of within the FRF project, where it was initially budgeted.

B03900 - Reserve for Title III

This item is proposed to be increased by $\leq 9,000$ which will allow to distribute these funds with the next agency transfer.

B.1.6 Digitalisation of justice: fundamental rights guidance

Area of activity: Justice, Digital and Migration Sector: Justice and Security Status: new

Policy relevance

On 9 June 2020, the Council adopted conclusions on "Shaping Europe's digital future", where it recognises that 'the digitalisation of the justice systems of the Member States has the potential to facilitate and improve access to justice throughout the EU.' The October 2020 Council conclusions on "Access to justice – seizing the opportunities of digitalisation" called on the Commission to take concrete action to digitalise justice. In December 2020, the Commission adopted a Communication on the digitalisation of justice in the EU, proposing a set of measures to bring forward digitalisation at both the national and EU level. Subsequently, the Commission adopted several proposals for EU secondary law instruments in this field, including a proposal from 2021 for the Regulation on the digitalisation of judicial cooperation and access to justice in cross-border civil, commercial and criminal matters - which seeks to guarantee a common approach towards the use of modern technologies in cross-border judicial cooperation and access to justice. The Commission has also been looking into the effectiveness of national justice systems through the European Semester and the EU Justice Scoreboard. According to the 2023 EU Justice Scoreboard, most EU Member States already use digital solutions in different contexts and to varying degrees in relation to their justice systems, while there is still significant room for improvement in the digitalisation of justice.

The use of digital technologies, including algorithm-based solutions, has the potential to make judicial systems more transparent and efficient for the benefit of all – from businesses to individuals (including both persons suspected or accused of crime, as well as victims). Digital solutions can ease the administrative burden, shortening case processing times, making communication more secure and reliable, making information more publicly accessible and partially automating case handling. At the same time, effective fundamental rights safeguards need to be put in place to ensure that the use of digital technologies in the area of justice does not undermine the right to a fair trial and effective legal remedy, including the equal opportunity for both parties to make their case (equality of arms), the right to have knowledge of/comment on all evidence and observations filed (adversarial proceedings), the right to a public hearing, as well as - in criminal proceedings - the rights of the defence, including access to a lawyer and the case file.

The project – with data collection in 2024 – sets out to provide a balanced assessment of the potential applications of digitalisation in the justice field with respect to its fundamental rights impact, looking at the opportunities and limitations, including 'red flags' and minimum safeguards needed. This should include how to ensure that digital justice is accessible for all. In line with established FRA methodologies, the research will consist of desk research complemented by fieldwork in selected Member States by means of targeted qualitative interviews with relevant stakeholders. The project will take into account and build upon the existing relevant work of European and other international actors active in this field; for example, the Council of Europe's European Commission for the efficiency of justice (CEPEJ) and the Consultative Council of European Judges (CCJE); in particular, exchanges of updated information on cyber-justice with CEPEJ's Resource Centre on Cyberjustice and Al could be organised on a regular basis.

Objectives

- Analyse in detail the fundamental rights impact of the digitalisation of justice systems, and assess the minimum fundamental rights safeguards required
- Provide guidance to EU institutions and Member States, in particular their justice authorities, about fundamental rights opportunities as well as risks and necessary safeguards when using digital tools in the justice system

Activities Outputs

- Desk research mapping the practical uses of digital tools/technologies in justice systems
- In-depth field research on selected 'use cases'
- Two meetings (maximum) with key stakeholders
- Drafting guidance on fundamental rights compliant 'digital justice'

B.2.1 Online content moderation - supporting implementation of the Digital Services Act

Area of activity: Justice, Digital and Migration Sector: Data and Digital Status: on-going

Policy relevance

In 2021-2023, FRA carried out a study on online harassment, hate speech and (incitement to) violence targeted at women and selected ethnic and religious minorities to address the pervasive challenge of creating a safer online space.

The project carried out an analysis of incidents of online harassment and hate speech through data collection from selected social media channels. Based on a methodology to systematically search for pre-specified terms in selected countries, the data highlight the extent and nature of harassment and other forms of hatred on various online platforms and in different languages in the EU, focusing on the impact on specific groups.

In 2024, the Digital Services Act enters into force, upgrading the liability and safety rules for digital platforms, addressing several fundamental rights matters in its provisions (the provisions related to very large online platforms and search engines already entered into force in 2023).

In 2024, the project's results will feed into the Commission's work on the implementation of policies and acts on online content moderation, such as the DSA and the code of conduct on illegal hate speech, with a view to informing the ongoing development of regulatory and non-regulatory responses to online content moderation. Given the ongoing need for evidence and analysis related to the implementation of the DSA, FRA will provide input based on its research findings, and additional input based on legal analysis and a literature review on fundamental rights protection in relation to online platforms' conduct. FRA will provide an analysis of fundamental rights standards in EU law, including case law, for selected fundamental rights mentioned in Article 34 (1) of the DSA to provide guidance in relation to online platforms' conduct. This will be complemented by an analysis of available empirical evidence and studies on risks to fundamental rights.

Objectives

- Collection of data on online harassment, hate speech and (incitement to) violence in selected EU member states to increase the understanding of existing online hatred;
- To better support through the provision of empirical evidence legislative and policy initiatives to address the fundamental rights implications of hate speech online and online platforms conduct in general;
- Contribute to the development of methodologies for online data collection on fundamental rights related topics

Activities Outputs

- Continuation of in-house background research on policies and laws regulating online content;
- Dissemination of research report;
- Stakeholder/expert consultation.
- Systematic mapping of applicable fundamental rights standards in EU law
- Systematic mapping of available empirical evidence on fundamental rights risks through online platforms' conduct.
- Two meetings (maximum) and presentations of project findings at policy level.
- FRA report in 2025.
