

PRIVACY NOTICE

Bodies of the Agency (MB, EB, SC)

The European Union Agency for Fundamental Rights (FRA) processes the personal data of a natural person in compliance with Regulation 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC.

PRIVACY NOTICE

1. Why do we collect personal data?

The data are collected for the specific objective of the organisation of meetings and reimbursements of participants.

2. What kind of personal data does the Agency collect?

Data subjects submit their name, address, contact details like e-mail addresses, phone, mobile and fax numbers, postal addresses, CV (listing educational background and professional experience), bank account information, and information on their legal entity.

3. How do we collect your personal data?

Data subjects submit their name, address, contact details like e-mail addresses, phone, mobile and fax numbers, postal addresses, CV (listing educational background and professional experience), bank account information, and information on their legal entity.

4. Who is responsible for the processing your personal data?

The Agency is the legal entity responsible for the processing of your personal data and determines the objective of this processing activity. The Head of Institutional Cooperation & Networks Unit is responsible for this processing operation.

5. Which is the legal basis for this processing operation?

Processing is necessary for organisation of meetings in which the data subject is involved in order to take steps at the request of the data subject, prior to entering into the organisation of the event, for the performance of tasks carried out in the public interest on the basis of the Treaties establishing the European Communities and in particular the Council Regulation (EC) No. 168/2007 establishing a European Union Agency for Fundamental Rights, as well as art. 5 (a) and (b) of the Regulation (EU) N° 2018/1725.

6. Who can see your data?

CVs of the Management Board members and, after consent, of the other members of the Bodies of the Agency, are published on the website together with their declarations. For the SC members, not only CVs and Declaration of interest, but also a Commitment of independence and Declaration of confidentiality are published on the website. Contact details are circulated (after consent) amongst members of the same group.

7. Do we share your data with other organisations?

Personal data is processed by the Agency and the Commission services that perform the reimbursements on behalf of the Agency only. In case that we need to share your data with third parties, you will be notified to whom your personal data has been shared with.

8. Do we intend to transfer your personal data to Third Countries/International Organizations?

9. When will we start the processing operation?

We will start the processing operation in the first day of data submission.

10. How long do we keep your data?

End of term of office plus 1 year.

11. How can you control your data?

You can access, modify or delete your personal data by sending an email request to Elena.Balzarini@fra.europa.eu. More details are provided below.

11.1. Your data protection rights

Under data protection law, you have rights we need to make you aware of. The rights available to you depend on our reason for processing your information.

a) Can you access your data?

You have the right to receive confirmation whether or not we process your personal data. Furthermore, you can have access to such data, as well as obtain copies of your data undergoing processing, at any time and free of charge, by sending an email request to Elena.Balzarini@fra.europa.eu

b) Can you modify your data?

You have the right to ask us to rectify your data you think is inaccurate or incomplete at any time by sending an email request to or Elena.Balzarini@fra.europa.eu

c) Can you restrict us from processing your data?

You have the right to block the processing of your personal data at any time by sending an email request to Elena.Balzarini@fra.europa.eu (when you contest the accuracy of your personal data or when the Agency no longer needs the data for completing its tasks. You can also block the processing activity when the operation is unlawful, and you oppose to the erasure of the data.

d) Can you delete your data?

You have the right to ask us to delete your data at any time by sending an email request to Elena.Balzarini@fra.europa.eu when the processing activity is unlawful.

e) Can you request the transfer of your data to a third party?

This only applies to information you have given us. You have the right to ask that we transfer the information you gave us from one organization to another, or give it to you. The right only applies if we are processing information based on your consent or under, or in talks about entering into a contract and the processing is automated.

f) Do you have the right to object?

Yes, you have the right to object at any time by sending an email request Elena.Balzarini@fra.europa.eu when you have legitimate reasons relating to your particular situation. Moreover, you will be informed before your information is disclosed for the first time to third parties, or before it is used on their behalf, for direct marketing purposes.

The Agency will address your requests within 15 working days from the receipt of the request.

g) Do we do automated decision making, including profiling?

12. What security measures are taken to safeguard your personal data?

The Agency has several security controls in place to protect your personal data from unauthorised access, use or disclosure. We keep your data stored on computer systems with limited access to specified personnel only.

13. What can you do in the event of a problem?

b) The second step, if you obtain no reply from us or if you are not satisfied with it, contact our data protection officer (DPO) at dpo@fra.europa.eu.

c) At any time you can lodge a complaint with the EDPS at <http://www.edps.europa.eu>, who will examine your request and adopt the necessary measures.
