- **Elisabeth Kaneza** is Senior Fellow at the UN Human Rights Fellowship Programme for People of African Descent. She is a human rights expert from Germany and currently works with the UN Human Rights Regional Office for Europe on the promotion of the International Decade for People of African Descent in the EU.
- **Esther Mamadou** is a jurist expert in forced migrations and human rights who has worked in the European and Southamerican contexts . Based in Valencia, she is currently the coordinator of the Refugee Programme at a Spanish non governmental organisation and the Executive Director of the European Network of People of African Descent.
- **Christie Edwards** has worked globally on international human rights, international humanitarian law, international development policy, and gender issues for over 18 years. She has lead and implemented successful human rights, political advocacy, and civil society building programs, as well as strategic planning, fundraising, and grants management in senior leadership roles at the national and international level with prominent human rights organizations and international organizations.
- **Tena Šimonović-Einwalter** is Deputy Ombudswoman at the Croatian Office of the Ombudswoman.
