Other (please specify): The data collected by CSES Europe for this project will be stored on CSES Europe's server located in Microsoft data centres within the European Union and accessed by CSES in Ireland and the United Kingdom.. All electronic data held by CSES Europe is backed up centrally on the servers on a daily basis. Backed up data is also securely stored off-site within secondary corporate facilities. The data is explicitly tied to the Data Centre location and no transfers outside of the EU can/will occur.
