THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR FUNDAMENTAL RIGHTS

HAVING REGARD to the Agency's Financial Rules and in particular article 20, the Director may accept any donation made to the Agency,

HAVING REGARD to the Agency's Financial Rules and in particular article 28, any amendment to the budget shall be the subject of an amending budget adopted by the same procedure as the initial budget, in accordance with the provisions of the constituent instrument and article 27 of the Financial Rules,

#### WHEREAS:

- 1. The Agency received a total of 244,000 EUR from the Austrian Authorities, corresponding to one third of the monthly rent for the period January December 2012.
- 2. The Agency received a total of 26,887.14 EUR, corresponding to the Danish government's contribution to the Disability project.

HAS ADOPTED the Amending Budget 2012-01 as provided in Annexes I and II.

#### a) Background

- 1. According to Article 20 of the Agency's Financial Rules, the Director may accept any donation made to the Agency.
- 2. The Agency negotiated with the Austrian Authorities a contribution to the payment of the rent in the new premises. Currently, the Austrian Authorities contribute to one third of the yearly rent.
- 3. On 3 May 2012 the Agency received a total of 244,000 EUR from the Austrian Authorities, corresponding to one third of the annual rent for the period January December 2012.
- 4. In addition, on 16 August 2012, the Agency received a total of 26,887.14 EUR. This amount refers to the Danish government's contribution to the Disability project.
- 5. Based on article 28 of the Financial Rules, these amounts need to be entered in the Agency's budget in the form of an amending budget.
