THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR FUNDAMENTAL RIGHTS

HAVING REGARD to the Council Regulation (EC) No 168/2007 of 15 February 2007 establishing a European Union Agency for Fundamental Rights (hereinafter referred to as the 'Agency'), and in particular Article 12 paragraph 6 (a) thereof;

HAVING REGARD to Management Board decision of 23 October 2008 on the Financial Rules applicable to the budget of the Agency (hereinafter referred to as the 'Financial Rules'), and in particular 23§2 thereof;

HAS DECIDED AS FOLLOWS:

Article 1

The reallocation of funds on 2012 budget from Title II to Title III amending the Agency's Annual Work Programme 2012, in order to finance research and data collection, and communication and awareness-raising activities as explained in Annexes I and II, III and IV.

SUBJECT: 2012-01 Management Board budgetary transfer

During the budget revisions of the first eight months of the financial year a need for additional funds under Title III (Operational Expenditure) amounting to 84,000 EUR has been identified. The Agency through economies under Title II (Operating Expenditure) saved this amount and proposes its transfer to Title III as discussed below. In addition, fine-tuning of funds under Title I – Staff Expenditure is needed.

Title I – Staff Expenditure

Following a revision it has been noticed that due to part-time working, parental leave, unpaid leave and the end of the contract of one staff member, surpluses have been generated in the salaries budget lines (i.e. A-1101, A-1131 and A-1190). These surpluses need to be reallocated in order to be used by other budget items.

The number of the trainees has been increased to twenty one. Therefore, budget item A-1113 Trainees is proposed to be increased by 18,000 EUR in order to cover the related expenses,

Following the reception of the invoice related to administrative services provided by the Commission, the estimated amount has been adjusted and budget item A-1178 External services can be reduced by 5,000 EUR.

The Agency needs a lawyer's advice on human resources issues. This results in a need of 18,500 EUR under budget item A-1430 Legal services.

The budget item A-1520 Staff exchanges needs to be increased by 120,000 EUR. During 2012 some of the secondments of the National Experts (SNEs) came to an end. There were cases were SNEs with no financial implications for the Agency (e.g. those seconded by Austrian governmental institutions) where replaced with SNEs entailing regular costs (e.g. those seconded by non-Austrian governmental institutions).

Budget items A-1610 Social contacts between staff and A-1620 Other welfare expenditure are proposed to be reduced by 30,000 EUR and 28,400 EUR accordingly. These surpluses refer to savings made from the organisation of the staff retreat and a revision of the schooling costs which was based on the actual enrolments.

Title II – Operating Expenditure

Title II is proposed to be reduced by 84,000 EUR representing a decrease of 1.5% compared to the adopted budget as presented below. In addition, minor amounts fond to be in surplus under the following budget items:

A-2000 Rent - 3,169 EUR A-2010 Insurance - 1,152 EUR A-2040 Fitting-out of premises -2,442 EUR

A-2020 Water, gas, electricity and heating

In late 2011 and early 2012 the Agency enhanced its heating system resulting in a reduction of the heating costs. Therefore, 14,800 EUR found to be in surplus under this budget item representing 11% of the adopted budget.

A-2100 Hardware/Software

Due to the growing needs of the Agency an additional amount of 94.920 EUR is required to cover the costs for the acquisition of the storage equipment. This amount will also allow the setup of offsite back up to a remote site (CEDEFOP), which will address the requirements of the Business Continuity.

The storage needs have been identified following performance assessment studies of the Agency's systems. Furthermore, Business Continuity is an area identified by IAS following their IT risk assessment. This investment was also discussed with the Agency's ICT steering committee that oversees IT related costs and proposes actions to the Director. This activity was foreseen in the ICT Annual Plan provided that there is financial opportunity of available funds.

A-2200 Technical equipment and installations

This budget item can be decreased by 13,698 EUR representing 68% of the adopted budget. The foreseen amount for the maintenance and enhancement of the technical equipment was not consumed. This amount related primary to the conference room and audio-visual equipment for the in-house video production. As no request was received so far the amount can be reallocated.

A-2203 Maintenance, use and repair of technical equipment

The total amount allocated to this budget item (i.e. 27,000 EUR) can be reallocated. The availability of this amount is due to the fact that the printer maintenance costs are now charged to the budget item A-2100 Hardware/Software. The reason for this is that printers are considered hardware and their acquisition is foreseen under that budget item.

A-2210 Furniture

During the course of the year, it was identified that no furniture is needed as some of the existing equipment could be used for longer time. Therefore, this budget item can be decreased by 13,900 EUR representing a decrease of 93% compared to the adopted budget.

A-2330 Legal expenses

The total amount allocated to this budget item can be transferred to Title III. As described in the Annual Activity report of 2011, there was an on-going court case against the Agency concerning the award of a procurement procedure. For this reason 20,000 EUR had been allocated to cover the related expenses. However, during the beginning of the year an amicable was found and the case was withdrawn. Therefore, no funds are required under this budget item.

A-2400 Postage and delivery charges

Following the Activity Based Budgeting (ABB) principle the postage expenditure related to the Agency's publications should be charged under Title III Operational Expenditure. Therefore, trying to reinforce the use of ABB in the Agency the amount of 14,262 EUR representing 31% of the adopted budget found to be in surplus.

A-2410 Telecommunications chargers

During the year the telecommunication costs have been reduced. Therefore, this budget item can be decreased by 35,475 EUR representing 24% compared to the adopted budget.

A-2611 Studies, surveys and consultations

The total amount allocated to this budget item (i.e. 33,020 EUR) can be transferred to Title III. The funds were provisionally allocated to this budget item and based on past needs. However, this year the Agency does not intent to request this type of services.

Title III – Operational Expenditure

Title III is proposed to be increased by 84,000 EUR representing an increase of 1% compared to the adopted budget.

B-3221 Visa and border control

Following a budget revision of the project treatment of third county nationals at the EU's external borders 4,476 EUR found to be in surplus. This amount represents 2% of budget item's the adopted budget.

B-3311 Racism, xenophobia and related intolerance

In March 2012 the Agency organised a stakeholder meeting referring to the project 'Discrimination and victimisation of Jews'. The budget of this meeting was estimated on the basis of the people invited. However, the Agency final invoiced on the basis of the actual participation resulting in a surplus of 7,785 EUR under this budget item. In addition, following a budget revision of the project 'Holocaust Education – Human Rights Education' the amount of 3,720 EUR found to be in surplus. The total amount (i.e. 11,506 EUR) represents a decrease of 15% compared to the budget item's adopted budget.

B-3321 Discrimination

The budget of the project 'LGBT survey' has been increase by 25,000 EUR. This amount, although it was referring to the project's 2012 tasks, it was inadvertently committed in 2011 from that year's funds and was not taken into consideration in the 2012 budget. During an ex-post control this was noticed and the 25,000 were de-committed in order to respect the principle of annuality and recommitted with 2012 funds. Therefore, the 2012 budget of this project needs to be increased accordingly.

In addition, the budget of the 'Fundamental Rights of Persons with Intellectual Disabilities and Persons with Mental Health Problems' project needs to be increased by 18,650 EUR. This amount indents to cover the costs for the translation and production of the 'Choice and Control' report, which amounts to 26,400 EUR. The difference is covered by the project's surpluses from other tasks.

The total amount of 43,649 EUR represents an increase of 2% compared to the adopted budget.

B-3331 The rights of the child, including the protection of children

The budget concerning the project 'Children and Justice' needs to be increased by 27,567 EUR representing 6% of the adopted budget under this item. One of the project team members will go on maternity leave as from the end of October 2012 which will be followed by parental leave returning in August 2013. Therefore, an external consultant needs to be contracted to ensure a smooth continuation of the on-going fieldwork, output delivery and preparation for next year's project. The purpose would be to support the project on child-friendly justice (CFJ) and the rights of the child team with regard to evaluating and analysing incoming deliverables as well as preparing draft documents on conducting research with children and reporting on policy-relevant development with regard to children rights within FRA as well as the EU.

B-3711 Communication and awareness-raising

Following a budget revision of the communication projects 3,776 EUR need to be reallocated to this budget item.

B-3801 Bodies of the Agency

For the organisation of the four Scientific Committee meetings or the year 50,000 EUR had been foreseen in the previous AWPs. For AWP 2012 the budget was increased to 85,000 EUR in order to cover the cost of the Scientific Committee opinions and the planned publication of the call for expression of interest for the new Scientific Committee member. Finally, the extra amount of 38,769 EUR was needed was needed to cover the cost for the publication of this expression of interest in different and relevant newspapers ensuring appropriate publication.

In addition, the Annual Work programme 2012 foresees two Management Board meetings in 2012 with a total amount of 75,000 EUR. An additional meeting is taking place in September, for which 27,267 EUR will be needed. The Austrian Ministry of Foreign affairs will contribute partially to the cost of this meeting. However, the amount will only be known after the Management Board meeting and the Agency will have to introduce it in its budget in the form of an amending budget after the amount has been cashed. This will probably happen during next financial year.

The total amount that needs to be reallocated to this budget items is 66,036 EUR which represents 25% of the adopted budget.

B-3900 Operational reserves

41,045 EUR of surplus has been identified under this budget item representing 14% of the adopted budget. 266,000 EUR had been initially placed under the operational reserves in order to cover the monitoring and evaluation activities of the operational projects in line with the market costs for that scale of tasks. Following a reopening of competition, the first specific contract referring to three of the five tasks, was awarded for the amount of 68,910 EUR. The estimated budget for the remaining two tasks has been revised accordingly and the excess funds are released.

Handbook on European law in the field of asylum, immigration and border control

Project description

Objectives

Issues arising in the areas of asylum, immigration and border control are increasingly coming under consideration in cases both before ECtHR and CJEU. Relevant European law is not always readily understood. Groups in need of particular guidance comprise administrative-law judges (and judicial training academies) and legal practitioners, as well as officials at border posts and in holding centres (and their in-house trainers), law enforcement officials, and NGOs.

The main objective of the project is to raise awareness and knowledge amongst judges and legal practitioners of fundamental rights guarantees in the area of asylum, immigration and border control. The European Court of Human Rights will be a project partner in the implementation of this project. In addition, the FRA will collaborate with the Court of Justice of the European Union, FRONTEX and the EASO when carrying out the project. The project will result in a Handbook, which will provide legal professionals and judges at national level, with an accessible summary and analysis (in selected EU languages) of the relevant case law of the Court of Justice of the European Union and the case law of the European Court of Human Rights.

In the area of asylum, the project will build on work undertaken in the context of the European Asylum Curriculum, which will be carried out in consultation with the EASO. The FRA will coordinate implementation of this project with other related initiatives that look to set up case law databases by the EASO, international organisations, and other related initiatives funded by the European Refugee Fund.

This project builds on the methodology followed in the first FRA-ECtHR joint project which enabled the publication of a Handbook on European case-law in the field of non-discrimination (2010-2011). It will also supplement FRA work on accessing efficient and independent justice, supplement FRA/FRONTEX cooperation in the area of training, and contribute to the various FRA projects in the area of asylum and immigration (2009-2011).

Treatment of third country nationals at the EU's external borders

Project description

Objectives

The Schengen Borders Code underlines that border checks should be carried out in a professional and respectful manner and fully respect human dignity in accordance with the Charter of Fundamental Rights and of the obligations deriving from the principle of non-refoulement. (Recitals 6 and 20, Articles 3 and 6). Procedural safeguards are foreseen in case of refusal of entry by border officials (Article 13). Organisations mandated to protect specific groups of persons, such as UNHCR, have highlighted the practical obstacles that asylum-seekers may face in accessing asylum procedures, including their access to redress (complaints mechanisms and follow-ups). NGOs have also raised concerns about the treatment of different vulnerable groups at the EU's borders.

There is limited information regarding the treatment of third country nationals at the external EU borders. The objective of this project is to support policy makers by providing a detailed picture of the situation at the EU's borders, as well as on the kind of training on fundamental rights that is provided to border guards. The Agency will cooperate with FRONTEX, and the new European Asylum Support Office (EASO), in the further development of the project so that the results may serve to inform national level and joint operations concerning the treatment of third country nationals at the EU's external borders.

Overall outputs

The following outputs are envisaged:

a comparative report on the treatment of third country nationals at the EU Southern sea borders, including good practices which promote respect for fundamental rights;

advice to national authorities in charge of border management on fundamental rights training and possibly development of innovative training tools.

comparative report on the treatment of third country nationals during border checks at border crossing points, focusing in particular on large air and land crossing points.

Following consultations with stakeholders in Vienna during 2010, the scope and content of the project was defined, and in the same year the Agency launched a tender for the research component of the project. Survey on discrimination and hate crime against Jews in selected EU Member States

Project description

On the basis of its EU-MIDIS survey the Agency started in 2011 a similar discrimination and victimisation survey on a random sample of Jews in selected EU Member States. The issues covered include experiences of discrimination (direct, indirect and harassment) in key areas of social life, as well as experiences of criminal victimisation and hate crime. In addition perceptions of the extent of discrimination and hate crime are also explored, as well as awareness of legal remedies and victim support.

Objectives

The survey provides research evidence, previously unavailable, on the experiences of discriminatory treatment and criminal victimisation (including hate crime), perceptions of discrimination and personal safety, and rights awareness among Jews in the selected Member States. The survey results will inform policy makers and other stakeholders in developing legislation and policies in the EU, regional, national and local levels to tackle discrimination, hate crime, lack of awareness of rights and to improved service delivery to affected persons.

Fundamental Rights Conference

Project description

The FRC is the Agency's flagship event, and creates a space for decision-makers, experts and human rights defenders to examine key fundamental rights challenges in the EU and develop courses of action that better guarantee their protection. It gathers senior officials and experts from national governments, EU bodies, intergovernmental organisations, local authorities, civil society and specialised human rights bodies. The conference promotes the sharing of information on innovative policies, promising practices and projects through practice-oriented workshops and interactive plenary discussions.

The FRC themes are set in the context of current EU policy and legislative developments, the Stockholm Programme in particular, and are informed by FRA research. The FRC is used as an opportunity to raise awareness of the work of FRA among key stakeholders and is therefore often combined with the launch of a major FRA report. Previous FRC themes included racism and freedom of expression (2008), social inclusion of marginalised communities (2009), justice for children and child protection (2010), and dignity and rights of irregular migrants (2011).

Description

The Agency is setting up Performance Measurement Framework (see Annex II) to monitor, report and evaluating on its performance as this will help FRA to manage and evaluate its usefulness, effectiveness and relevance, as well as strengthen the alignment of the organisation's projects with its strategic objective, main tasks and thematic priorities.

The performance framework sets out the practical steps needed to assess the FRA performance elaborating some important aspects (such as defining more precise quantitative and qualitative information to be collected, selecting methods and tools of collecting monitoring data) as well as providing a clear and accurate overview of the extent to which the activities contribute to the realization of FRA's outcomes.

One of the major challenges of FRA performance monitoring and evaluation is to create links between the different levels of its intervention and to collect data regarding both the Agency's (1) outputs and (2) outcomes. Monitoring the performance of FRA will be the carried out in accordance with a logic model (composed by outputs, immediate, intermediate and ultimate outcomes) which includes the list of the performance measures.

Planned activities in 2012

Regarding outputs the monitoring information will be based on the collection, analysis and interpretation of reliable and robust quantitative and qualitative data, e.g. on the projects implemented by the FRA.

At the level of outputs the main sources of information to be used include standard reporting templates, surveys of participants and checklists for quality assessments.

Regarding outcomes the monitoring information will be based on the collection, analysis and interpretation of reliable and robust quantitative and qualitative data regarding the adoption of or follow-up to key FRA conclusions and opinions by "relevant institutions, bodies, offices and agencies of the Union and its Member States".
